Whereas, the murder of Trayvon Martin on February 26, 2012 in Florida sparked outrage in the Black community, and

Whereas, a strong perception following this homicide that the nation placed a low value on the lives of Black Americans led Alicia Garza, Opal Tometi, and Patrisse Cullors to form the Black Lives Matter movement (BLM), and

Whereas, BLM was formed to affirm Black Americans' humanity and resilience in the face of deadly oppression, and

Whereas, the killing of Michael Brown, 18 years of age, in Ferguson, Missouri, on August 9, 2014, ignited major growth in BLM, and

Whereas, the deaths of at least 102 unarmed Black Americans in 2015 reaffirmed the continuing crisis in the relationship between Black Americans and law enforcement officials, and

Whereas, BLM focuses its work on diversity, restorative justice, and being unapologetically Black, and

Whereas, the repeated incidents of violence against Black Americans have demonstrated the core reason that BLM was established, and

Whereas, BLM supporters in Vermont, who include members of all races, have stood in solidarity with this nationwide movement, and

Whereas, only 1.2 percent of Vermonters are Black and still face discrimination in many aspects of their daily lives, and

Whereas, the General Assembly has acknowledged the problems Black Vermonters encounter with public safety officials, and in 2012 and 2014, the General Assembly enacted legislation leading to the establishment of bias-free policing policies, and a greater law enforcement awareness and readiness to adopt those policies, and

Whereas, the Vermont Black Lives Matter movement has spurred a continuing dialogue to ensure that all Vermonters are guaranteed fundamental civil rights and equality, now therefore be it

Whereas, in 1963, Barbara Wood was elected to the Bethel School Board, on which she served conscientiously for 22 years, and

Whereas, her effectiveness as a school board member convinced Bethel area voters to send her to Montpelier to represent them in the House of Representatives, where she would serve honorably for seven consecutive terms, and

Whereas, Barbara Wood's extensive familiarity with public education resulted in her appointment to the House Committee on Education, and her legislative tenure twice included service as the committee's vice chair (1983-1984) and (1987–1988) and, one term on the House Committee on Health and Welfare, and

Whereas, she was a sponsor and strong supporter of 1985 Acts and Resolves No. 71, the law that established universal access to kindergarten in Vermont, and

<u>Whereas</u>, her continuing interest in public education resulted in her serving on the Vermont Higher Education Planning Commission, the Board of Trustees of the Vermont State Colleges, and the Education Commission of the States, and

Whereas, Barbara Wood's long and fulfilling life ended with her death on November 7, 2015, and survivors include her children, Craig, Brian, Dennis, and Joan; Joann, the widow of Barbara Wood's late son, Gary; 12 grandchildren; and six great-grandchildren, now therefore be it

Whereas, the determination that RRMC offers a high quality patient experience was based on a 27-question survey of the hospital's patients, and
