Whereas, the residents of Cambridge consider Jane Porter and town government nearly synonymous, and

Whereas, she performs her duties with enthusiasm, integrity, and an unlimited passion, and

Whereas, she grew up working in her family's store, where her parents, Winona and Murray Noble, instilled in her the importance of giving back to the community, and

Whereas, Jane Noble graduated from the former Cambridge High School, and in 1969 she earned a degree in political science from the University of Vermont, and

Whereas, on January 29, 1974, at 26 years of age, upon the retirement of Lorraine Wells, Jane Noble was elected Cambridge Town Clerk and Treasurer, in an election in which she was unopposed, and

Whereas, 1974 was an historic year in her life, as she married Dave Porter on October 12, and today they are the parents of a daughter, Jennifer, and the grandparents of two grandsons, Dylan and Jackson, and

Whereas, since her initial standing for elected municipal office, Jane Porter has always been reelected to her post without any opposition, evidence that the voters of Cambridge appreciate the high quality of her job performance, and

Whereas, in 1997, Jane Porter volunteered to assume the often contentious job of collector of delinquent taxes, and she has stoically continued performing this office's challenging responsibilities for 19 years, and

Whereas, after 42 years of serving the citizens of Cambridge, professionally and with a friendly demeanor, Jane Porter has decided not to seek reelection on Town Meeting Day 2016, concluding an exemplary municipal government career, worthy of high praise and many thanks from her constituents and the General Assembly, now therefore be it

Whereas, Wendell Coleman has resided in the town of Londonderry for over six decades, and

Whereas, after graduating from the former Leland & Gray Seminary in Townshend, he earned a bachelor's degree in education at the University of Vermont, and

Whereas, public education is a topic of great importance for Wendell Coleman, and he served on the Flood Brook Union School Board for many years, and

Whereas, when the General Assembly enacted 2010 Acts and Resolves No. 153, providing for the voluntary merger of school districts into a new regional educational district (RED), Wendell Coleman chaired the Mountain Town RED Merger Study Committee, and

Whereas, this voluntary endeavor resulted in the formation of the first RED in the State, the Mountain Town RED, of which he is now a member, and

Whereas, for five bienniums (1989–1998), Wendell Coleman represented the town of Londonderry in the House of Representatives, and

Whereas, he served a term each on the Committee on Government Operations and the Committee on Fish, Wildlife and Water Resources, and three terms, including one as vice chair, on the Committee on Natural Resources and Energy, and

Whereas, closer to home, Wendell Coleman served as the Londonderry Town Agent, performing the office's various fiduciary duties, and

Whereas, most recently, Wendell Coleman has presided at the Londonderry Town Meeting, in his role as the municipality's town moderator, and

Whereas, as an individual who has long served in local and State legislative bodies, he was well acquainted with the process of conducting business in this type of forum, and

Whereas, 2016 will be Wendell Coleman's final year presiding at the Londonderry Town Meeting, as he will soon be moving from the community that has been his home for most of his life, and

Whereas, Wendell Coleman has served the citizens of Londonderry with diligence and distinction, and has left his mark on the town's civic life, now therefore be it

Whereas, Ralph Coleman placed great importance on providing youngsters with a solid educational foundation, and he served as a member of the Jamaica Village School Board, and

Whereas, he extended his educational focus to include serving multiple terms on the board of the L&GUMHS, and

Whereas, the expertise Ralph Coleman developed as a board member proved invaluable during his recently concluded role as the L&GUMHS moderator, and

Whereas, he developed a broad knowledge of Jamaica's municipal government as a member of the town's selectboard, and

Whereas, the voters of Jamaica respected and trusted Ralph Coleman's good judgement and sense of fairness, and, in 1978, they elected him to serve as town moderator, and

Whereas, his mastery of *Robert's Rules of Order* and ability to facilitate a meeting that was open to all viewpoints, yet conducted in a dignified and respectful manner, became the hallmark of his service as town moderator, and

Whereas, in 1974, George Lang began his volunteer career on the Champion 5 force, dedicating his time to mastering all aspects of serving on, and eventually managing, a volunteer fire department, and

Whereas, he proved a dedicated and skilled firefighter, who took great pride in serving his community in this important and essential role, and

Whereas, after George Lang had volunteered at Champion 5 for 16 years, his colleagues decided that his experience and temperament were ideal for him to serve as the fire company's sixth chief, and

Whereas, during the past 26 years, George Lang has been an active chief, always working to keep Champion 5 technologically current, and

Whereas, as chief, he served on four truck committees and secured over \$300,000.00 in funding from the Federal Emergency Management Agency, the State of Vermont, and local nonprofit organizations, and

Whereas, George Lang has decided that it is time to pass on the chief's portfolio to another firefighter, and

Whereas, although George Lang will assume the title of retired chief, he does not plan to conclude his firefighting career and has been quoted as saying that "as long as you guys let me in the door," he will continue to answer the fire alarm's call to service, now therefore be it

Whereas, Marvin Locke graduated from the former Lamoille Central Academy and is a U.S. Army veteran, and

Whereas, as a young man, he served on the Eden selectboard, and

Whereas, in 1970, he purchased a dairy farm in North Hyde Park that he owned until 1998, but farming never deterred his civic involvement, and

Whereas, in 1971, Marvin Locke joined the North Hyde Park Volunteer Fire Department, remaining on the force for 36 years, and

Whereas, his willingness to respond to departmental calls, mastery of firefighting skills, and demonstrated leadership potential were all factors in his 1976 election as the North Hyde Park Fire Chief, and

Whereas, during his tenure as chief, Marvin Locke excelled at fundraising for constructing the department's current headquarters; purchasing equipment, including vehicles; and securing training services for his colleagues, and

Whereas, Marvin Locke convinced the Eden Fire Department that merging would improve area firefighting efficiencies, and he also established a junior firefighting program, and

Whereas, recognizing the need for improved regional interdepartmental coordination, he became a founder of the Lamoille County Mutual Aid Association, and

Whereas, Marvin Locke raised the North Hyde Park–Eden Fire Department to modern operational standards, and

Whereas, since 1999, Marvin Locke has served as a water commissioner for Hyde Park Fire District #1 and was active in the recent water system upgrade to introduce fire hydrants for rural fire protection, and

Whereas, for 30 years, until retiring at the end of 2015, Marvin Locke was the Town of Hyde Park Delinquent Tax Collector, and

Whereas, the Town of Eden dedicated its town report in his honor in 2006, and the Town of Hyde Park bestowed a similar recognition in 2008, now therefore be it

Whereas, Elise McKenna has served as the project manager for the Blueprint for Health grantee for the Lamoille County Health Service Area (LCHSA), Community Health Services of Lamoille Valley, and

Whereas, she has led a collaborative process with the LCHSA Care Coordinators Corey Perpall, Kate Myerson, Gloria Tuthill, Jean Audet, Shannon Chauvin, Rorie Dunphey, Kori Day, Jillian Monack, Oana Louviere, Jennifer Tuttle, and Karen Field and with the LCHSA's community health teams, and

Whereas, her great leadership effort resulted in the LCHSA becoming one of the first HSAs in the State to have 100 percent of its health care practices merged into an integrated patient-centered medical home, now therefore be it

#### H.C.R. 253.

House concurrent resolution in memory of Donald G. Milne of Washington, the respected former Clerk of the House

Whereas, former House Clerk Don Milne sat as the member from Washington during the historic first post-reapportionment legislative session of 1966, and

Whereas, preceding his term as a legislator, Don Milne served as Second Assistant Clerk of the House and then experienced life in the other body as Assistant Secretary of the Senate, before "returning home" as First Assistant Clerk of the House, and

Whereas, his vast knowledge of legislative process, especially as practiced in Vermont, made Don Milne an ideal candidate to be elected as Clerk of the House, and

Whereas, for eleven and one-half biennia, beginning in January 1993 and under five Speakers, parliamentary order in the Vermont House of Representatives benefited from his wise advice, and

Whereas, from the moment he first took the Clerk's oath of office and until his retirement on September 30, 2015, Don Milne was an unfailingly fair and nonpartisan parliamentarian, who never allowed his personal opinion on an issue, nor a Speaker's partisan affiliation, to affect his procedural guidance, and

Whereas, Don Milne's familiar, though neither melodious nor theatrical, voice was heard on many roll call votes and bill first readings, and

Whereas, whenever a parliamentary inquiry or point of order was raised, all concerned—and at times that proved to be a rather large crowd—would huddle around the Clerk's desk, waiting attentively to hear Don Milne's perspective, and

Whereas, in his role as a member of the editorial committee of the National Conference of State Legislatures' *Mason's Manual of Legislative Procedure*, he worked on behalf of all state legislators, and

Whereas, this extraordinary parliamentarian and loving husband, father, and grandfather, died on January 24, 2016, and he will be remembered as an exemplary public servant, now therefore be it

#### H.C.R. 254.

House concurrent resolution commending municipalities providing water fluoridation

Offered by: Representative Fagan of Rutland City

Whereas, for 70 years, fluoridation of a municipality's water source, using the naturally occurring mineral fluoride, has been a safe and cost-effective, community-based method of limiting cavities and other oral health diseases, and

Whereas, the American Dental Association and the U.S. Surgeon General, who in December 2015 issued a 70th anniversary commemorative statement on the occasion of fluoride's original introduction in Grand Rapids, Michigan, support the use of fluoride in local drinking water systems, and

<u>Whereas</u>, the U.S. Centers for Disease Control and Prevention (CDC) has recognized water fluoridation as one of 10 great public health achievements of the 20th century, and

Whereas, according to the CDC, children and adults living in communities that use fluoride in the local water system have approximately 25 percent less tooth decay than in communities that do not use fluoride, and

Whereas, the CDC also reports that every dollar spent on fluoridation saves about \$38.00 in dental treatment costs, and

Whereas, preventing oral health diseases helps to reduce rates of other costly and debilitating diseases, including diabetes and heart disease, and

Whereas, fluoride is a proven, low-cost way to improve public health and help reduce health care costs, now therefore be it

Whereas, the contamination of wells along Quaker Village Road resulted in the building of a salt and recycling shed to alleviate this health-threatening situation, and

Whereas, a dangerous occurrence of a different kind, but equally important for the citizens of Weybridge, was the town's clerk-treasurer embezzling municipal funds, and

Whereas, AJ Piper's wise advice and calm response were critical to the town's seeing this financial problem through to a satisfactory conclusion, and

<u>Whereas</u>, the amiable relationships between the town's fire department, school board, and other municipal organizations and committees are due, in large measure, to AJ Piper's collaborative working style that focuses on the community's best interests, and

Whereas, Town Meeting Day 2016 will mark the conclusion of his long and productive service on the Weybridge Selectboard, now therefore be it

<u>Whereas</u>, another hobby of Warren Whitcomb's is woodworking, especially building reproductions of early American furniture and other smaller period items, and

Whereas, while Warren Whitcomb's family, farm, and hobbies occupied much of his daily life, he still found the time to serve his community in many important ways, and

Whereas, one of his first forays into local civic leadership was participating in the 1968 establishment of the New Haven Volunteer Fire Department, and, as the department's treasurer, he assisted in securing the department's federal 501(c)(3) tax status, and

Whereas, his service as a lister extended from 1968 to 1971, simultaneous with the State's introduction of a uniform lister card appraisal system, and

Whereas, Warren Whitcomb then assumed the all-encompassing municipal governance role of selectboard member, for a tenure beginning in 1971 and continuing until 1976, and

Whereas, in 1975, he added the special and historic duty of membership on New Haven's Bicentennial Committee, and

Whereas, the writing of New Haven's original town plan was an important responsibility during his planning commission service, starting in 1975 and concluding in 1983, and

Whereas, New Haven is honoring Warren Whitcomb with a dedication in the 2015 town report, now therefore be it

Whereas, when Earl Bessette was only a toddler, his father purchased the Elgin Spring Farm in New Haven, and his parents relocated to this Addison County town, and

Whereas, the purchase has proven enduring as the Bessette family's ownership of the farm has continued into a fourth generation, and

Whereas, Earl Bessette raised seven children on the farm, and

Whereas, he became knowledgeable about the town's history, especially with respect to its earlier farmers, and

<u>Whereas</u>, another historical interest of his is local Native American history, and he donated his impressive artifact collection to the town, and

Whereas, storytelling is a special passion for Earl Bessette, and his stories can focus on historical or contemporary people or places, and

Whereas, annually, he publishes a collection of stories, both his own and favorites that others have told, and

Whereas, as a young man, Earl Bessette was an avid trapper, and he sold the hides of the beaver, mink, and muskrat that he trapped, and

Whereas, despite his already busy life, Earl Bessette recognized the importance of serving his community, and

Whereas, he began his continuing tenures as a fence viewer in 1972 and as a grand juror in 1994, and

Whereas, in the 1970s, Earl Bessette was a member of the New Haven Revenue Sharing Committee, and

Whereas, for over 20 years (1976–1999), he performed the electoral administration, tax appeal determination, and other required duties of a justice of the peace, and

Whereas, Earl Bessette's broad knowledge of life in New Haven was appreciated during his five years of service (1990–1995) on the town's selectboard, and

Whereas, in recognition of his service to the community in so many ways, Earl Bessette is being honored with a 2015 New Haven Town Report dedication, now therefore be it

Whereas, citizens who serve on municipal legislative bodies dedicate countless hours to making their communities the best possible places to live, and

Whereas, municipal legislators, be they city councilors, aldermen, selectboard members, or village trustees, must acquire familiarity, if not

expertise, on a broad range of topics ranging from election administration to highway maintenance, and,

Whereas, one of a municipal legislative body's most important functions is to oversee the preparation of the locality's annual budget for presentation to the voters on Town Meeting Day, and

Whereas, the chair of a municipal legislative body must oversee preparation of the agenda and coordinate the relationship with full-time municipal officials, and

Whereas, a municipal legislator and chair deserving special recognition is Rockingham Selectboard Chair Tom MacPhee, and

Whereas, Tom MacPhee first won election to the Rockingham Selectboard in 2005, and

Whereas, he quickly mastered the intricacies of town government and the complexities of parliamentary procedure, and

Whereas, his selectboard colleagues were duly impressed, and, in 2006, Tom MacPhee was selected to serve as chair, a role he has performed adroitly and fairly for the past decade, and

Whereas, after 11 years of outstanding work on behalf of the Rockingham citizenry, 10 as selectboard chair, Tom MacPhee will be banging the gavel for the last time, as he concludes his representational and leadership roles on the Rockingham Selectboard, now therefore be it
