Whereas, Upward Bound, the original federally financed college incentive program for disadvantaged students, was established in 1964 under the auspices of the federal Office of Economic Opportunity, and it helps secondary school students prepare for college, and

Whereas, the Talent Search program, initially authorized in the Higher Education Act of 1965, assists students early in the college admissions and financial aid process, and

Whereas, the federal Education Amendments of 1968 added the Student Support Services program that was originally known as Special Services for Disadvantaged Students, and, in the late 1960s, the term TRIO was coined to describe these three programs, and

Whereas, over the years, TRIO, through additional federal legislation or U.S. Department of Education administrative action, has been expanded to encompass a total of eight student support programs, including a veterans-specific Upward Bound program, and

Whereas, in a major change, in 2001, the Student Support Services program began offering direct grants to certain students who were already the recipients of federal financial support from the Pell Grant program, and

Whereas, students and administrators representing the federal TRIO programs in Vermont are visiting the State House today, Wednesday, March 16, 2016, now therefore be it

That the General Assembly is pleased to honor the outstanding work of the federal TRIO programs in Vermont, and be it further

Whereas, in 2011 Acts and Resolves No .43, the General Assembly adopted the Interstate Compact on Educational Opportunity for Military Children that addresses the academic aspects of military children's frequent relocations, and

Whereas, the Vermont National Guard has implemented and promotes the Vermont National Guard (VTNG) Child and Youth Program in accordance with guidance from the National Guard Bureau, and

Whereas, the VTNG Child and Youth Program assists Vermont's military youth in adjusting to situations other children do not experience, and

Whereas, for 2015, the VTNG Child and Youth program reported 755 programming hours were provided, including day and overnight camping opportunities, that reached 689 Army and Air National Guard children, and

Whereas, the VTNG Child and Youth Program also educates the broader civilian community on the effect of parental deployments for military children, and

Whereas, military parents whose children participate in VTNG Child and Youth program have responded favorably to the program's impact on their children's lives, and

Whereas, nationally, April marks the nation's "Month of the Military Child," a time to honor those youth military deployment has affected, and

Whereas, today, April 5, 2016, Vermont Army and Air National Guard families, along with staff from the VTNG Child and Youth Program, are visiting the State House, now therefore be it

Whereas, it was not until shortly prior to World War I and Congress's passage of the National Defense Act of 1916 that ROTC was established, and

Whereas, the first ROTC unit was formed in 1916 at Norwich University in Northfield, Vermont, and

Whereas, during the past century, ROTC has evolved into an essential program for training future U.S. military officers, and

Whereas, in 2016, there are U.S. Air Force, Army, and Navy ROTC programs, and

Whereas, ROTC is offered at six private or state senior military colleges, including Norwich University, the Citadel, Texas A&M University, the University of North Georgia, Virginia Military Institute, and Virginia Polytechnic Institute and State University; at many civilian colleges; and at junior military colleges, some participating in ROTC's early commissioning program, and

Whereas, in celebration of ROTC's centennial anniversary, Norwich University is conducting special events on April 21–23, 2016, including a keynote address that U.S. Army Chief of Staff General Mark Milley will deliver at Kreitzberg Arena; a second keynote address that Lieutenant General H.R. McMaster, the deputy director at the Army Capabilities Integration Center, will deliver; a panel discussion on "Preparing for the Next Century of ROTC," featuring National Public Radio's Pentagon reporter Tom Bowman moderating, and including military and business leaders as participants; a ceremony at the State House; and several other commemorative activities, including a worldwide synchronized 5k fun run, now therefore be it
