Whereas, Josh Harrington (Boys & Girls Club of Rutland), a Rutland High School senior, loves to hunt, fish, hike, fix cars, and ride his bike, serves on the Club's teen council, and plans to attend the University of Northwestern Ohio, and

Whereas, in 2007, in partnership with their four daughters — Anne, Theresa, Susan, and Annette — Robert and Gisele Gervais purchased the Boston Post Dairy that is located on a farm the family has nicknamed "The Girls Farm," and

Whereas, their farm is home to 180 goats, 90 cows, and 20 free-range chickens, as well as an array of cats and rabbits, and

Whereas, on purchasing the dairy, the Gervais family added a cheese production facility and a retail store, and

Whereas, Boston Post Dairy is named after the Old Boston Post Stagecoach Road, and

Whereas, the dairy produces goat, cow, and goat-cow blend cheeses and recently introduced its first goat milk camembert-style cheese, and

Whereas, Boston Post Dairy also sells homemade natural goat milk soaps and features a bakery and country store, and

Whereas, one of the Boston Post Dairy's delicious cheeses is Très Bonne, a Gouda-style goat milk cheese that has a fresh, mild, and nutty flavor; requires three to five months of aging; and has a yellow paracoat finish, and

Whereas, at the 2016 World Championship Cheese Contest, held on March 7–9 in Madison, Wisconsin, Très Bonne was awarded third place in the Hard Goat's Milk Cheeses category, garnering 99.2 out of a possible 100 points, and

Whereas, everyone associated with Boston Post Dairy, including cheesemaker Anne Doe, was thrilled with this spectacular accomplishment, as

the competition in this category included 25 entrants from around the world, now therefore be it

Whereas, the tale of Lisa and Roy Haynes' journey from Florida to rural Vermont is hardly the story of a typical family, and

Whereas, Lisa Haynes was once employed by day as an insurance adjuster but, at night, she transformed herself into a powerful professional wrestler who adored the limelight of fans cheering her prowess on the wrestling mat, and

Whereas, one day, while Lisa and Roy were driving near their Florida home, they spotted a group of boys harassing a dog with firecrackers, and the couple stopped immediately to rescue the frightened animal, and

Whereas, they decided to keep the dog, a Shiloh shepherd, that was ill and malnourished, and they nurtured it back to health and found it a loving new home, and

Whereas, realizing they had discovered their life's calling, Lisa and Roy Haynes were confronted with a dilemma as they resided in a development with a three-dog-per-household maximum, and

Whereas, these conflicting realities resulted in their purchasing a home with a large yard in Huntington where they established a nonprofit known as SOS Save Our Strays, and

Whereas, Lisa and Roy Haynes have developed a network of contacts consisting of animal shelter volunteers, especially in southern states where 31 percent of the animals (usually dogs) are euthanized, and

Whereas, one set of volunteers takes temporary possession of the animals identified as worthy of rescue and provides necessary immediate care while another set of volunteers including a private airplane pilot who occasionally flies animal rescue missions, transports the dogs to Huntington, and

Whereas, once in Vermont, the animals are given major medical attention if needed and found ideal new homes, and

Whereas, Lisa and Roy Haynes are not paid for their good deeds, and despite Roy Haynes' fame as the "Cheapest Man in America," the couple must engage in fundraising activities, including the publication of a new colorful graphic novel entitled *The Adjuster*, produced in collaboration with graphic illustrator and author Michael Tonn, and

Whereas, since 1995, SOS has rescued and found new homes for over 3,000 animals, now therefore be it

Whereas, he is a Rutland native, and his family has long been associated with the *Rutland Herald*, as both his brothers were State House reporters, and his mother worked as a day editor, and

Whereas, A.J. Marro graduated from Mount St. Joseph Academy in 1966, and from the then Castleton State College in 1971, and

Whereas, he began his *Rutland Herald* career as a delivery boy, and A.J. Marro later worked as a sports intern and as a copy boy before becoming a full-time employee in 1969, and

Whereas, A.J. Marro is a photojournalist who never took a single photography class and transitioned from 35 millimeter black-and-white film, to color film, and finally to digital photography—which, despite his initial reluctance, became his preferred photographic medium, especially as it eliminated the need for smelly darkroom chemicals, and

Whereas, until he learned to drive at age 40, A.J. Marro's official work place was the darkroom, with periodic forays to photographic assignments when he could arrange for a ride, or walk or take his bike, and

Whereas, A.J. Marro has covered every imaginable type of news event from a disastrous fire to political rallies and sports, perhaps his favorite, and

Whereas, he brought happiness to the many families whose student athletes appeared in his photos, and

Whereas, dedicated to meeting a deadline, in the predigital age, A.J. Marro once developed sports photographs in an improvised car-based darkroom, while being driven home from a Burlington game, and

Whereas, after four and one-half decades as a full-time, and much loved, *Rutland Herald* employee, A.J. Marro retired on December 31, 2015, although he has agreed to accept occasional sports assignments, now therefore be it

Whereas, Equal Pay Day is a symbolic day in the spring, chosen to highlight that, due to the wage gap, women must work well into the next year before their earnings catch up to what men made the year before, and

Whereas, the wage gap in Vermont is 16 percent, with women earning 84 cents for every dollar men earn, and that gap widens to 23 percent when a woman has dependent children and is even wider for women of color, and

Whereas, the wage gap exists in jobs at all levels of pay: women chief executives in Vermont earn 31 percent less than their male counterparts, and

Whereas, the wage gap in Vermont exists in jobs in which women are the majority of workers, including personal care and service workers, who are 74 percent female but have a wage gap of 31 percent, and

Whereas, according to the Institute for Women's Policy Research, equal pay for working women in the United States would result in reductions in poverty for all working families of 50 percent nationally and 57 percent in Vermont, and

Whereas, if working women received equal pay in Vermont, at least one billion dollars would be added into the State's economy, now therefore be it

<u>Whereas</u>, *Hobbes Goes Home*, which is the true story of Hobbes's rescue from an abusive home and his subsequent adoption by the Zeman family, has raised significant awareness of these important issues and shown Vermont in a positive light, and

Whereas, the book has received significant positive attention from across the nation, as a result of its empowering messages for students of all ages, and has earned praise from President Barack Obama, Vermont Governor Peter Shumlin, Congressman Peter Welch, and dozens of educators, teachers, students, and animal welfare organizations, and

Whereas, through their book and the web-based radio show, *Bruce and Hobbes Radio*, this broadcasting duo continues to promote positive messages for students, empowering them to make changes in their lives and the lives of others by acting with kindness, compassion, and empathy, and

Whereas, in recognition of his outstanding work on the adult transition project, Bill Sugarman was the recipient of the Governor's Award for Service to People with Disabilities, and

Whereas, caring Vermonters in the health, education, and human services fields are working very hard to support children and youths with autism, and

Whereas, 8 V.S.A. § 4088i requires that a "health insurance plan shall provide coverage for the evidence-based diagnosis and treatment of early childhood developmental disorders," including autism, and

<u>Whereas</u>, several federal laws provide for autism support services across the lifespan as well as important scientific research, and

Whereas, Vermont families nonetheless struggle to access the necessary support services for their autistic family members, and

Whereas, children and youths with autism will become adults in the next decade with many needing continuing support, and

Whereas, Vermonters need to recognize the skills and potential contributions of individuals with autism, now therefore be it

Whereas, at Oxbow Union High School, he led the varsity soccer team to over 200 victories during his 30-plus years as head coach, and

Whereas, a second assignment was serving as junior varsity coach at Hanover High School where he compiled another 142 victories, and

Whereas, Michael Callanan was considered the dean of high school soccer coaches in both states bordering the Connecticut River, and

Whereas, as a result of the Vermont Victim Assistance Program, crime victims receive support and advocacy as they recover financially, emotionally, and physically from their experiences, and the criminal justice system as a whole is more transparent and accessible to the law-abiding public and responsive to the communities that it serves, and
