Subj: Federal Reporting of Child Safety Interventions – DCF Family Services

You have asked us to shed light on why Vermont's report acceptance rate looks low compared to the national data. There are two realities that affect this:

- 1. <u>Number of Intakes</u>: Family Services has a very high per capita rate of intakes for several reasons:
  - a. DCF Family Service's philosophy which translates into training for mandated reporters
     is to encourage reporters to call the Child Protection Hotline.
  - b. In Vermont, any call to the centralized intake unit that results in an intake being documented is counted as an intake. In other states, they have the ability to combine intakes concerning the same child and the same incident, but are called in by a different reporter. We do not. At times, the Hotline may receive multiple intakes on the same allegation. All are counted.
  - c. Because Family Services is not just the child protection agency, but also the youth justice agency, this includes intakes on child abuse and neglect, child behavior, delinquency, etc. For the 2009 federal reporting year, this resulted in Vermont having the highest rate on intakes per 1000 children living in the state. The table below is for 2009 intakes

Family Assessments listed below. They are not reported, as they are conducted under Family
Services' authority under 33 VSA Chapter 53, not under the child abuse statute 33 VSA Chapter
49. In 2012, Family Services conducted 1044 Family Assessments.

Because in Vermont (1) the # of accepted reports does not include Family Assessments, and (2) the number of intakes is very high, the translates mathematically into a lower rate of accepted report, as compared to the nation.
