## Demographic drivers of cost (the main drivers):

- 1. We have lost about 23% of our student population since our peak, and are continuing to shrink (declining enrollment).
- 2. We are maintaining almost all the public and independent schools we had at our peak (overhead has not changed).
- 3. The number of teachers has decreased, but not consistently with the loss in number of students (student-to-teacher ratios are still declining).
- 4. Thus, we have fewer students, more schools and proportionally more overhead to support on a per-pupil basis
- 5. We have 58 students per board member, compared to 72 at our peak.
- 6. We have proportionally more children living in adversity (poverty).


