

Homestead Tax Rate Adjustment Based on Per-Pupil Education Spending

Based on FY2016 Education Spending

A portion of the difference between a district's per-pupil education spending and the statewide average per-pupil education spending in the prior year is added to the district's actual per-pupil education spending for the purpose of calculating the district's homestead education tax rate. The homestead tax rate is reduced in districts with below average per-pupil education spending and increased in districts with above average per-pupil education spending.
