11	opportunities; Expanded Learning Opportunities Review Committee;

13	Statement of purpose of bill as introduced: This bill proposes to create an
14	Expanded Learning Opportunities (ELOs) Grant Program developed and
15	administered by an ELO Review Committee to support and encourage
16	increased student participation in and access to ELO programs offered outside
17	school hours and during the summer throughout Vermont.
18	An act relating to increasing expanded learning opportunities
19	It is hereby enacted by the General Assembly of the State of Vermont:

1	Sec. 1. FINDINGS
2	(a) Data collected nationally reveals that children and youth are most likely
3	to be in or cause automobile accidents, commit crimes, be victims of crime, or
4	engage in risky behavior between the hours of 3:00 and 6:00 p.m.
5	(b) Multiple national studies conclude that:
6	(1) students from families with low income regress academically and
7	socially when they do not have access to the same types of learning
8	experiences outside school hours and during the summer as more affluent
9	students enjoy; and
10	(2) differences in math achievement attributable to family income were
11	eliminated for students in kindergarten through 5th grade who were provided
12	consistent, high-quality afterschool activities.
13	(c) Research and analysis conducted by Vermont Afterschool, Inc. in 2014
14	estimates that for every dollar spent on quality ELOs, Vermont could realize
15	\$2.18 in long-term savings and benefits.
16	(d) Twenty-four percent of Vermont kindergarten-grade 12 children are
17	currently enrolled in ELOs.
18	(e) Only 14 percent of Vermont children who participate in an afterschool
19	ELO qualify for the federal free and reduced price lunch program, compared to
20	an average of 45 percent participation nationally.

1	(f) Thirty-three percent of parents of Vermont children who are not
2	currently enrolled in an ELO report that they would enroll their child if a
3	program were available. In addition, parents identify ELO program cost as one
4	of the primary barriers to enrollment.
5	Sec. 2. 16 V.S.A. chapter 43 is added to read:
6	CHAPTER 43. EXPANDED LEARNING OPPORTUNITIES
7	<u>§ 1641. DEFINITIONS</u>
8	As used in this title:
9	(1) "Committee" means the Expanded Learning Opportunities Review
10	Committee created by this chapter.
11	(2) "Expanded Learning Opportunity (ELO)" means a structured
12	program designed to serve prekindergarten through secondary school-aged
13	children and youth outside the school day and year on a regular basis,
14	including before and after school and during the summer, by providing
15	opportunities for personal, emotional, and academic growth for children and
16	youth.
17	(3) "Program" means the Expanded Learning Opportunities Grant
18	Program created by this chapter

1	<u>§ 1642. EXPANDED LEARNING OPPORTUNITIES REVIEW</u>
2	COMMITTEE; REPORT
3	(a) Creation; membership. There is created an Expanded Learning
4	Opportunities Review Committee, to be composed of the following members:
5	(1) the Secretary of Education or designee;
6	(2) the Commissioner of the Department for Children and Families or
7	designee;
8	(3) the Director of Vermont Afterschool, Inc. or designee;
9	(4) one current member of the House of Representatives, who shall be
10	appointed by the Speaker of the House;
11	(5) one current member of the Senate, who shall be appointed by the
12	Committee on Committees;
13	(6) one member appointed by the Vermont Superintendents Association;
14	(7) one member appointed by the Vermont School Boards Association;
15	(8) one member appointed by the Vermont Principals' Association;
16	(9) two members appointed by the Prekindergarten-16 Council; and
17	(10) three members representing ELO programs that have been in
18	operation since at least July 1, 2014, with one member to be appointed each by
19	the Governor, the Speaker, and the Committee on Committees.
20	(b) Terms. Committee members shall serve staggered three-year terms
21	commencing on January 1, or until the member's earlier resignation or

1	removal, except for legislative members who shall be appointed to two-year
2	terms that mirror their legislative terms. The respective appointing authority
3	shall fill a vacancy for the remainder of any unexpired term. An appointed
4	member shall not serve more than three full consecutive terms.
5	(c) Officers; subcommittees; rules. The Committee shall elect a chair from
6	among its members. It may elect other officers, establish subcommittees, and
7	adopt procedural rules as it determines necessary and appropriate to perform its
8	work.
9	(d) Quorum; voting; meetings.
10	(1) A majority of all members shall constitute a quorum.
11	(2) Action is taken by the Committee if authorized by a majority of the
12	members present and voting at any regular or special meeting at which a
13	quorum is present.
14	(3) The Committee may permit any or all members to participate in a
15	regular or special meeting by, or conduct the meeting through the use of, any
16	means of electronic communication, by which all members participating may
17	simultaneously or sequentially communicate with each other during the
18	meeting. A member participating in a meeting by this means is deemed to be
19	present in person at the meeting.
20	(e) Administrative support. The Agency of Education shall provide
21	administrative support to the Committee.

1	(f) Compensation. For attendance at meetings during adjournment of the
2	General Assembly, legislative members of the subcommittee shall be entitled
3	to compensation and reimbursement for expenses pursuant to 2 V.S.A. § 406.
4	Other members of the subcommittee who are not employees of the State of
5	Vermont and are not otherwise compensated for their attendance shall receive
6	per diem compensation and reimbursement of expenses pursuant to
7	<u>32 V.S.A. § 1010.</u>
8	(g) Report. Notwithstanding 2 V.S.A. § 20(d), the Committee shall report
9	to the General Assembly on January 15 annually regarding the Committee's
10	activities, applications received, and grants awarded under this chapter.
11	§ 1643. EXPANDED LEARNING OPPORTUNITIES GRANT PROGRAM
12	(a) Program created. There is created an Expanded Learning Opportunities
13	Grant Program that shall award grants for the purpose of increasing access to
14	expanded learning opportunities throughout Vermont.
15	(b) Grants. Grants shall be available in the following three categories:
16	(1) The Committee may award grants to school districts or supervisory
17	unions that operate an ELO program or that have contracted with an ELO
18	program or a Licensed Child Care Center to provide expanded learning
19	opportunities, or both. The Committee shall determine the award based upon
20	the size of the program. If a grant recipient is contracting with an ELO
21	program or Licensed Child Care Center that is not located in the school that the

1	children enrolled in the program attend, then the grant recipient shall provide
2	safe transportation from the school to the ELO program site, and may use grant
3	funds to provide the transportation.
4	(2) The Committee may award grants to organizations providing
5	technical assistance or professional development opportunities to ELO
6	programs. An award under this subdivision shall not exceed \$300,000.00
7	annually to any one recipient.
8	(3) The Committee may award grants to grants to community
9	organizations in order to assess whether an ELO program is needed in the
10	community, to determine how families might access an ELO program, or to
11	explore opportunities for ELO partnerships in the community. An award under
12	this subdivision shall not exceed \$5,000.00.
13	(c) Duties of Committee. The Committee shall:
14	(1) develop all aspects of the Program, including an application process
15	and the criteria for evaluating applications and for awarding grants and other
16	incentives, such as professional development opportunities, for Expanded
17	Learning Opportunities in Vermont;
18	(2) award grants from the Expanded Learning Opportunities Fund
19	created in this chapter;
20	(3) pursue and accept grants or other funding from any public or private
21	source for the purposes of this section, including federal funding through the

1	Child Care Development Fund, to help working families access ELOs for
2	children up to 16 years of age; and
3	(4) administer the grants or other funding consistent with the terms of
4	acceptance.
5	(d) Matching funds. Grants awarded pursuant to subdivisions (b)(1) or (2)
6	of this section shall be made on a one-for-one matching basis; provided,
7	however, that grant recipients may satisfy this requirement through in-kind
8	support and through the use of 21st Century Community Learning Centers
9	<u>funds.</u>
10	<u>§ 1644. VERMONT EXPANDED LEARNING OPPORTUNITIES SPECIAL</u>
11	FUND
12	There is established a Vermont Expanded Learning Opportunities Special
13	Fund comprising appropriations made by the General Assembly and grants,
14	donations, and contributions from any other public or private source. Monies
15	in the Fund shall be available to the Committee for the purposes of the
16	Program created in this chapter. The Commissioner of Finance and
17	Management may draw warrants for disbursements from this Fund in
18	anticipation of receipts. The Fund shall be administered pursuant to
19	32 V.S.A. chapter 7, subchapter 5, except that interest earned and any
20	remaining balance at the end of the fiscal year shall be retained and carried
21	forward in the Fund.

1	§ 1645. DATA COLLECTION; ACCOUNTABILITY
2	(a) Each ELO program that is awarded grant funds pursuant to the Program,
3	or that receives any other form of public funding, shall collect data on student
4	participation and student outcomes pursuant to metrics established by the
5	Committee in connection with development of the criteria for evaluating
6	applications and awarding grants. The ELO program shall report this data
7	annually at a time and in a format established by the Agency of Education.
8	(b) The Secretary of Education, in coordination with the Vermont School
9	Boards Association and Vermont Afterschool, Inc., shall develop three
10	results-based accountability performance measures. All grantees shall report
11	on these measures, and the data will be compiled annually for the fiscal year
12	and submitted in a report by the Agency of Education to the House and Senate
13	Education Committees and the House and Senate Appropriations Committees
14	annually by January 15. These performance measures will also be included in
15	the Agency of Education's Balanced Accountability Model.
16	Sec. 3 GRANT CRITERIA
17	On or before December 31, 2015, the Expanded Learning Opportunities
18	Review Committee shall establish an application process and the criteria for
19	evaluating applications and awarding grants. Criteria shall be designed to
20	identify practices that support and encourage school-community partnerships;
21	engaged learning; family involvement; intentional programming; a diverse,

1	prepared staff; increased participation and access; safety, health, and wellness;
2	and ongoing programmatic assessment and improvement. The Review
3	Committee shall accept the first round of grant applications in January and
4	February 2016 and shall award the first set of grants on or before
5	<u>April 15, 2016.</u>
6	Sec. 4. REVIEW COMMITTEE; INITIAL MEETING; INITIAL
7	MEMBERSHIP TERMS
8	(a) On or before September 1, 2015, the Secretary of Education shall
9	convene the first meeting of the Expanded Learning Opportunities Review
10	Committee.
11	(b)(1) The term of the initial members appointed pursuant to Sec. 2 of this
12	act, 16 V.S.A. § 1642(a)(6), (7) and (8) shall expire on January 1, 2017.
13	(2) The term of the initial members appointed pursuant to Sec. 2 of this
14	act, 16 V.S.A. § 1642(a)(9) shall expire on January 1, 2019.
15	(3) The term of the initial members appointed pursuant to Sec. 2 of this
16	act, 16 V.S.A. § 1642(a)(10) shall expire as follows:
17	(A) The term of the initial member appointed by the Governor shall
18	expire on January 1, 2017.
19	(B) The term of the initial member appointed by the Speaker of the
20	House shall expire on January 1, 2018.

1	(C) The term of the initial member appointed by the Committee on
2	Committees shall expire on January 1, 2019.
3	Sec. 5. APPROPRIATION
4	The sum of \$4,500,000.00 is appropriated to the Secretary of Education for
5	the Vermont Expanded Learning Opportunities Special Fund from the
6	Education Fund in fiscal year 2016. Of this amount:
7	(1) at least \$4,000,000.00 shall be awarded in the form of ELO program
8	grants pursuant to Sec. 2 of this act, 16 V.S.A. § 1643(b)(1);
9	(2) up to \$450,000.00 may be allocated to technical assistance and
10	professional development grants pursuant to Sec. 2 of this act, 16 V.S.A.
11	<u>§ 1643(b)(2); and</u>
12	(3) up to \$50,000.00 shall be allocated to the small community grants
13	pursuant to Sec. 2 of this act, 16 V.S.A. § 1643(b)(3).
14	Sec. 6. EFFECTIVE DATE
15	This act shall take effect on passage.
