**Legislation Reporting Requirement**

[Act No. 129 of 2012](#)

Act 129, Sec. 34 re-codified Public High School Choice, from 16 V.S.A. §§1621 and 1622, to 16 V.S.A. § 822a. Section 822a (m) requires the Agency of Education to:

“[R]eport annually in January to the Senate and House Committees on Education on the implementation of public high school choice as provided in this section, including a quantitative and qualitative evaluation of the program's impact on the quality of educational services available to students and the expansion of educational opportunities.”

**I. Background**

On an annual basis, the Agency collects data on public school choice, including the number of students taking part, by gender, grade, IEP status, and eligibility for Free or Reduced Price Lunches (FRL).

Given the breadth of last year’s report, with longitudinal school choice data for the areas covered, reviewing it provides a useful context for this year’s more streamlined report. Due to capacity constraints, the Agency did not collect qualitative data for the current year’s report.

Act 129 provides for statewide public school choice, with responsibility for implementation of high school choice residing at the local and regional levels. Local and regional staff put into effect the provision allowing students to apply to any other public high school in the state.

## **II. Implementation, School Year 2015 – 2016 (SY2016)**

### **A. Participation by Students**

Participation in public school choice dropped by one student from 381 in SY2015 to 380 this year. During the same period, the total student population continued to decline. This essentially level number actually represents an increase in the proportion of students exercising public high school choice. This represents 1.64 percent of the 23,191 students in grades 9 – 12 in SY 2016. Enrollments shown in this report, both for a school and grades 9-12, are current year enrollments (SY2016). In earlier reports, current year enrollments were unavailable at the time of the report so enrollments from the prior year were used – i.e., the SY2015 report used SY2014 enrollments. The figures for participation during SY2016 are included in Table 1 below:

Six schools had a net loss of more than 5% of their high school enrollment through public school choice: Bellows Falls Union High School, Black River Union School, Blue Mountain Union School, Cabot School, Northfield School and Proctor High School. See **Table 2 below**. Roughly 40% of the net sending schools have enrollments below the SY 2016 state median enrollment of 299 for 9-12 graders in schools serving grades 9-12.

Only two schools had an increase in enrollment of 5% or more due to public school choice: Lakes Region and Twinfield Union School District. See table 3 below. The majority of net receiving schools had enrollments greater than the SY2016 median enrollment of 299.

## 1. Participation by Gender and Eligibility for Free and Reduced Price Lunch (FRL)

Students eligible for Free and Reduced Price lunch represent 33% of the total 9-12 population, and 29% of the Public School Choice population. This year's Public School Choice data suggest that there is a slight overrepresentation of non-FRL eligible students who participate in Public School Choice compared to the presence of non-FRL eligible students in the 9-125 public school population.

While overall high school grade enrollments have gradually declined over time, in most cases statewide, participation in choice by grade has varied.

## B. School Participation in Choice

Of the four schools (Concord is non-operating 9-12 for SY15-16) that neither received nor sent public school choice students, all but one had enrollments below the SY2016 state median enrollment of 299 for schools serving grades 9-12.

## C. Patterns

### 1. Size of Schools

### **III. Agency of Education's Responsibilities for Administration and Oversight of School Choice, SY2016**

#### **A. Fielding Inquiries**

Agency staff respond as requested to administrative and legal questions relating to public school choice from administrators, guidance staff, and families.

#### **B. Common Dates for Application Process, January 2016**

In response to questions and suggestions from administrators and staff in the field, and in cooperation with them, the Agency continues to develop and distribute information regarding public school choice. The Agency communicates with the field regarding two important parts of the application process:

- Common dates for schools to follow in the application process, based on statutory requirements (e. g., applications are due on March 1<sup>st</sup> and students' acceptances are due April 15<sup>th</sup>) and reasonable steps in between, for the lottery process;
- Combined statutory requirement (February 1<sup>st</sup> for school boards to determine capacity to receive students each year) and a reasonable interpretation (also February 1<sup>st</sup>) of when boards shall make their discretionary determinations on the number of students allowed to transfer from their school

These and other communications are included in the Agency's Weekly Field Memos, are emailed to all principals and superintendents; and are posted on the Agency's Public School Choice Web page.

#### **C. Data Collection: Numbers of Students Transferring to and from Other Schools**

AOE needs to collect data on student's first, second, and third choices along with any waiting lists sending schools may have.

Related to the preceding paragraph, the Agency, pursuant to 16 V.S.A. §242 (4)(A), will send a request for information to Business Managers, after April 15<sup>th</sup>, for School Year 2016-2017 covering:

##### **Sending schools**

- What was the limit set by the school board on transfers to other schools?
- How many students applied to attend another school?
- Was there a waiting list and, if so, how many could not go?

##### **Receiving schools**

- What was the capacity the high school board set for accepting school choice students for the coming school year?

- How many applications were there?
- How many did the high school accept and enroll?

The data received from the collection will be related to what data are reported in the fall census. As previously noted, they include only the number of students transferring to and from which schools, and their gender, FRL eligibility status, and grade.

#### **D. Public School Choice Web Page**

This winter, Agency staff have reviewed, reorganized, and revised all documents on the Public High School Choice Web page.

### **V. Agency Recommendations**

#### **A. Reporting Requirement**

This report is the fourth report following passage of Act 129 of 2012. It is the Agency's request that after next year's reporting obligation is met (in January 2017) that the sunset provision on this reporting requirement, in 2 V.S.A. § 20(d) be applied to this reporting requirement. At that time, the Agency will have filed five annual reports on Act 129 and the value of additional reports is unclear. The information will likely be redundant and of limited value, and we have limited capacity to meet reporting requirements such as this report.

~~While 16 V.S.A. §822a(m), requires the Agency of Education to provide this report, 2 V.S.A. §20(d) has a sunset:~~

~~(d) Unless otherwise provided by law, whenever an agency is required by law to submit an annual, biennial, or other periodic report to the general assembly, that requirement shall no longer be required after five years or after five years from July 1, 2009, whichever date is later.~~

~~This report is the fourth report following passage of Act 129 of 2012. It is the Agency's request that, given that the amended public school choice law and implementation of statewide public choice have been in effect for only four years, the sunset provision in 2 V.S.A. § 20(d) not pertain to this report.~~

#### **B. Quantitative and Qualitative Research**

Given the volume of legislative reports this year and finite capacity, the Agency did not collect qualitative data and provided qualitative analysis for this report. However, as noted above, the Agency intends to continue collecting data for qualitative analyses in future reports.
