1	TO THE HOUSE OF REPRESENTATIVES:
2	The Committee on General, Housing and Military Affairs to which was
3	referred House Bill No. 187 entitled "An act relating to absence from work for
4	health care and safety" respectfully reports that it has considered the same and
5	recommends that the bill be amended by striking out all after the enacting
6	clause and inserting in lieu thereof the following:
7	Sec. 1. FINDINGS
8	The General Assembly finds:
9	(1) According to the Vermont Department of Labor's 2013 Fringe
10	Benefits Study, roughly one-half of all private sector employers provide some
11	form of paid leave to their employees.
12	(2) Based on information provided by the 2013 Fringe Benefits Study, it
13	is estimated that slightly less than 50 percent of private sector workers
14	employed by companies with fewer than 20 workers have access to paid leave,
15	while approximately 78 percent of workers employed by larger companies
16	have access to paid leave time.
17	(3) Based on information provided by the 2013 Fringe Benefits Study, it
18	is estimated that more than 60,000 working Vermonters lack access to paid
19	leave.

1	Sec. 2. PURPOSE
2	The purpose of this act is to promote a healthier environment at work,
3	school, and in public by ensuring that employees are provided with paid leave
4	time for purposes of health care and safety.

8	(d) For the purposes of earned sick time, an employer shall comply with the
9	provisions required under subchapter 4B of this chapter.

12	<u>§ 481. DEFINITIONS</u>
13	As used in this subchapter:
14	(1) "Combined time off" means a policy wherein the employer provides
15	time off from work for vacation, sickness, or personal reasons, and the
16	employee has the option to use all of the leave for whatever purpose he or she
17	chooses.
18	(2) "Commissioner" means the Commissioner of Labor.
19	(3) "Differential" means compensation paid in addition to the usual
20	compensation paid to an employee of a health care facility as defined in
21	18 V.S.A. § 9432(8) who does not work on a regular schedule and who works

1	only when he or she indicates that he or she is available to work and has no
2	obligation to work when he or she does not indicate availability.
3	(4) "Earned sick time" means discretionary time earned and accrued
4	under the provisions of this subchapter and used by an employee to take time
5	off from work for the purposes listed in subdivisions 483(a)(1)–(5) of this
6	subchapter.
7	(5) "Employee" has the same meaning as set forth in section 341 of this
8	title. However, the term "employee" shall not include:
9	(A) An individual who is employed by the federal government.
10	(B) An individual who is employed by an employer:
11	(i) for 20 weeks or fewer in a calendar year;
12	(ii) in a job scheduled to last 20 weeks or fewer; and
13	(iii) for the purpose of supporting or supplementing the
14	employer's workforce in certain situations, including employee absences,
15	temporary skill shortages, seasonal workloads, and special assignments and
16	projects.
17	(C) An individual who is employed by the State and is exempt or
18	excluded from the State classified service pursuant to 3 V.S.A § 311.
19	(D) An employee of a health care facility as defined in 18 V.S.A.
20	<u>§ 9432(8) if the employee:</u>
21	(i) is under no obligation to work a regular schedule;

1	(ii) works only when he or she indicates that he or she is available
2	to work and has no obligation to work when he or she does not indicate
3	availability; and
4	(iii) receives higher pay in the form of a differential as defined in
5	subdivision (3) of this section, or some other increased compensation than that
6	paid to an employee of a health care facility performing the same job on a
7	regular schedule.
8	(E) An employee of a school district, supervisory district, or
9	supervisory union as defined in 16 V.S.A. § 11 that:
10	(i) is employed pursuant to a school district or supervisory union
11	policy on substitute educators as required by the Vermont Standards Board for
12	Professional Educators Rule 5381;
13	(ii) is under no obligation to work a regular schedule; and
14	(iii) is not under contract or written agreement to provide at least
15	one period of long-term substitute coverage which is defined as 30 or more
16	consecutive calendar days in the same assignment.
17	(6) "Employer" means an individual, organization, or governmental
18	body, partnership, association, corporation, legal representative, trustee,
19	receiver, trustee in bankruptcy, and any common carrier by rail, motor, water,
20	air, or express company doing business in or operating within this State.

1	(7) "Paid time off policy" means any policy under which the employer
2	provides paid time off from work to the employee that includes a combination
3	of one or more of the following:
4	(A) annual leave;
5	(B) combined time off;
6	(C) vacation leave;
7	(D) personal leave;
8	(E) sick leave; or
9	(F) any similar type of leave.
10	<u>§ 482. EARNED SICK TIME</u>
11	(a) An employee shall accrue not less than one hour of earned sick time for
12	every 40 hours worked.
13	(b) An employer may require a waiting period for new hires. During this
14	waiting period, an employee shall accrue earned sick time pursuant to this
15	section but cannot use the earned sick time until after he or she has worked for
16	the employer for one year or 1,400 hours, whichever occurs first.
17	(c) An employer may:
18	(1) limit the amount of earned sick time accrued pursuant to this
19	section to:
20	(A) from January 1, 2016, until December 31, 2017, a maximum of
21	24 hours in a 12-month period; and

1	(B) after December 31, 2017, a maximum of 40 hours in a 12-month
2	period; or
3	(2) limit to 40 hours the number of hours in each workweek for which
4	full-time employees not subject to the overtime provisions of the Federal Fair
5	Labor Standards Act, 29 U.S.C. § 213(a)(1), may accrue earned sick time
6	pursuant to this section.
7	(d)(1) Earned sick time shall be compensated at a rate that is equal to the
8	greater of either:
9	(A) the normal hourly wage rate of the employee; or
10	(B) the minimum wage rate for an employee pursuant to section 384
11	of this title.
12	(2) Employment benefits shall continue during an employee's use of
13

3	<u>§ 483. USE OF EARNED SICK TIME</u>
4	(a) An employee may use earned sick time accrued pursuant to section 482
5	of this subchapter for any of the following reasons:
6	(1) The employee is ill or injured.
7	(2) The employee obtains professional diagnostic, preventive, routine, or
8	therapeutic health care.
9	(3) The employee cares for a sick or injured parent, grandparent, spouse,
10	child, brother, sister, parent-in-law, grandchild, foster child, person residing
11	with the employee, or family member for whom the employee is primarily
12	responsible to arrange or provide care for, including helping that individual
13	obtain diagnostic, preventive, routine, or therapeutic health treatment.
14	(4) The employee is arranging for social or legal services or obtaining
15	medical care or counseling for the employee or for the employee's parent,
16	grandparent, spouse, child, brother, sister, parent-in-law, grandchild, foster
17	child, person residing with the employee, or family member for whom the
18	employee is primarily responsible to arrange or provide care for, who is a
19	victim of domestic violence, sexual assault, or stalking or who is relocating as
20	the result of domestic violence, sexual assault, or stalking. As used in this

1	section, "domestic violence," "sexual assault," and "stalking" shall have the
2	same meaning as in 15 V.S.A. § 1151.
3	(5) The employee cares for a parent, grandparent, spouse, child, brother,
4	sister, parent-in-law, grandchild, foster child, person residing with the
5	employee, or family member for whom the employee is primarily responsible
6	to arrange or provide care for, because the school or business where that
7	individual is normally located during the employee's workday is closed for
8	public health or safety reasons.
9	(b) If an employee's absence is shorter than a normal workday, the
10	employee shall use earned sick time accrued pursuant to section 482 of this
11	subchapter in the smallest time increments that the employer's payroll system
12	uses to account for other absences.
13	(c) An employer may limit the amount of earned sick time accrued
14	pursuant to section 482 of this subchapter that an employee may use to:
15	(1) from January 1, 2016, until December 31, 2017, no more than 24
16	hours of earned sick time accrued pursuant to section 482 of this subchapter in
17	a 12-month period; and
18	(2) after December 31, 2017, no more than 40 hours of earned sick time
19	accrued pursuant to section 482 of this subchapter in a 12-month period.
20	(d)(1) Except as otherwise provided in subsection 484(a) of this
21	subchapter, earned sick time that remains unused at the end of an annual period

1	shall be carried over to the next annual period and the employee has the right
2	to earn the balance between the unused portion and the maximum allowed.
3	(2) If, at an employer's discretion, an employer pays an employee for
4	unused earned sick time accrued pursuant to section 482 of this subchapter at
5	the end of an annual period, then the amount for which the employee was
6	compensated does not carry over to the next annual period.
7	(e) Upon separation from employment, an employee shall not be entitled to
8	payment for unused earned sick time accrued pursuant to section 482 of this
9	subchapter unless agreed upon by the employer.
10	(f) An employee who is rehired by the same employer within 12 months
11	after separation from employment shall begin to accrue and may use earned
12	sick time without any waiting period, but shall not be entitled to retain any
13	unused earned sick time that had accrued pursuant to section 482 of this
14	subchapter before the time of separation unless agreed upon by the employer.
15	(g) An employer shall not require an employee to find a replacement for
16	absences, including absences for professional diagnostic, preventive, routine,
17	or therapeutic health care.
18	(h) An employer may require an employee planning to take earned sick
19	time accrued pursuant to section 482 of this subchapter to:
20	(1) make reasonable efforts to avoid scheduling routine or preventive
21	health care during regular work hours; or

1	(2) notify the employer as soon as practicable of the intent to take
2	earned sick time accrued pursuant to section 482 of this subchapter and the
3	expected duration of the employee's absence.
4	(i) If an employee is absent from work for one of the reasons listed in
5	subsection (a) of this section, the employee shall not be required to use earned
6	sick time accrued pursuant to section 482 of this subchapter and the employer
7	will not be required to pay for the time that the employee was absent if the
8	employer and the employee mutually agree that either:
9	(1) the employee will work an equivalent number of hours as the
10	number of hours for which the employee is absent during the same pay
11	period; or
12	(2) the employee will trade hours with a second employee so that the
13	second employee works during the hours for which the employee is absent and
14	the employee works an equivalent number of hours in place of the second
15	employee during the same pay period.
16	(j) An employer shall post notice of the provisions of this section in a form
17	provided by the Commissioner in a place conspicuous to employees at the
18	employer's place of business. An employer shall also notify an employee of
19	the provisions of this section at the time of the employee's hiring.

1	(k) An employee who uses earned sick time accrued pursuant to section
2	482 of this subchapter shall not diminish his or her rights under sections 472
3	and 472a of this title.
4	(1) The provisions against retaliation set forth in section 397 of this title
5	shall apply to this subchapter.
6	(m) An employer who violates this section shall be subject to the penalty
7	provisions of section 345 of this title.
8	(n) The Commissioner shall enforce this section in accordance with the
9	procedures established in section 342a of this title.
10	<u>§ 484. COMPLIANCE WITH EARNED SICK TIME REQUIREMENT</u>
11	(a) An employer shall be in compliance with this subchapter if either of the
12	following occurs:
13	(1) The employer offers a paid time off policy or is a party to a
14	collective bargaining agreement that provides the employee with paid time off
15	from work that:
16	(A) he or she may use for all of the reasons set forth in subsection
17	483(a) of this subchapter; and
18	(B) accrues and may be used at a rate that is equal to or greater than
19	the rate set forth in sections 482 and 483 of this subchapter.
20	(2) The employer offers a paid time off policy or is a party to a
21	collective bargaining agreement that provides the employee with at least the

1	full amount of paid time off from work required pursuant to sections 482 and
2	483 of this subchapter at the beginning of each annual period and the employee
3	may use it at any time during the annual period for the reasons set forth in
4	subsection 483(a) of this subchapter. If the employer provides an employee
5	with the full amount of paid time off at the beginning of each annual period,
6	the paid time off shall not carry over from one annual period to the next as
7	provided in subdivision 483(d)(1) of this subchapter.
8	(b) Nothing in this subchapter shall be construed to prevent an employer
9	from providing a paid time off policy or agreeing to a collective bargaining
10	agreement that provides a paid time off policy that is more generous than the
11	earned sick time provided by this subchapter.
12	(c) Nothing in this subchapter shall be construed to diminish an employer's
13	obligation to comply with any collective bargaining agreement or paid time off
14	policy that provides greater earned sick time rights than the rights provided by
15	this subchapter.
16	(d) A collective bargaining agreement or paid time off policy may not
17	diminish the rights provided by this subchapter.
18	<u>§ 485. SEVERABILITY OF PROVISIONS</u>
19	If any provision of this subchapter or the application of such provision to
20	any person or circumstances shall be held invalid, the remainder of the

1	subchapter and the application of such provisions to persons or circumstances		
2	other than those as to which it is held invalid shall not be affected thereby.

4	§ 345. NONPAYMENT OF WAGES AND BENEFITS		
5	(a) Each employer who violates sections 342 and 343 342, 343, 482, and		
6	483 of this title shall be fined not more than \$5,000.00. Where the employer is		
7	a corporation, the president or other officers who have control of the payment		
8	operations of the corporation shall be considered employers and liable to the		
9	employee for actual wages due when the officer has willfully and without good		
10	cause participated in knowing violations of this chapter.

12	Sec. 6. DEPARTMENT OF LABOR REPORT		
13	The Department of Labor shall, on or before January 15, 2017, report to the		
14	House Committee on General, Housing and Military Affairs and the Senate		
15	Committee on Economic Development, Housing and General Affairs regarding		
16	the number of inquiries and complaints submitted to the Department in relation		
17	to this act and the number of investigations and enforcement actions		
18	undertaken by the Department in relation to this act during the first year after		
19	its effective date.
