I am the (young) dinosaur of rural family doctor who has delivered many of my young patients and cares for their parents, grandparents and even great-grandparents. We are really struggling. Me to survive on the reimbursement while trying to provide my neighbors and patients with appropriate and necessary care. Together we make daily decisions of which medications to order or not order based on cost. Many of my working families have up to a \$12,000 deductible working for our local Vermont bank. This is not survivable. That is more than many of them pay in rent. They do not come in until they are so sick that hospitalization is sometimes required. I am in solo private practice. NCQA level three, Meaningful Use Year 5, doing all the "right things." And yet for less than 1,000 patients I must employ 1.3 FTE to deal with the insurance and billing. I sit on hold with BCBS and Medicare for ridiculous lengths of time. We need a single payer system that universally provides care to all Vermonters without causing undo financial burdens on our young families, working patients or elders. I know this is a difficult task but it must be done. I currently work for 30% of the salary I would get at DHMC so that I can provide the care all Vermonter's deserve. # Dear House Health Care Committee Members,

As a primary care internist, I am writing to you to encourage you to take up universal primary care in Vermont. I currently practice in Toledo, Ohio as medical director for a center city clinic sponsored by the Catholic hospital for which I work. In the year 2001, I helped lead an effort to provide universal primary care to all the citizens of Lucas County, Ohio. After months of organizing and discussing the structure and financing of this effort, we proposed financing primary care for all by using part of the Disproportionate Share Medicaid money that was being sent to hospitals in Lucas County as partial compensation for care given to uninsured patients after they used the ERs and/or hospitals for care. We made the argument to community leaders that primary care could prevent much of the need for these expensive ER and hospital services and that it would save money, save lives and was the right thing to do. Newly elected Mayor Jack Ford liked the idea and pushed the hospitals to support it and this program grew into a more complete system of coverage for the low income uninsured citizens of Lucas County called CareNet (http://www.toledocarenet.org/about\_carenet/).

If Vermont moves forward with providing primary care to all its citizens, it could be the model for a larger movement across the entire country to give everyone the peace of mind that they can see a doctor for preventive care and when sick without worrying about co-pays and deductibles. Having a primary care provider who knows every patient and their medical history and can coordinate any added care that would be necessary is a first step toward lower costs and higher patient satisfaction. If we could do this for the 440,000 citizens of Lucas County, I am certain that you can do it for the 630,000 citizens of Vermont and they will thank you for it and Vermont can do it maybe the country can do it too. Wouldn't that be a legacy worth leaving to Vermont and the country as a whole. It could start with you.

I realize that there may be some complications with the bills, like procuring Federal waivers out of the Affordable Care Act, along with the neverending issue which haunts all of our health care reform efforts: money. Yet, H.207/S.88 could help us save whatever money we might spend by solving our eternal conundrum of people incurring vastly more expense because they cannot access primary care in the first place. I am an example. Several years ago I nearly died from liver disease. I was employed by a Vermont employer. Though I was fortunate enough to have health insurance through them, this did little good when the employer switched insurers. This swap was thrust upon us employees without our consent or input. It is like we did not matter to them. This is not an unusual situation.

The change threw my primary care provider into what, in insurance land, is called "out-of-network" just as my disease was coming on. "Out-of-network" means that I could not access my primary care provider at the insured rates negotiated with the provider. I did not understand this back then; what I did know was that if I stayed with my primary care doctor, the insurance would not cover it. This prospect was too expensive, of course; my liver malady had plenty of time to grow into a life or death situation while I scrambled to find another primary care physician in the new insurer's (an out-of-state company) network of providers. It was almost too late when I finally got one. I am sure that the operations I needed to stay alive were twice as expensive because the disease was not caught in its early stages due to this primary care travail.

Anyone who has been in this or a similar position knows how primary care is so thoroughly essential. Without it we die unnecessary deaths. With it, we can prevent these unnecessary mortalities and save money in the long term which we now waste on procedures like what happened to me for lack of a primary care provider.
