POSSESSION

POSSESSION OF MORE THAN ONE OUNCE OR 5 GRAMS (H) OR CULTIVATE (GROW ANY)=

FIRST OFFENSE: DIVERSION PRESUMED OR 6 MONTHS  
OR \$500 OR BOTH

SECOND OR SUBSEQUENT OFFENSE: 2 YRS OR \$2000  
OR BOTH

POSSESSION OF 2 OUNCES OR MORE OR 10 GRAMS (H) OR MORE THAN 3 PLANTS=

3 YRS OR \$10,000 OR BOTH

POSSESSION OF 1 LB OR MORE OR 2.8 OUNCES (H) OR MORE THAN 10 PLANTS=

5 YRS OR \$100,000 OR BOTH

POSSESSION OF 10 LBS OR MORE OR ONE POUND (H) OR MORE THAN 25 PLANTS=

15 YRS OR \$500,000 OR BOTH

SALE/DISPENSE

SALE OF ANY AMOUNT=	2 YRS OR \$10,000 OR BOTH
*SALE OR DISPENSE ½ OUNCE OR MORE OR 2.5 GRAMS (H)=	5 YRS OR \$100,000 OR BOTH
SALE OR DISPENSE 1 LB OR MORE OR 2.8 OUNCES (H)=	15 YRS OR \$500,000 OR BOTH
POSSESS W/INTENT TO SELL OR DISPENSE 50 LBS OR MORE OR 5 LBS (H)=	30 YRS OR \$1,000,000

**S.6 PROPOSAL**

**\*AMEND TO BE SALE OR DISPENSE MORE THAN ONE OUNCE OR 5 GRAMS FOR THE 5 YEAR FELONY PROVISION**

**(THIS CHANGE BRINGS THE SALE/DISPENSE QUANTITIES IN LINE WITH THE CIVIL VIOLATION QUANTITIES.)**

UNDER 21 POSSESSION

*POSSESSION OF ONE OUNCE OR LESS OR 5 GRAMS =	FIRST OFFENSE: YOUTH SUBSTANCE ABUSE PROGRAM OR \$300 AND 90 DAY LICENSE SUSPENSION
	SECOND OFFENSE: \$600 AND 180 DAY LICENSE SUSPENSION
	THIRD OR SUBSEQUENT: 30 DAYS OR \$600 OR BOTH
