  - (b) For a plan of merger or share exchange to be approved:

8	continues in existence after a conversion.
9	(5) "Converting organization" means the domestic organization that
10	approves a plan of conversion pursuant to section 11.04 of this title or the
11	foreign organization that approves a conversion pursuant to the law of its
12	jurisdiction of formation.
13	(6) "Domestic organization" means an organization whose internal
14	affairs are governed by the law of this State.
15	(7) "Domesticated corporation" means the corporation that exists after a
16	domesticating corporation effects a domestication pursuant to sections 11.13
17	through 11.16 of this title.
18	(8) "Domesticating corporation" means the corporation that effects a
19	domestication pursuant to sections 11.13 through 11.16 of this title.
20	(9) "Domestication" means a transaction authorized by sections 11.13
21	through 11.16 of this title.

1	(10) "Governing statute" means the statute that governs an
2	organization's internal affairs.
3	(11) "Interest holder" means:
4	(A) a shareholder of a business corporation;
5	(B) a member of a nonprofit corporation;
6	(C) a general partner of a general partnership, including a limited
7	liability partnership;
8	(D) a general partner of a limited partnership, including a limited
9	liability partnership;
10	(E) a limited partner of a limited partnership, including a limited
11	liability partnership;
12	(F) a member of a limited liability company;
13	(G) a shareholder of a general cooperative association;
14	(H) a member of a limited cooperative association or mutual benefit
15	enterprise;
16	(I) a member of an unincorporated nonprofit association;
17	(J) a beneficiary or beneficial owner of a statutory trust, business
18	trust, or common-law business trust; or
19	(K) any other direct holder of an interest.
20	(12) "Merger" means a merger authorized by sections 11.08 through
21	11.12 of this title.

1	(13) "Organization":
2	(A) means any of the following, whether a domestic or foreign
3	organization, and regardless of whether organized for profit:
4	(i) a business corporation;
5	(ii) a nonprofit corporation;
6	(iii) a general partnership, including a limited liability partnership;
7	(iv) a limited partnership, including a limited liability limited
8	partnership;
9	(v) a limited liability company;
10	(vi) a general cooperative association;
11	(vii) a limited cooperative association or mutual benefit enterprise
12	(viii) an unincorporated nonprofit association;
13	(ix) a statutory trust, business trust, or common-law business
14	trust; or
15	(x) any other person that has:
16	(I) a legal existence separate from any interest holder of that
17	person; or
18	(II) the power to acquire an interest in real property in its own
19	name; and
20	(B) does not include:
21	(i) an individual;

1	(ii) a trust with a predominantly donative purpose or a charitable
2	<u>trust;</u>
3	(iii) an association or relationship that is not an organization listed
4	in subdivision (A) of this subdivision (13) and is not a partnership under
5	11 V.S.A. chapter 22 or 23, or a similar provision of law of another
6	jurisdiction;

8	(v) a government or a governmental subdivision, agency, or

10	(14) "Organizational documents" means the organizational documents
11	for a domestic or foreign organization that create the organization, govern the
12	internal affairs of the organization, and govern relations between or among its
13	interest holders, including:
14	(A) for a general partnership, its statement of partnership authority
15	and partnership agreement;
16	(B) for a limited liability partnership, its statement of qualification
17	and partnership agreement;
18	(C) for a limited partnership, its certificate of limited partnership and
19	partnership agreement;

1	(D) for a limited liability company, its certificate or articles of
2	organization and operating agreement, or comparable records as provided in its
3	governing statute;
4	(E) for a business trust, its agreement of trust and declaration of trust;
5	(F) for a business corporation, its certificate or articles of
6	incorporation, bylaws, and other agreements among its shareholders which are
7	authorized by its governing statute, or comparable records as provided in its
8	governing statute; and
9	(G) for any other organization, the basic records that create the
10	organization and determine its internal governance and the relations among the
11	persons that own it, have an interest in it, or are members of it.
12	(15) "Personal liability" means:
13	(A) liability for a debt, obligation, or other liability of an organization
14	which is imposed on a person:
15	(i) by the governing statute solely by reason of the person
16	co-owning, having an interest in, or being a member of the organization; or
17	(ii) by the organization's organizational documents under a
18	provision of the governing statute authorizing those documents to make one or
19	more specified persons liable for all or specified debts, obligations, or other
20	liabilities of the organization solely by reason of the person or persons
21	co-owning, having an interest in, or being a member of the organization; or

1	(B) an obligation of an interest holder under the organizational
2	documents of an organization to contribute to the organization.
3	(16) "Private organizational documents" means organizational
4	documents or portions thereof for a domestic or foreign organization that are
5	not part of the organization's public record, if any, and includes:
6	(A) the bylaws of a business corporation;
7	(B) the bylaws of a nonprofit corporation;
8	(C) the partnership agreement of a general partnership or limited
9	liability partnership;
10	(D) the partnership agreement of a limited partnership or limited
11	liability limited partnership;
12	(E) the operating agreement of a limited liability company;
13	(F) the bylaws of a general cooperative association;
14	(G) the bylaws of a limited cooperative association or mutual benefit
15	enterprise;
16	(H) the governing principles of an unincorporated nonprofit
17	association; and
18	(I) the trust instrument of a statutory trust or similar rules of a
19	business trust or common-law business trust.

1	(17) "Protected agreement" means:
2	(A) a record evidencing indebtedness and any related agreement in
3	effect on July 1, 2017;
4	(B) an agreement that is binding on an organization on July 1, 2017;
5	(C) the organizational documents of an organization in effect on
6	July 1, 2017; or
7	(D) an agreement that is binding on any of the partners, directors,
8	managers, or interest holders of an organization on July 1, 2017.
9	(18) "Public organizational documents" means the record of
10	organizational documents required to be filed with the Secretary of State to
11	form an organization, and any amendment to or restatement of that record, and
12	includes:
13	(A) the articles of incorporation of a business corporation;
14	(B) the articles of incorporation of a nonprofit corporation;
15	(C) the statement of partnership authority of a general partnership;
16	(D) the statement of qualification of a limited liability partnership;
17	(E) the certificate of limited partnership of a limited partnership;
18	(F) the articles of organization of a limited liability company;
19	(G) the articles of incorporation of a general cooperative association;
20	(H) the articles of organization of a limited cooperative association or
21	mutual benefit enterprise; and

1	(I) the certificate of trust of a statutory trust or similar record of a
2	business trust.
3	(19) "Record," used as a noun, means information that is inscribed on a
4	tangible medium or that is stored in an electronic or other medium and is
5	retrievable in perceivable form.
6	(20) "Share exchange" means a share exchange authorized by sections
7	11.08 through 11.12 of this title.
8	(21) "Surviving organization" means an organization into which one or
9	more other organizations are merged whether the organization preexisted the
10	merger or was created by the merger.
11	§ 11.02. CONVERSION AUTHORIZED
12	(a) By complying with sections 11.03 through 11.06 of this title, a domestic
13	corporation may become a domestic organization that is a different type of
14	organization.
15	(b) By complying with sections 11.03 through 11.06 of this title, a
16	domestic organization may become a domestic corporation.
17	(c) By complying with sections 11.03 through 11.06 of this title applicable
18	to foreign organizations, a foreign organization that is not a foreign corporation
19	may become a domestic corporation if the conversion is authorized by the law
20	of the foreign organization's jurisdiction of formation.

1	(d) If a protected agreement contains a provision that applies to a merger of
2	a domestic corporation but does not refer to a conversion, the provision applies
3	to a conversion of the corporation as if the conversion were a merger until the
4	provision is amended after July 1, 2017.
5	§ 11.03. PLAN OF CONVERSION
6	(a) A domestic corporation may convert to a different type of organization
7	under section 11.02 of this title by approving a plan of conversion, and a
8	domestic organization, other than a corporation, may convert into a domestic
9	corporation by approving a plan of conversion. The plan shall be in a record
10	and shall contain:
11	(1) the name of the converting corporation or organization;
12	(2) the name, jurisdiction of formation, and type of organization of the
13	converted organization;
14	(3) the manner and basis for converting an interest holder's interest in

7	Subject to section 11.17 of this title and any contractual rights, a converting

1	(b) A domestic general or limited partnership may amend a plan of

5	(2) by the partners as provided in the plan, but a partner who was
6	entitled to vote on or consent to approval of the conversion is entitled to vote
7	on or consent to an amendment of the plan that will change:
8	(A) the amount or kind of consideration the partner may receive
9	under the plan;
10	(B) the public organizational documents, if any, or private
11	organizational documents of the converted organization in effect after the
12	conversion, except for a change that the interest holders of the converted
13	organization are not required to approve under its governing statute or
14	organizational documents; or
15	(C) other terms or conditions of the plan if the change would
16	adversely affect the partner in any material respect.
17	(c) A domestic limited liability company may amend a plan of conversion:
18	(1) in the same manner the company approved the plan, if the plan does

1	(2) by the managers or members as provided in the plan, but a member
2	who was entitled to vote on or consent to approval of the conversion is entitled
3	to vote on or consent to an amendment of the plan that will change:
4	(A) the amount or kind of consideration the member may receive
5	under the plan;
6	(B) the public organizational documents, if any, or private
7	organizational documents of the converted organization in effect after the
8	conversion, except for a change that the interest holders of the converted
9	organization are not required to approve under its governing statute or
10	organizational documents; or
11	(C) other terms or conditions of the plan if the change would
12	adversely affect the member in any material respect.
13	(d)(1) After a domestic converting organization approves a plan of
14	conversion, and before a statement of conversion takes effect, the organization

14	§ 11.07. EFFECT OF CONVERSION
15	(a) When a conversion takes effect:
16	(1) The converted organization is:
17	(A) organized under and subject to the governing statute of the

19	(B) the same organization continuing without interruption as the

1	(2) The property of the converting organization continues to be vested in
2	the converted organization without transfer, assignment, reversion, or

4	(3) The debts, obligations, and other liabilities of the converting

8	rights, privileges, immunities, powers, and purposes of the converting

13	(6) The public organizational documents of the converted organization
14	takes effect.
15	(7) The provisions of the organizational documents of the converted
16	organization that are required to be in a record, if any, that were approved as
17	part of the plan of conversion take effect.
18	(8) The interests in the converting organization are converted, and the
19	interest holders of the converting organization are entitled only to the rights
20	provided to them under the plan of conversion.
