





# **Outcomes: Enterprise Fund**

Started Fiscal year with \$2,124,025

Canadian Prospect: \$200k awarded

GW Plastics: \$500k awarded

Projected 148 new jobs with Capex of \$14.8 million

A few more prospects will come before the e-board.

Meant to augment retention and recruitment efforts: with or without VEGI.



# **Outcomes: Vermont Training Program**

STAFF OF 1.5

#### **EMPLOYEES**

Over 3200 Vermont workers were trained under the program through both on-site training as well as classroom

Trade skills in HVAC, welding and electrical repair were requested either through a training provider or an individual business application

The median quarterly wage increased by 15.3% between the second quarter of 2013 to the third quarter of 2015. On an annualized basis, the analysis shows a median wage increase from \$51,802 to \$59,738 between second quarter 2013 and third quarter 2015.

#### **EMPLOYERS**

272 companies served, 92 of them have 49 employees or less.

Leadership training was a popular training request as businesses continue to adjust to workforce needs and challenges..

Software and IT training were requested as more businesses are continuing to streamline their processes with the support of various software. Businesses continue to train internally as the number of incumbent employees trained is a majority of the applications for both skill upgrades as well as advancement in position.

#### TRAINING PROVIDERS

Fourteen training providers were awarded grants and they served 244 businesses across the State.

Advanced manufacturing skills such as Lean Technology was the most sought after but CAD and CNC were also popular requests. CNC skills were trained in traditional metal fabricators but were also needed in wood prefabrication companies.

# Outcomes: International Trade and Investment (VGTP)

#### **EXPORT ASSISTANCE**

Federal SBA (STEP IV) grant. The \$174,000 grant will allow VGTP to continue some of the work that was started with the STEP III grant. This work will include business export training and participation in international trade shows such as MEDICA – the world's largest medical trade show – in Germany; Aero Montreal where companies will have access to Quebec's \$13.8 billion aerospace cluster; and Hannover Messe, which the United States is this year's partner country.

Assisted five eligible Vermont small businesses to attend Arab Health in Dubai joining the Best of New England booth. (This was the first time VGTP had a presence at this trade show, resulting in an expected 3.5 million dollars.

#### EB-5

As of December 30, 2015, approximately \$563,000,000 has been invested in projects via the Vermont EB-5 Regional Center. We calculate some 2,385 direct, indirect and induced jobs are being supported via EB-5 investment in the State of Vermont.

#### FDI

Attended select usa Event in Toronto which has generated leads.

The Vermont Quebec Inititative commenced this past year with several events in VT and Montreal.

Will Participate in Hannover Messe this year and will participate in the FDI component.

# Working Lands

**NBRC** 

One Business Support staffer serves as our liaison to the working lands enterprise board.

Review of 142 applications, funded 36 for a total of \$1.2mm, leveraging \$1.8MM additional funds

Established scoring and review process for these economic and infrastructure grant program for non-profits and municipalities in Franklin, Caledonia, Essex, Lamoille, and Orleans Counties

Granted approximately \$1.2 million to non-profits and public entities for six economic development projects across the NBRC service area (Northeast Kingdom, Lamoille, Franklin, and Grand Isle counties), which in turn leveraged an additional \$2.6 million in matching funds.



# Outcomes: Brownfields Redevelopment

#### **FUNDED PROJECTS**

Franklin (subgrant - Downtown Core remediation)

Windsor (Loan - 100 River Street/Beer Shapers)

Bennington (both loans - Vermont Tissue redevelopment and Alcaro Motors)

Washington (subgrant - 22 Keith Street)

Chittenden (all loans - 28 Archibald, 247 Pearl and 237 North Winooski) counties in 2015



We also identified new BERA (Brownfield Economic Revitalization Alliance) projects: Richmond Creamery redevelopment, Robertson Paper Mill Project in Bellows Falls and J&L Plant One in Springfield

To date, we have provided funding to every region in Vermont with the exception of Grand Isle and the Northeast Kingdom, but we are working on a couple of possible projects in the NEK at this time.

In 2015, three projects supported new housing development.

One, 28 Archibald in Burlington, allowed the City to create a community garden in the North End.

Two, Bennington, the Vermont Tissue project created space for a distillery and the developers were also able to restart a long-idled hydro facility.

Three, Also in Bennington, we funded the redevelopment of the Alcaro Motors site, which is now the site of a furniture store.

St. Albans, we were able to provided funding to the City to assist with the downtown core project; which allowed for the construction of a new State Office building and the expansion of Mylan Technologies.

# **Outcomes: VEPC**

### TIF

For the 7 active TIFs, selected activity for FY14:

Public Infrastructure Investment: \$5.7 million

Private Sector Investment: \$53 million

Vermont Contractors: \$13.5 million

## **VEGI**

Approved nine business projects that will contribute an additional \$1.7 million in net new tax revenue (after the cost of the incentive) over the next five years. The businesses will create 332 new jobs with an average compensation of \$48,250, generating \$13.5 million in new, qualifying payroll.

For 2007 to 2013 we invested \$10 million to leverage investments of \$866 million by the private sector recipients.

### **WCEDP**

During FY15, \$3.144 million has been committed for projects that will result in the creation of 142 direct jobs.

Leverages \$16.2 million of private investment.
