# Grant Programs at the Vermont Agency of Agriculture, Food & Markets (VAAFM) -- Grant Descriptions --

# Agricultural Fairs & Field Days Capital Projects Competitive Grants Program

Provides financial assistance to Vermont agricultural fairs and field days for capital projects.

# Who can apply?

Applications are sent to all eligible fairs and field days throughout Vermont. Agricultural fairs and field days must operate a minimum of three consecutive eight-hour days per year in order to be eligible.

# When are applications accepted?

Applications are accepted between October 1st and November 1st.

#### **Maximum Award**

Dependent on legislative appropriation. Average award in 2015 was \$23,000.

# **Cost Sharing Requirements**

There is a 15% match requirement.

# **Agricultural Fairs Stipend Fund Program**

\_\_\_\_\_

Provides Vermont Agricultural Fairs with financial support for competitive exhibits, plant improvements, and general operations.

#### Who can apply?

Qualifying Agricultural Fairs or Field Days must meet minimum selection criteria; applications are sent to all eligible fairs and field days throughout Vermont.

# When are applications accepted?

Applications are accepted between Jan. 1st & Feb. 1st.

# **Maximum Award**

Dependent on legislative appropriation. 2015 awards ranged between \$2,000-\$9,000.

# **Best Management Practice Cost Share Program**

Provides financial assistance for the voluntary construction of on-farm improvements designed to abate nonpoint source agricultural waste discharges into the waters of the state.

# Who can apply?

Program funds are available to farmers seeking voluntary implementation of farm improvements; projects are selected on the basis of watershed treatment priorities.

# When are applications accepted?

Applications are accepted and evaluated year round.

#### **Maximum Award**

\$50,000 for a single farm or \$75,000 for multiple farms

### **Cost Sharing Requirements**

Funds can be combined with federal cost share to provide a maximum of 85% of an approved project. State cost share is limited to a maximum of 35% when combined with federal cost share and up to 80% without federal cost share. Farmer covers a minimum of 15% of costs.

# **Conservation Reserve Enhancement Program**

Provides financial assistance to build/maintain conservation buffers along waterways to abate nonpoint source agricultural waste discharges into the waters of the state.

#### Who can apply?

Any producer/landowner whose land is used for agriculture.

# When are applications accepted?

Applications are accepted and evaluated year round.

### **Maximum Award**

Maximum per acre incentive rates and per acre rental rates will depend on recent land use.

# **Cost Sharing Requirements**

Cost share to install the buffer practices is 90% from the Farm Service Agency. Remaining 10% may be covered by the US Fish and Wildlife's Partners Program.

# **Domestic Export Trade Show Assistance Grant**

Provides Vermont food and forestry businesses with funds to help identify, plan, exhibit and sell Vermont products at national trade shows.

# Who can apply?

Any business registered with the state of Vermont that principally produces its ag, food or forestry product in state.

# When are applications accepted?

Applications are accepted between Nov. 1st & Dec. 1st.

#### **Maximum Award**

The grants have a maximum award of \$2,000.

# **Cost Sharing Requirements**

There is 50% cash match requirement.

# **Farm Agronomic Practices Program**

Provides financial assistance to Vermont farmers to implement annual soil-based practices that improve soil quality, increase crop production, and reduce erosion and agricultural waste discharges.

# Who can apply?

Funds are available to farmers seeking voluntary implementation of farm agronomic practices. Educational and instructional activity grants are available to farmers, citizens and organizations.

### When are applications accepted?

Applications accepted and evaluated year round.

# **Maximum Award**

The maximum award in this program is \$5,000 per farm and \$1,000 per educational activity.

# **Farm to School Grant Program**

Provides financial and technical assistance to Vermont schools to plan and implement farm to school programs.

# Who can apply?

Any Vermont school, school district, supervisory union or consortium of schools may apply.

# When are applications accepted?

Applications accepted between October and November.

\$10,000

# **Cost Sharing Requirements**

Cost sharing is preferred, but not required.

# **Milk Cooler Grant Program**

Provides financial assistance to Vermont schools in order to increase student access to fresh, nutritious dairy products.

# Who can apply?

Any Vermont school may apply.

# When are applications accepted?

Applications are accepted and evaluated year round.

# **Maximum Award**

\$1,000 is available per school toward purchase of a new milk cooler. No grant payment can exceed the total cost of the cooler.

# **Cost sharing requirements**

Applicants are responsible for any costs incurred above the \$1,000 grant award limit.

# **Mosquito Control Grants**

Provides state financial assistance to Vermont Mosquito Control Districts for voluntary survey and control of nuisance mosquitoes that breed and emerge from wetlands within these districts.

# Who can apply?

Vermont Mosquito Control Districts may apply.

# When are applications accepted?

Applications are accepted and evaluated year round.

#### **Maximum Award**

Based on available funding and demonstrated need.

# **Cost Sharing Requirements**

Applicant districts are required to demonstrate a 25% match, which may be met through actual cash contribution or through in-kind services, including adulticide application or the purchase of capital equipment for mosquito control.

# **Specialty Crop Block Grant Program**

Provides funds to enhance the competitiveness of Vermont specialty crops including fruits and vegetables, honey, maple, hops, Christmas trees and nursery crops.

# Who can apply?

Any business, organization, or individual may apply, but projects must demonstrate measurable benefits to more than one business, organization or individual.

# When are applications accepted?

Applications are generally accepted each spring, after the VAAFM issues a Request For Proposals (RFP).

#### **Maximum Award**

Awards are not capped; successful proposals are generally awarded between \$10,000 and \$30,000 per project year.

Projects can be up to three years in length.

# **Cost Sharing Requirements**

Applications must show matching funds of at least 50%.

# Specialty Crop Multi-State Program

Provides funds to enhance the competitiveness of specialty crops through collaborative, multi-state projects that address regional or national-level specialty crop issues including food safety; plant pests and disease; research; crop-specific issues; and marketing and promotion.

# Who can apply?

Any business, organization, or individual may apply. Projects must demonstrate measurable benefits to more than one business, organization or individual, and project partners must be based in more than one state.

#### When are applications accepted?

We expect AMS to announce the next request for applications in the summer or fall of 2016.

#### **Maximum Award**

Proposals can request between \$250,000 and \$1,000,000.

# **Water Quality Grants**

Provides financial assistance to organizations to improve Vermont's water quality, targeting specific locations or practices. Projects are initiated by VAAFM and may be awarded directly to an entity or applied for through a Request For Proposals (RFP) opportunity.

# Who can apply?

Projects are initiated by VAAFM and may be awarded directly to an entity or applied for through a Request For Proposal (RFP) opportunity.

#### **Maximum Award**

Payments are based on performance measures established within individual grant agreements.

# **Working Lands Enterprise Fund**

Provides funds to support agriculture and forestry projects that enhance Vermont's communities, economy, and culture.

# Who can apply?

Primary applicant must be based in Vermont and registered with the Vermont Secretary of State at the time of full application submission.

# When are applications accepted?

Applications are accepted in the fall, after the VAAFM issues a Request For Proposals (RFP).

#### **Maximum Award**

- 1. Proposals for Business Investments can request between \$5,000–\$50,000.
- 2. Proposals for Service Provider Investments can request between \$15,000–\$75,000.

# **Cost Sharing Requirements**

- 1. Business Investment budgets must show at least a 1-to-1 match. At least 50% of this match must be cash; the rest may be in-kind.
- 2. Service Provider Investments require a 100% (1-to-1) cash or in-kind match of total requested funds.

# **DEFINITIONS**

# **Cost Sharing and Match**

These terms are used to describe a requirement or condition that a minimum amount of funding for a proposed project originates from another source.

# **In-Kind Match**

In-kind contributions may include personnel time; use of existing equipment or facilities; and waived or unrecovered indirect (administration) costs.

# **Cash Match**

"Cash match" is real cash contributed to a project, such as cash contributed by an organization; equipment purchased; personnel to be hired; or paying for a brochure.
