- The Committee on Corrections and Institutions to which was referred

 Senate Bill No. 212 entitled "An act relating to court-approved absences from

 home detention and home confinement furlough" respectfully reports that it

 has considered the same and recommends that the House propose to the Senate

 that the bill be amended by striking out all after the enacting clause and

 inserting in lieu thereof the following:
- 8 Sec. 1. 13 V.S.A. § 7554 is amended to read:
- 9 § 7554. RELEASE PRIOR TO TRIAL
 - (a) Any person charged with an offense, other than a person held without bail under section 7553 or 7553a of this title, shall at his or her appearance before a judicial officer be ordered released pending trial in accordance with this section.
 - (1) The defendant shall be ordered released on personal recognizance or upon the execution of an unsecured appearance bond in an amount specified by the judicial officer unless the judicial officer determines that such a release will not reasonably ensure the appearance of the person as required. In determining whether the defendant presents a risk of nonappearance, the judicial officer shall consider, in addition to any other factors, the seriousness of the offense charged and the number of offenses with which the person is charged. If the officer determines that such a release will not reasonably ensure the

- appearance of the defendant as required, the officer shall, either in lieu of or in addition to the above methods of release in this section, impose the least restrictive of the following conditions or the least restrictive combination of the following conditions that will reasonably ensure the appearance of the defendant as required:
- (A) Place the defendant in the custody of a designated person or organization agreeing to supervise him or her if the defendant is charged with an offense that is not a nonviolent misdemeanor or nonviolent felony as defined in 28 V.S.A. § 301.
- (B) Place restrictions on the travel, association, or place of abode of the defendant during the period of release.
- (C) Require the defendant to participate in an alcohol or drug treatment program. The judicial officer shall take into consideration the defendant's ability to comply with an order of treatment and the availability of treatment resources.
- (D) Require the execution of a secured appearance bond in a specified amount and the deposit with the clerk of the Court, in cash or other security as directed, of a sum not to exceed 10 percent of the amount of the bond, such deposit to be returned upon the appearance of the defendant as required.

16	(a)(1) The Windham County Sheriff's Office (WCSO) shall establish and		
17	manage a two-year electronic monitoring pilot program in Windham County		
18	for the purpose of supervising persons ordered to be under electronic		
19	monitoring as a condition of release or in addition to the imposition of bail		
20	pursuant to section 7554 of this title, to home detention pursuant to section		
21	7554b of this title, and home confinement furlough pursuant to 28 V.S.A.		

1	§ 808b. The program shall be a part of an integrated community incarceration
2	program and shall provide 24-hours-a-day, seven-days-a-week electronic
3	monitoring with supervision and immediate response.
4	(2) For purposes of this program;
5	(A) if electronic monitoring is ordered by the Court pursuant to
6	section 7554 of this title, the Court shall use the following criteria in section
7	7554b for determining whether home detention electronic monitoring is
8	appropriate;
9	(B) the seven-day waiting period under 7554b of this title shall not
10	apply; and
11	(C) for persons who are under the custody of the Department of
12	Corrections pursuant to section 7554b of this title and 28 V.S.A. § 808b, the
13	WCSO shall notify the Department of any violations.:
14	(A) the nature of the offense with which the defendant is charged;

4	(b) The goal of the pilot program is to assist policymakers in determining	
5	whether electronically monitored home detention and home confinement can	
6	be utilized for pretrial detention and as a post-adjudication option to reduce	
7	recidivism, to improve public safety, and to save valuable bed space for	
8	detainees and inmates who should, without an electronic monitoring program,	
9	would otherwise be lodged in a correctional facility. Additional benefits may	
10	include reducing transportation costs, increasing detainee access to services,	
11	reducing case resolution time, and determining if the program can be replicated	
12	statewide.	
13	(c) The WCSO shall work with the Crime Research Group (CRG) for	
14	design and evaluation assistance. The program shall be evaluated by CRG to	
15	determine if the stated goals have been attained, the cost and savings of the	
16	program, identifying what goals or objective were not met and if not, what	
17	could be changed to meet the goals and objectives to ensure program success.	
18	The Joint Fiscal Office shall contract with the CRG to provide design and	
19	evaluation services.	
20	(d)(1) The WCSO is authorized to enter into written agreements with the	
21	sheriffs of other counties permitting those counties to participate in the pilot	

1	program subject to the policies and procedures established by the WCSO under	
2	this section. At least one of the agreements shall be between the WCSO and a	
3	county with a significant population.	
4	(2) The purpose of expanding the electronic monitoring program to	
5	other counties under this subsection is to increase the number of participants to

3	(a) An offender may be sentenced to serve a term of imprisonment, but
4	placed by a court on home confinement furlough that restricts the defendant to

6	Home confinement furlough shall be enforced by appropriate means of
7	supervision, including electronic monitoring and other conditions such as
