## FY 2017 Governor's Proposed Budget Secs. E.100.6-E.100.44 Creation of Division of Purchasing and Contracting

### **Overview**

- Transfers the State's purchasing and contracting responsibilities from the Department of Buildings and General Services (BGS) to a newly-created Division of Purchasing and Contracting
- Keeps purchasing and contracting responsibilities within the Agency of Administration
- Places all of the State's responsibilities for bidding, procurement, contracting, printing and purchasing supplies within the new division

### Framework of New Division

- Creates a new "division" within the Agency of Administration
  Orafting note re: 3 V.S.A. § 2289)
- Establishes a Director of the Division and sets this as an exempt (appointed) position
  - (Note re: testimony requesting two new positions and creation of exempt position)
- Places Division directly under the Secretary of Administration
  (Drafting note re: 3 V.S.A. 213)
  - (Dratting note ie. 5 v.S.A. 213)

# **Division's Powers and Duties**

- Transfers the following responsibilities from BGS to the Division of Purchasing and Contracting:
  - Oversees bidding and procurement for the State (all State departments, offices, institutions, and agencies)
  - Purchases equipment and supplies for State (including all State agencies and departments, and schools)
  - Manages State purchase card program (and administers related revolving fund)
  - Procures food and agriculture for the State
  - Oversees compliance with bidding requirements
  - Oversees State duplicating services
- Provides that the Agency of Administration, through the Division, shall maintain the prohibited contractor's list

#### Changes to BGS Authority

- Requires Commissioner to request the Division to give public notice to employ an architect or other professional assistance
- Provides that Commissioner may contract for custodial and maintenance services after Division completes bidding process
- Requires Commissioner to have Division advertise or invite bids for construction projects in excess of \$50,000.00
- Transfers responsibility to the Division for establishing evaluation criteria for the competitive procurement process for the designbuild construction delivery process
- Maintains fleet management system, but does not oversee purchasing of vehicles
- Removes BGS' authority to establish substitute practices and exceptions to requisitioning and purchasing procedures
- Removes responsibility of BGS to employ an engineer to assist buyers and requisition agencies in formulating specifications
- Transfers responsibility to develop quality standards for State purchases, and prescribe forms for purchasing, warehousing, and inventory functions, from Commissioner of BGS to Secretary of Administration
- Maintains printing and supply services for State departments and agencies, but requires Commissioner of BGS to coordinate with the Director of Purchasing and Contracting to assess a rate for printing and requires Commissioner to consult with Director on printing jobs
- Transfers BGS' responsibilities to the Division to bill expenses for all proposals and contracts to Division
- Transfers Commissioners' authority to the Division to designate a printer for legislative documents
- Transfers Commissioner's authority to the Division to obtain State flags
- Transfers Commissioner's authority to the Division to purchase spirits and wines on behalf of the Liquor Control Board
- Transfers responsibility to the Division to purchase liability insurance from the Commissioner to the Secretary of Administration and consult with the AG on settlements and claims against the State
- Transfers responsibility to the Division to consult with the State Board of Education on rules for the prequalification of bidders on school construction projects

- Transfers responsibility to the Division to solicit bids and award contracts for engineering services for the Veterans Home
- Transfers responsibility to the Division to coordinate with the Department of Corrections on using the bidding process to come up with cost effective alternatives for housing inmates in out-of-state correctional facilities.
