## 3SquaresVT – (SNAP) Supplemental Nutrition Assistance Programs

- 3SquaresVT is a federal USDA program that helps eligible Vermonters to stretch their food budgets and put three healthy meals on their tables every day
- At the national level, the program is called the Supplemental Nutrition Assistance Program or SNAP
- SNAP is the largest program in the domestic hunger safety net
- ESD works with community partners such as Community Action Agencies, Area Agencies on Aging, the Vermont Food Bank, Hunger Free Vermont, and others to reach out to Vermonters who are eligible for 3SquaresVT and ensure they can access benefits



## **Bonus Awards FFY 2014**

#### **Best Program Access Index - \$252,344.00**

 The Best Program Access Index is the percentage of people below 125% of FPL in Vermont who are accessing SNAP benefits. Vermont's Program Access Index is 92.99%. Vermont ranks 5<sup>th</sup> in the country.

#### **Most Improved Payment Accuracy Rate - \$293,274.00**

• Vermont's payment accuracy rate was 9.66% in FFY 2013 and improved to 2.76%, the most improved in the country.

## Payment Error Rate (PER)

#### FFY 2013 Error Rate

• Received a penalty that was approximately \$575,000 for an error rate of 9.66%. Vermont appealed the penalty and reached a settlement for \$202,593.92.

#### FFY 2012 Error Rate

Received a penalty that was \$135,606.00 for an error rate of 6.96%.

#### FFY 2011 Error Rate

Received a penalty that was \$341,187.00 for an error rate of 8.53%.

## Payment Error Rate Improvement Activities

- Added eligibility staff: 12 BPS in Fall of 2013
- Re-established training unit: 1 manager, 2 trainers for 3SquaresVT in Fall of 2013
- Returned to a Geographic Case Load in 2014
- Instituted Supervisory Case Reviews in 2013
- Quality Assurance Case Reviews beginning in August 2013 and expanded in November of 2014
- IT changes to ACCESS
- Hired outside consultant for policy/process improvements and trainings for QC and eligibility staff
- Intensive Training for eligibility staff in 2013
- New Worker Trainings which are ongoing
- Interviewing Excellence Training in 2014
- Refresher Training which are ongoing
- Targeted Trainings-topic specific (child care deductions, medical deductions, etc.) which are ongoing
- Managing Performance Training for Managers and Supervisors in 2014

## Payment Error Rate FFY 15

While we are still finalizing the review of cases we anticipate the PER for FFY 15 to be approximately 1.25%.
