**APPELLATE AND ADMINISTRATIVE RESPONSIBILITIES OF THE SUPREME COURT**

Pursuant to the Vermont Constitution, Chapter II, §§ 30; 31 and 37, Administrative Order No. 14 is amended as follows (new matter underlined, deleted matter overstruck):

To implement the appellate and administrative responsibilities of the Supreme Court under Chapter II, § 30 of the Vermont Constitution, the State of Vermont is divided into four areas as follows:

Area I	Chittenden Grand Isle Franklin Essex	Area II	Rutland Addison Bennington Windsor
Area III	Windham Lamoille Washington (trial courts)	Area IV	Washington (administrative boards and agencies) Caledonia Orleans Orange





Associate Justice Crawford <u>Eaton</u>	Area IV



House Judiciary Committee Hearing  
Testimony on “Lightening the Load” Bill.  
February 3, 2016

*Transcribed by Douglas DiSabito*

Leg. Counsel Erik FitzPatrick: “. . . Regional Venue. That starts on page 12. And the idea right now, if you think of the concept of venue. Venue is in which Court do you file your action. And by that I mean, by which Court, not which type of Court, but it is more geographic. Where does venue lie. [inaudible] venue rules, depending on what kind of case you have. A personal injury case, you could file in the court where the injury occurred, or where the plaintiff or the defendant reside. That means, which court do I file it in. You know, which district, which county. So there are all these rules for venue, and the proposal here is to create what’s known as ‘Regional Venue’. So in certain instances, in certain cases, if you might, it allows the Court to create I believe four county regions, or is it four district, or four unit regions . . . up to, yeah, regions of up to four counties. This is on page 13, lines 16 & 17. So it permits the Court to, or authorizes the court to designate a region of no more than 4 counties in which the venue for specified types of cases, so that could be particular types of cases, in the region, shall be a region as a whole irrespective of the region in which the venue would lie for the case under the governing statute. So in other words, if you were ordinarily, under the typical venue rules, if you were, you would have to file, for example, in a particular county, if that county was part of one of these ‘up to four county’ regions, you could file, or perhaps hold a hearing in one of the other counties. And I think that is also connected to, you don’t see it here, but one of the provisions that was repealed in last year’s budget, which was related to the concept of judicial funding, was this video arraignment. So there was a prohibition on video arraignment that was repealed. So now, video arraignment can be done. So that’s just one example of it, but I think the expanded use of video will be, will dovetail with the authority establish regional venue, so that person could appear by video perhaps in one county while a judge sat in another county.”

Court Admin. Pat Gabel: “Judge Grearson is prepared to address Regional Venue.”

Judge Brian Grearson: “So I guess, in short, this was part of the bill last year, and by the end of the process it was down to regional venue for TPRs, as it came out of the senate side. And then it did not survive the conference. Just by way of background, since then, the S9 workgroup

that came out of that legislation, in discussing to approaches to TPRs and the issues surrounding the impact of opiates on the juvenile docket, and the caseloads that are quite frankly driving a great part of this request, although I do not believe of the committee elected to come forward with a bill this year, they are talking about regionalization for TPR purposes [inaudible]. And so this, although it is more expansive than that, the concept is the same, and it is not as some folks believe last year and perhaps continue to believe this year, that it is designed to close Courts. The Judiciary has no intention of closing any Courts, and I can tell you that over the last few months, as new judges have come on, the reality is that there is, I do not believe any one Court that needs a judge. Rather, almost every Court needs additional judge time. So what I have been attempting to do, as the new judges come on, in many of the dockets—the domestic docket, the civil docket, that take a backseat in many counties, either for completely lack of a judge or they are just backed up with their dockets because the focus has been on the juvenile docket, and the one that comes to mind most readily is Franklin County. It probably has one of the largest, if not the largest, recent number of CHINS filings, CHINS petitions, children in custody. That Court has gone in a relatively short time from one or two days a week to juveniles almost four days a week. And by listening closely to the judge hearing those cases, they would want five days a week. So what I have attempted to do, as new judges come on, is have a judge come on to hear more of the domestic cases to free up the judge to continue to hear juvenile cases. And that has worked up to a point where I now have more judge time available that I can put into Franklin County, but I do not have the physical space within Franklin County to hear more cases. We are currently using the Court in the State Court building, and we also use the County Court. And the County Court presently, or historically had three days of civil scheduled and two other days the judicial bureau hears its cases in there. In the last week, this is an evolving situation, last week I convinced the Judicial Bureau to reduce their number of days in that Court to two days a week<sup>1</sup>. But even with that additional time, in my discussion with the Court Clerk in Franklin, I put a simple question to her: If I have more judge time available, do you have a place to put that judge, and the answer is no. And so what I have tried to do is get a discussion going with the Bar in Franklin about the opportunity to hear cases in Grand Isle which right now is one day a week, leaving four days, almost four days, they sometimes have a Magistrate over there or their own Judicial Bureau, but to hear Franklin cases, domestic cases, in Grand Isle. It has not been met with a resounding vote of confidence to do that. But I

am still having those discussions with them, and I don't know if I can convince them of the wisdom of that or not. Of course, the immediate response is the travel involved for litigants or parties, which we recognize. But what I also recognize, is that there are significant delays in getting cases heard, and this one way in trading off if you want to wait six to nine months to get a case heard partially—in other words, a day here and a day here—or do you want to go over to Grand Isle in this case and where we can devote a day or a day-and-a-half or two days, whatever is needed. So this is the same way I believe this statute could be used, when there is a demand, when there is a need to move dockets, that this could be the mechanism to do it. And so in its simplest terms, that is the way I see this being used. It's not designed to reduce activity in any particular Court. It gives us more flexibility to hear the cases that need to be heard. We just run out of physical space to do them up there. And it's common in other Courts, where the caseloads have grown. For instance, in Barre there used to be one day a week Juvenile Court; it is now two days a week. And I know they could use more time. They share their Courtrooms as well with criminal, family, magistrates, juvenile and judicial bureau. And again it's a space [inaudible]. There are other Courtrooms there. So again, that's it in its simplest terms, and the idea behind it. And I'll be glad to answer any questions."

Rep. Chip Conquest: "So you had said, I think, that there's a bill in the senate now, or there was last year, and may now that would do this just for TPR's?"

Judge Brian Grearson: "That's how this bill started out in the senate, the same, exactly the way it's written. In the Senate Judiciary, by the time we left there, it was reduced down to TPR's. Then it did not survive conference."

Rep. Chip Conquest: "So is your feeling though that you would, your preference would be to leave it with the language that would specify types of cases giving you the latitude to do it for the various cases?"

Judge Brian Grearson: "Yes."

Rep. Chip Conquest: "So I understand that you are not doing this in order to close Courts, but I am wondering what the practical effect if it's a four county area, and perhaps I should preface that I don't quite know how all this works, in terms of venue, but if it's a four county area, that could be a fairly large area in parts of Vermont, or just in terms of getting from one side of that

area to another. So I guess I wonder about, does that present, you acknowledge that it might present some problem for litigants and various people involved that have to go from one area to another if it's that far away. So I just wonder if that needs to be examined farther, but mostly if it's, aren't we, is there a possibility that the, since small Courts are small and likely to be the ones that don't have room, that you're going to be asking, the venue is going to be established in somewhere that there is more room typically, and so the effect will be that, even though you don't intend to close the Court, the effect will be that much of the work of some Courts will be moved out of their county regularly. Is that a valid possibility of the way that this is set up?"

Judge Brian Grearson: "I understand. In the sense that anything is possible, sure. But that's not what we are trying to do here. There's a balance in my mind of, yes there are transportation issues, but there are transportation issues anywhere in Vermont, and we recognize that. But what we are seeing is, if these cases are not being heard, it's a balancing on the one hand, whether it's a TPR where the rights of the child and the parents are at stake, or whether it's a divorce case for instance, where the people are waiting for a hearing for dividing property, determining the same issues in a juvenile case, in other words, deciding parental rights and responsibilities, and parent-child contact, somewhere I think there could be a balance that this case, it's worth it to travel that hour to get that case heard, rather than to just let it languish there. And we are already hearing cases that aren't being heard where, you know, bills still have to be paid, mortgages have to be paid, and it's up in the air as to who's responsible, for the lack of the hearing time. So, I will use Grand Isle as an example, because I was up there for a couple of months during their regular docket, and I know that they schedule one day a week at this time, and I know that the State's Attorney is very concerned about closing that Court, and the example I gave is just one example of, it's using the resources that are available to us, and what it means is if we are over there hearing a divorce, we will have, we're there. There may be times when we can hear their cases so that when they're crying out for more need, we'll be able to address that. When I say this dialogue is still going on, I had communicated with an attorney in Franklin; they have a regular monthly bar/bench meeting and I was hoping to be there today, but I couldn't. But he sent me a very lengthy email saying that all of this was discussed there, and one of the comments was that they need four judges up in Franklin, and I am close to being able to give them four judges, but I don't have any place to those four judges. So I am trying to take advantage of what, you all know my theme song last year was, that I don't have the judges and I have vacancies. Now as we're filling them, we're

trying to use them in different ways, because there is no one Court that needs them. In spreading them out, we are trying to address the issues that were in part created by this [inaudible] juvenile docket and give people hearings sooner. This is one way of doing it. This gives us another way of doing it.”

Rep. Willem Jewitt: “What would the Court think if it were drafted to draw some limits on it, so that it were only useable to alleviate to run in the direction that you’re talking about and not necessarily in the other direction, so to alleviate waiting lines, rather than to depopulate, if you will, a docket of a Court that wasn’t fully utilized.”

Judge Brian Grearson: “I think the way that this bill is drafted at this point, with this committee’s expertise, there may be another way to accomplish what we want, and what this committee would find acceptable. We think this is the way, this gives us the most flexibility. This is something that I am told historically long before my time, has come before a many number of years, and there may have been different motivations, as I wasn’t here, but what I am seeing is getting letters, emails, phone calls from attorneys saying we need more hearing time. And so now we are in a position to try to provide that hearing time and we need as much flexibility, uh. There may be some cases that are more appropriate for this than others. But I would leave that to the committee to discuss, and I’ll be glad to discuss it further. But we think it’s an approach that’s overdue in order to take advantage of [inaudible].”

Rep. Thomas Burditt: “I’m just wondering what kind of challenges were created, I know there’s two judges in the Rutland area that were recently, one with a personal injury, and one with a family member, and they both, I know one is back and that one is still missing time due to a family member. What kind of challenges has that created for you, because there was a significant amount of time when they weren’t able to work.”

Judge Brian Grearson: “Let me put it into perspective. As of September of this past year, I had six vacancies. So the fact that I am now able to fill some of those, I’m used to having judges not being available. What it really means is in both those cases, and in particular the most recent one, in order to accommodate the fact that that judge was no longer available in one docket, in order to make up for that, it involved moving, impacting four other counties. In other words, moving a judge sitting in one county over to another county [inaudible] to another docket. And so something, I don’t want to say, as simple as that, but something that happens, it involves or

impacts four counties and four or five judges. And so, we've done it. It's again part of this patchwork that I've been putting together for the last year. I'm used to doing that, so it didn't help anything, but that is what we've been doing for the last year, so it was something that . . .”

Rep. Thomas Burditt: “Routine.”

Judge Brian Grearson: “Well, I don't want to say it was routine, but we've adjusted to it because we had someone last summer that was in an accident that we lost, uh, and when we lose folks like that, we generally schedule out two to three months. So when someone goes down unexpectedly, it creates a real problem, because they're all, every docket is scheduled, so it requires some movement. It requires, as we have been, using other judges in different roles. We've had the Supreme Court sit on, justices sit on jury trials, we've had them sit on TPR's. They sit on mental health hearings. So we're using retired judges. Everybody gets a call from me.”

*[At this point, Rep. Betty Nuovo asked Judge Grearson about law clerks, and whether they can alleviate the work loads of judges—this seemed unrelated to the topic/discussion of Regional Venue.]*

Court Admin. Pat Gabel: “I just want to remind those who may not remember that when the Court does things by rule, which is what would happen in the case of venue, it not only goes through a very elaborate and deliberative rulemaking process in the Judiciary, but then those proposed rules still go over to the Legislative Committee of Judicial Rules. So there is a process where, and the way that works is when the Judiciary is still in the process, the rules normally go out as proposed rules, the Bar gets a chance to comment on them. Then they go back to, sometimes it's the rules committee itself that looks at it. If it's an emergency, it might be the Court. But there is an opportunity to explore some of these issues as the Court is looking at adopting rules [inaudible] on the legislative side. We've had some very lively and dynamic discussions with the Legislative Committee on Judicial Rules. And sometimes rules don't go ahead as a result or that, or they get changed along the way.”
