Mission

The Commission promotes full civil and human rights in Vermont. The Commission protects people

from unlawful discrimination in housing, state government employment and public accommodations and pursues its mission by enforcing laws,



mediating disputes, educating the public and providing information and referrals.

Duties

The Commission:

- Works to create public awareness of the importance of human and civil rights
- Examines and evaluates the effectiveness of Vermont's civil rights laws
- Identifies the existence of practices of discrimination that detract from the full enjoyment of civil and human rights
- Recommends measures to protect those rights

Commissioners

- There are five (5) Commissioners appointed by the Governor and confirmed by the Senate.
- They are appointed for five (5) year terms which are staggered so that one Commissioner's term ends each year.
- Commissioners can be reappointed.
- At least one Commissioner must be a member of a racial minority.

Enforcement

The HRC has three investigators who conduct <u>impartial</u> <u>investigations</u> into allegations of discrimination in the areas of:

- Housing- rental and sales
- Public Accommodations- any establishment or facility that offers services, goods, facilities, privileges, advantages, or benefits to the public
- State Government Employment-(private employment issues go to the Attorney General)



State vs. Federal Law

- Vermont law provides protections similar to those provided under the federal Civil Rights Act of 1964 specifically Title II (public accommodations), Title VI (access to government services), Title VII (employment), Title VIII (housing) and §§503 and 504 of the Rehabilitation Act of 1973 and the American's with Disabilities Act (ADA) (disability)
- Vermont law has more protected categories than federal law






Type of Case and Protected Category FY14




Fiscal Year Comparisons

OUTCOMES- FY14

Fifty-six (56) cases were closed:

- 24 settled either pre or post-determination
- 11 cases were heard by the Commissioners
 Of those, 4 were reasonable grounds and 8
 were no reasonable grounds
- 10 were administratively dismissed or withdrawn
- 11 charges were sent out but not returned

RELIEF

Monetary settlements: \$345,000

Public interest relief:

- Training
- Changes in policies or procedures
- Job restored, supervisor changed, etc.
- Accommodation granted
- Premises made more accessible

Training and Outreach

- Staff provided training to 37 groups or individuals
- Staff attended and participated in 20 other outreach related activities

New statistics being gathered for FY15 will allow us to better track the number of individuals reached. In the first 6 months of FY15, we have provided training or outreach to 388 people.
