Representative Sibia of Dover moves that the bill be amended as follows:

First: In Sec. 9, 18 V.S.A. § 4353, by striking out subdivision (a)(1) in its entirety and inserting in lieu thereof a new subdivision (a)(1) to read:

- (1) Restaurant I – Seating capacity of 0 to 25; ~~\$85.00~~ \$94.00
- II — Seating capacity of 26 to 50; ~~\$145.00~~ \$160.00
- III — Seating capacity of 51 to 100; ~~\$245.00~~ \$270.00
- IV — Seating capacity of 101 to 200; ~~\$305.00~~ \$335.00
- V — Seating capacity of over 200; ~~\$390.00~~ \$430.00
- VI — Home Caterer; ~~\$95.00~~ \$105.00
- VII — Commercial Caterer; ~~\$200.00~~ \$220.00
- VIII — Limited Operations; ~~\$95.00~~ \$105.00
- IX — Fair Stand; ~~\$70.00~~ \$77.00; if operating for four or more days per year; ~~\$160.00~~ \$176.00

Second: In Sec. 9, 18 V.S.A. § 4353, by striking out subdivision (a)(2) in its entirety and inserting in lieu thereof a new subdivision (a)(2) to read:

- (2) Lodging I — Lodging capacity of 1 to 10; ~~\$80.00~~ \$88.00
- II — Lodging capacity of 11 to 20; ~~\$135.00~~ \$149.00
- III — Lodging capacity of 21 to 50; ~~\$200.00~~ \$220.00
- IV — Lodging capacity of over 50; ~~\$340.00~~ \$374.00

1 Third: In Sec. 9, 18 V.S.A. § 4353, by adding subdivisions (a)(6) and (7) to
2 read:

3 (6) In addition to fees required under this subsection, restaurants and
4 similar food establishments part of a chain with 20 or more locations doing
5 business under the same name and offering for sale substantially the same
6 menu items — \$1,400.00.

7 (7) In addition to fees required under this subsection, lodging
8 establishments part of a chain with 20 or more locations doing business under
9 the same name and offering for sale substantially the same overnight
10 accommodations — \$1,000.00.

11 Fourth: In Sec. 10, 18 V.S.A. § 4446, by striking out subsection (a) in its
12 entirety and inserting in lieu thereof a new subsection (a) to read:

13 (a) A person owning or conducting a bakery as specified in sections 4441
14 and 4444 of this title shall pay to the ~~board~~ Board a fee for each certificate and
15 renewal thereof in accordance with the following schedule:

16 Bakery I – Home Bakery; ~~\$55.00~~ \$61.00

17 II – Small Commercial; ~~\$125.00~~ \$138.00

18 III – Large Commercial; ~~\$250.00~~ \$275.00

19 IV – Camps; ~~\$90.00~~ \$99.00
