13	contrary, a person shall not sell or provide tobacco products, tobacco
14	substitutes, or tobacco paraphernalia to any current or former member of the
15	U.S. Armed Forces younger than 18 years of age.
16	(c) For current or former members of the U.S. Armed Forces under 21
17	years of age purchasing tobacco products, tobacco substitutes, or tobacco
18	paraphernalia, proper proof of age pursuant to section 1004 of this title shall be
19	a photographic U.S. Military identification card showing the person is a current
20	member of the U.S. Armed Forces or a photographic identification card issued
21	by the U.S. Department of Veterans Affairs showing the person is a veteran of

1	the U.S. Armed Forces. A U.S. Military dependent's identification and
2	privilege card shall not constitute proper proof under this subsection.
3	(d)(1) Notwithstanding any provision of section 1005 of this title to the
4	contrary, a current or former member of the U.S. Armed Forces under 18 years
5	of age shall not possess, purchase, or attempt to purchase tobacco products,
6	tobacco substitutes, or tobacco paraphernalia unless the person is an employee
7	of a holder of a tobacco license and is in possession of tobacco products,
8	tobacco substitutes, or tobacco paraphernalia to effect a sale in the course of
9	employment. A current or former member of the U.S. Armed Forces under 18
10	years of age who possesses tobacco products, tobacco substitutes, or tobacco
11	paraphernalia in violation of this subdivision is subject to having the tobacco
12	products, tobacco substitutes, or tobacco paraphernalia immediately
13	confiscated and shall be further subject to a civil penalty of \$25.00.
14	(2) Notwithstanding any provision of section 1005 of this title to the
15	contrary, a current or former member of the U.S. Armed Forces under 18 years
16	of age shall not misrepresent his or her age to purchase or attempt to purchase
17	tobacco products, tobacco substitutes, or tobacco paraphernalia. A current or
18	former member of the U.S. Armed Forces under 18 years of age who
19	misrepresents his or her age by presenting false identification to purchase
20	tobacco products, tobacco substitutes, or tobacco paraphernalia shall be fined
21	not more than \$50.00 or provide up to 10 hours of community service, or both.

1	(3) An action under subdivision (1) or (2) of this subsection shall be
2	brought in the same manner as a traffic violation pursuant to 23 V.S.A.
3	chapter 24.
4	(e) Notwithstanding any provision of section 1007 of this title to the
5	contrary, an individual who sells or furnishes tobacco products, tobacco
6	substitutes, or tobacco paraphernalia to a current or former member of the U.S.
7	Armed Forces under 18 years of age shall be subject to a civil penalty of not
8	more than \$100.00 for the first offense and not more than \$500.00 for any
9	subsequent offense. An action under this section shall be brought in the same
10	manner as for a traffic violation pursuant to 23 V.S.A. chapter 24 and shall be
11	brought within 24 hours of the occurrence of the alleged violation.
