Other mergers approved by voters to date:

- Mountain Town (RED) Operational July 1, 2013
- Mount Mansfield (MUUSD) (Huntington vote pending) Operational July 1, 2015

Sample benefits identified to date:

- Better professional development and retention of teachers
- Greater equity in access to technology
- Ability to develop specialized programs using the strengths of particular staff and the strengths of particular schools
- Greater ability to provide broader, richer educational opportunities
- Equity in preparation for high school
- Clearer accountability for the superintendent and transparency for the electorate



Sample Challenges:

Proportionality of Board membership:

- Only needs to be proportional if (1) the articles of agreement apportion board members to each member town AND (2) only voters of that town vote for their own apportioned members.
- In other words, there are no constitutional requirements of proportionality if members are apportioned to each town (e.g., 2 are residents of Town A, 3 are residents of Town B, etc.) but are voted on at-large by all voters in the district. This is what we are calling the Hybrid Model.

Sample Challenges:

Management of choice to avoid inequities:

- In most proposals, the New Unified Union School Board is charged with developing a process to allow elementary school students to select the elementary school (sometimes mentioning magnet approach) – usually within a year after the new district begins operation.
- The State Board has asked districts also to provide for true access (e.g. transportation, etc...)



Sample Challenges:

Closing elementary schools:

- Boards are addressing this in a number of ways ³/₄ vote of Unified Union School Board; unanimous vote of Board; subsequent vote of host town approving; etc.
- NOTE that some of the accelerated merger articles of agreement include the RED provision of 4 years with no school closure without town approval
