I feel like after working in the woods for fifty years, and dealing with land owner's on my own, cutting my own property and others property, it seems like a violation of my civil rights to have that taken from me for not having a forestry license. If this happens it will terminate a portion of my ability to practice business as I have for years, and by looking at the list of schools and entities that we supply with heating chips including National Life and Norwich University it would appear that we have done something right over the years. As we were selected by Dave Paganelli, Orange County Forester, in charge of current use plans, to do work on his own personal property in Orange County, we have worked on state land with Brad Greenough, and we have worked on other people's property on just our own foresight and experienced forestry knowledge. Many landowners' do not want to have to pay a forester for a job that doesn't require one. If someone wants a forester I am very glad to make available a list of foresters' names. I do not understand what brought this into being, I am not quite sure what is broken in the forest industry, and I am not sure that having a forestry license will fix the problem if there is one, because, I certainly know of some foresters that collect the money instead of the land owner. They have the wood brought to their log yard, grade the wood, and pay the land owner when they are done, and they have a forestry license As with the Orange County Forester, Dave Paganelli, who we worked on his land, we worked on Brad Greenoughs property, he is the head forester for AMP violations and over sees some of the state logging operations. So, I do not understand why myself and my family can no longer log without having a forester involved on our property or neighbor's property. It would appear to be a termination of a way of life in Vermont.
