1 (C) whose death was due to abuse or neglect or acts suggesting abuse 2 or neglect. 3 (2) The Team shall review fatalities which are not under investigation 4 and fatalities in cases that have been adjudicated through final judgment. 5 (3) The Team is not required to conduct a review of a specific fatality in 6 any year, but shall not conduct more than 12 reviews of specific fatalities in 7 any year. The Team shall establish criteria for selecting specific fatalities for 8 review to ensure the analysis of fatalities occurring in institutional, home and community-based settings. 9 10 (c)(1) Beginning in 2016, the Team shall submit an annual report to the 11 Governor and the General Assembly on or before October 1 of each year. 12 (2) The annual report shall: 13 (A) summarize the Team's activities for the preceding year; 14 (B) identify any changes to the Team's uniform procedures; 15 (C) identify any system gaps and risk factors associated with deaths 16 reviewed by the Team; 17 (D) recommend any changes in statute, rule, policy, procedure, 18 training, or service coordination that would decrease the number of preventable 19 deaths in Vermont's vulnerable adult population; and

2	<u>§ 6963. CONFIDENTIALITY</u>
3	(a) The proceedings and records of the Team are confidential and shall not
4	be subject to subpoena or discovery or be admissible in any civil or criminal
5	proceedings; provided, however, that nothing in this subsection shall be
6	construed to limit or restrict the right to discover or use in any civil or criminal
7	proceedings anything that is available from another source and entirely
8	independent of the Team's review. The Team shall not use information,
9	records or data that it obtains or generates for purposes other than those
10	designated by Section 6962.
11	(b) The aggregate findings of the Team may be disclosed or published in
12	statistical form, but shall not identify or allow for the identification of any
13	person.
14	(c) All information obtained or generated by the Team regarding a case
15	review is confidential and exempt from public inspection and copying under
16	the Public Records Act, and shall not be released. Meetings of the Team are
17	confidential and shall be exempt from the Vermont Open Meeting Law, except
18	the Team shall hold an open meeting to publish its annual report.
