

1 TO THE HONORABLE SENATE:

2 The Committee on Institutions to which was referred House Bill No. 492
3 entitled “An act relating to capital construction and State bonding” respectfully
4 reports that it has considered the same and recommends that the Senate
5 propose to the House that the bill be amended by striking out all after the
6 enacting clause and inserting in lieu thereof the following:

7 * * * Capital Appropriations * * *

8 Sec. 1. LEGISLATIVE INTENT

9 (a) It is the intent of the General Assembly that of the \$157,207,752.00
10 authorized in this act, no more than \$80,068,449.00 shall be appropriated in the
11 first year of the biennium, and the remainder shall be appropriated in the
12 second year.

13 (b) It is the intent of the General Assembly that in the second year of the
14 biennium, any amendments to the appropriations or authorities granted in this
15 act shall take the form of a Capital Construction and State Bonding Adjustment
16 Act. It is the intent of the General Assembly that unless otherwise indicated,
17 all appropriations in this act are subject to capital budget adjustment.

Sec. 42. TRAINING CENTER; FINDINGS, PURPOSE, AND INTENT

(a) The General Assembly finds that the Robert H. Wood, Jr. Criminal Justice and Fire Service Training Center of Vermont (the Training Center) is an asset to the State because it provides multiple agencies with the space to train people who protect the lives of Vermonters. These agencies presently include the Vermont Criminal Justice Training Council, the Vermont Fire Service Training Council, the Department of Public Safety, the Department of Corrections, and the Department of Motor Vehicles.

20 requests for use of the Robert H. Wood, Jr. Criminal Justice and Fire Service
21 Training Center of Vermont made on and after the initial Committee meeting,

1 but shall permit any scheduled use of the Training Center made prior to that
2 date.

3 (c) The Training Center Governance Committee shall have access to any
4 contracts regarding the operations of the Training Center that are in existence
5 prior to the date of the initial Committee meeting.

7 On or before February 1, 2016, the Training Center Governance Committee

12 Sec. 46. STATE HOUSE SECURITY

13 (a) The Sergeant at Arms, in consultation with the Chair of the Capitol
14 Complex Working Group established in 2014 Acts and Resolves No. 178,
15 Sec. 26, is authorized to create a security and safety protocol for the State
16 House, conduct trainings for the State House and One Baldwin Street, and
17 install security cameras at the exterior entrances of the State House. The
18 Sergeant at Arms may retain consultant services to complete the work
19 described in this subsection. Any consultants retained pursuant to this
20 subsection shall be hired by the Joint Fiscal Office and shall work through the

1 Joint Fiscal Office under the direction of the Sergeant at Arms and the Chair of
2 the Working Group.

3 (b) The Sergeant at Arms is authorized to use funds appropriated in 2013
4 Acts and Resolves No. 51, Sec. 2(c)(17), as amended by 2014 Acts and
5 Resolves No. 178, Sec. 1 and Sec. 20(b) of this act, to directly conduct the
6 work described in subsection (a) of this section or retain consultant services
7 through the Joint Fiscal Office to conduct the work described in subsection (a)
8 of this section.

9 (c) Prior to the installation, the Sergeant at Arms, in consultation with the
10 Chair of the Working Group, shall establish a policy for the use of the security
11 cameras described in subsection (a) of this section. The policy shall include
12 requirements on limiting access rights to the camera and video feed, and
13 retaining video feed for a minimum of seven days and a maximum of 30 days.
