

1 TO THE HONORABLE SENATE:

2 The Committee on Natural Resources and Energy to which was referred  
3 House Bill No. 857 entitled “An act relating to timber harvesting” respectfully  
4 reports that it has considered the same and recommends that the Senate  
5 propose to the House that the bill be amended by striking out all after the  
6 enacting clause and inserting in lieu thereof the following:

7 \* \* \* General Policy and Enforcement Provisions \* \* \*

8 Sec. 1. 10 V.S.A. § 2600 is added to read:

9 § 2600. FINDINGS

10 The General Assembly finds that:

11 (1) Private and public forestlands:

12 (A) constitute unique and irreplaceable resources, benefits, and  
13 values of statewide importance;

14 (B) contribute to the protection and conservation of wildlife habitat,  
15 air, water, and soil resources of the State;

16 (C) mitigate the effects of climate change; and

17 (D) benefit the general health and welfare of the people of the State.

18 (2) The forest products industry, including maple sap collection:

19 (A) is a major contributor to and is valuable to the State’s economy  
20 by providing jobs to its citizens;

1           (B) is essential to the manufacture of forest products that are used  
2           and enjoyed by the people of the State; and

3           (C) benefits the general welfare of the people of the State.

4           (3) Private and public forestlands are critical for and contribute  
5           significantly to the State’s outdoor recreation and tourism economies.

6           (4) Forestry operations are adversely affected by the encroachment of  
7           urban, commercial, and residential land uses throughout the State that result in  
8           forest fragmentation and conversion and erode the health and sustainability of  
9           remaining forests.

10          (5) As a result of encroachment on forests, conflicts have arisen between  
11          traditional forestry land uses and urban, commercial, and residential land uses  
12          that threaten to convert forestland permanently to other uses, resulting in an  
13          adverse impact to the economy and natural environment of the State.

14          (6) The encouragement, development, improvement, and preservation of  
15          forestry operations will result in a general benefit to the health and welfare of  
16          the people of the State and the State’s economy.

17          (7) The forest products industry, in order to survive, likely will need to  
18          change, adopt new technologies, and diversify into new products.

19          (8) Forestry operations, including logging, transportation, and  
20          processing of on-site-derived forest products, may be subject to lawsuits based

1 on the theory of nuisance. Nuisance suits could encourage and result in the  
2 conversion of forestland and loss of the forest products industry.

3 Sec. 2. 10 V.S.A. § 2601 is amended to read:

4 § 2601. POLICY AND PURPOSES

5 (a) The conservation of the forests, timberlands, woodlands, and soil and  
6 recreational resources of the ~~state~~ State are hereby declared to be in the public  
7 interest. It is the policy of the ~~state~~ State to encourage economic management  
8 of its forests and woodlands, to sustain long-term forest health, integrity, and  
9 productivity, to maintain, conserve, and improve its soil resources, and to  
10 control forest pests to the end that forest benefits, including maple sugar  
11 production, are preserved for its people, floods and soil erosion are alleviated,  
12 hazards of forest fires are lessened, its natural beauty is preserved, its wildlife  
13 is protected, the development of its recreational interests is encouraged, the  
14 fertility and productivity of its soil are maintained, the impairment of its dams  
15 and reservoirs is prevented, its tax base is protected, and the health, safety, and  
16 general welfare of its people are sustained and promoted.

17 (b) The ~~department~~ Department shall implement the policies of this chapter  
18 by assisting ~~forest land~~ forestland owners and lumber operators in the cutting  
19 and marketing of forest growth, encouraging cooperation between forest  
20 owners, lumber operators, and the ~~state~~ State of Vermont in the practice of  
21 conservation and management of ~~forest lands~~ forestlands, managing,

1 promoting, and protecting the multiple use of publicly owned forest and park  
2 lands; planning, constructing, developing, operating, and maintaining the  
3 system of ~~state~~ State parks; determining the necessity of repairs and  
4 replacements to all ~~department-owned~~ Department-owned buildings and  
5 causing urgent repairs and replacements to be accomplished, with the approval  
6 of the ~~secretary of administration~~ Secretary of Administration, if within the  
7 limits of specific appropriations or if approved by the ~~emergency board~~  
8 Emergency Board; and providing advice and assistance to municipalities, other  
9 political subdivisions, ~~state~~ State departments and nongovernmental  
10 organizations in the development of wholesome and adequate community or  
11 institutional recreation programs.

12 (c) The Commissioner shall implement the policy established under this  
13 section when constructing the provisions of this chapter related to the  
14 management of forestlands and the construction of chapters 85 and 87 of  
15 this title.

17 § 2602. DEFINITIONS

18 As used in this chapter:

19 (1) “Agency” means the ~~agency of natural resources~~ Agency of Natural  
20 Resources as created by 3 V.S.A. chapter 51 of Title 3;

1           (2) “Department” means the ~~department of forests, parks and recreation~~  
2           Department of Forests, Parks and Recreation within the ~~agency of natural~~  
3           ~~resources;~~ Agency of Natural Resources.

4           (3) “Commissioner” means the ~~commissioner of the department of~~  
5           ~~forests, parks and recreation;~~ Commissioner of Forests, Parks and Recreation.

2 § 2608. ENFORCEMENT; PENALTIES; LIABILITY

3 (a) Enforcement of the provisions of this chapter or ~~any regulations or~~  
4 ~~proclamations promulgated~~ rules adopted hereunder shall be in accordance  
5 with ~~the provisions of 3 V.S.A. § 2822(e)~~ chapter 201 or 211 of this title.

6 (b) ~~A person who violates any provision of this chapter or regulations or~~  
7 ~~proclamations promulgated hereunder, or neglects or refuses to assist a fire~~  
8 ~~warden when called upon to do so as provided in section 2644 of this title,~~

14 § 2612a. HARVEST NOTIFICATION; PILOT PROGRAM

15 (a) Findings. The General Assembly finds that:

16 (1) The public will benefit from accountability of persons conducting  
17 timber harvests by providing a mechanism for the Department to distribute  
18 information and guidance to achieve compliance with existing laws and  
19 programs related to harvesting, including Use Value Appraisal eligibility  
20 requirements, and those that protect landowners, the environment, and the  
21 economy.

1           (2) Enforcement of compliance with the Acceptable Management  
2           Practices for Maintaining Water Quality on Logging Jobs in Vermont will be  
3           facilitated through notification and documentation of timber harvests.

4           (3) Owners of forestlands will benefit from proactive and timely  
5           delivery of guidance and resources that support successful forestry operations,  
6           including timber harvesting, provided by the Department, including the  
7           Vermont Voluntary Harvesting Guidelines.

8           (4) State knowledge of harvest locations will improve the understanding  
9           of factors affecting the forest economy, thereby informing opportunities to  
10          support it.

11          (b) Harvest notification; pilot. The Commissioner shall establish a harvest  
12          notification pilot program under which a landowner of property may notify the  
13          Commissioner prior to commencement of a timber harvest. The process  
14          established by the Commissioner shall allow for a harvest notification by  
15          electronic means, telephone, or paper submission.

16          (c) Requested information. The Commissioner shall designate the  
17          information to be submitted to the Department in a voluntary harvest  
18          notification. The requested information shall contain, at a minimum, the  
19          following information:

20               (1) the landowner's name; mailing address; physical address of  
21               residence; e-mail address, if any; and telephone number;

1           (2) the name of the logger or contractor conducting the harvest and his  
2           or her mailing address; address of the principal place of business or residence;  
3           e-mail address, if any; and telephone number;

4           (3) the name of the landowner's agent or consulting forester, if any, and  
5           his or her mailing address; address of the principal place of business or  
6           residence; e-mail address, if any; and telephone number;

7           (4) the location of the timber harvest, including the town and the nearest  
8           public town highway used to access the timber harvest;

9           (5) the school property account number (SPAN) of the parcel where the  
10          timber harvest will occur;

11          (6) the estimated date the timber harvest will commence and the  
12          estimated date the harvest will be completed;

13          (7) the estimate of the acreage of the timber harvest area; and

14          (8) whether the parcel where the timber harvest will occur is enrolled in  
15          the use value appraisal program.

16          (d) Harvest number; technical assistance. Upon receipt of a complete  
17          harvest notification, the Commissioner shall assign a unique harvest number to  
18          the timber harvest and shall provide the landowner with technical guidance or  
19          information, including: a sample timber sale contract; voluntary harvesting  
20          guidelines; guidance on compliance with maintaining water quality protection



1 during a timber harvest; and referral, where applicable, to appropriate natural  
2 resource professionals.

3 (e) Confidentiality. Information submitted by a landowner in a voluntary  
4 harvest notification under this section is confidential and exempt from public  
5 inspection under the Public Records Act.

6 Sec. 6. DEPARTMENT OF FORESTS, PARKS AND RECREATION;

7 HARVEST NOTIFICATION **UPDATE**

8 On or before February 1, 2018, the Commissioner of Forests, Parks and  
9 Recreation shall testify before or submit written testimony to the House  
10 Committees on Natural Resources and Energy and on Agriculture and Forest  
11 Products and the Senate Committee on Natural Resources and Energy  
12 regarding implementation of the Harvest Notification Pilot Program  
13 established under 10 V.S.A. § 2612a. The testimony shall:

14 (1) Summarize implementation of and participation in the Pilot Program,  
15 including the number of harvest notifications received.

16 (2) Summarize the technical assistance and information provided to  
17 landowners under the program.

18 (3) Summarize the effectiveness of the program in increasing  
19 compliance with the Acceptable Management Practices for Maintaining Water  
20 Quality on Logging Jobs in Vermont.

1           (4) Summarize whether the Pilot Program increased the amount or  
2           quality of information collected by the Department of Forests, Parks and  
3           Recreation regarding timber harvests in the State.

4           (5) Recommend whether harvest notification should be a voluntary or  
5           mandatory program.

6           Sec. 7. SUNSET; HARVEST NOTIFICATION PILOT PROGRAM

7           10 V.S.A. § 2612a (Harvest Notification Pilot Program) shall be repealed  
8           on February 15, 2020.

9           Sec. 8. 10 V.S.A. § 2613 is added to read:

10          § 2613. HARVEST NOTIFICATION; RULEMAKING; REQUIREMENT

11          (a) On or before July 1, 2018, the Commissioner of Forests, Parks and  
12          Recreation shall adopt rules requiring a landowner of property where timber is  
13          or will be harvested to notify the Department of Forests, Parks and Recreation  
14          of the harvest. The rules shall:

15               (1) specify the time period within which the landowner will be required  
16               to provide notice of the harvest;

17               (2) identify the method or means by which the landowner shall provide  
18               notice, provided that the rules shall allow for a harvest notification by  
19               electronic means, telephone, or paper submission;

20               (3) establish exemptions from the harvest notification requirement based  
21               on the size of the harvest or other criteria;

1           (4) identify the information to be submitted in a harvest notification,

2           provided that the rules shall require the following information:

3                   (A) the landowner's name; mailing address; physical address of  
4                   residence; e-mail address, if any; and telephone number;

5                   (B) the name of the logger or contractor conducting the harvest and  
6                   his or her mailing address; address of the principal place of business or  
7                   residence; e-mail address, if any; and telephone number.

8                   (C) the name of the landowner's agent or consulting forester, if any,

1           (5) specify whether a harvest identification number will be assigned to

11           Sec. **9**. 10 V.S.A. § 2606b is amended to read:

12           § 2606b. ~~LICENSE OF FOREST LANDS~~ FORESTLANDS FOR MAPLE  
13                           SUGAR PRODUCTION

14           (a) The ~~general assembly~~ General Assembly finds and declares that:

15                   (1) Maple sugaring is an important cultural tradition of Vermont life that  
16                   should be maintained and encouraged.

17                   (2) Maple sugaring is an important component of the agricultural and  
18                   forest products economy in Vermont and is increasingly necessary for farmers  
19                   that must diversify in order to continue to farm in Vermont.

20                   (3) Maple sugaring is a sustainable use of ~~forest land~~ forestland.

1           (4) State ~~forest land~~ forestland should be managed and used for multiple  
2 uses, including maple sugar production.

3           (b) It is hereby adopted as ~~state~~ State policy to permit limited use of  
4 designated ~~state-owned~~ State-owned land under the jurisdiction of the  
5 ~~department~~ Department for maple sugar production.

6           (c) ~~Beginning on July 1, 2009, pursuant~~ Pursuant to guidelines developed  
7 ~~jointly by the department of forests, parks and recreation and the Vermont~~  
8 ~~maple sugar makers' association~~ Department of Forests, Parks and Recreation,  
9 in consultation with the Vermont Maple Sugar Makers' Association, the  
10 ~~department shall~~ Department may issue licenses for the use of ~~state forest land~~  
11 State forestland for the tapping of maple trees, the collection of maple sap, and  
12 the transportation of such sap to a processing site located off ~~state forest land~~

14 ~~Vermont commercial grade syrup as those prices are set on May 1 of each~~

2       Sec. 10. DEPARTMENT OF FORESTS, PARKS AND RECREATION;  
3                   WORKING GROUP ON INTERGENERATIONAL TRANSFER OF  
4                   FORESTLAND

5           (a) On or before August 1, 2016, the Commissioner of Forests, Parks and  
6       Recreation shall establish a working group of interested parties to develop  
7       recommendations for a statewide program to improve the capacity of providing  
8       successional planning technical assistance to forestland owners in Vermont.

9       The working group shall:

10           (1) develop recommended priorities for succession planning for  
11       forestland owners;

12           (2) develop strategies for improving conservation investments or  
13       incentives that facilitate the intergenerational transfers of intact forestland;

14           (3) develop other strategies for lessening the impact of estate taxes or  
15       other pressures that could lead to the breaking up and subdivision of intact  
16       forest parcels;

17           (4) develop recommended legislative changes that may be needed to  
18       implement its recommendations and strategies; and

19           (5) identify fiscal issues related to its recommendations.

20       (b) On or before December 15, 2016, the Commissioner shall submit a

5 Sec. 11. 10 V.S.A. chapter 83, subchapter 4 is amended to read:

6 Subchapter 4. Forest Fires and Fire Prevention

7 § 2641. TOWN FOREST FIRE WARDENS; APPOINTMENT AND  
8 REMOVAL

9 (a) Upon approval by the ~~select-board~~ selectboard and acceptance by the  
10 appointee, the ~~commissioner~~ Commissioner shall appoint a town forest fire  
11 warden for a term of five years or until a successor is appointed. A town forest  
12 fire warden may be reappointed for successive five-year terms by the  
13 Commissioner or until a successor is approved by the selectboard and  
14 appointed by the Commissioner. The warden may be removed for cause at any  
15 time by the ~~commissioner~~ Commissioner with the approval of the ~~select-board~~  
16 selectboard. A warden shall comply with training requirements established by  
17 the ~~commissioner~~ by rule Commissioner.

18 (b) The ~~commissioner~~ Commissioner may appoint a forest fire warden for  
19 an unorganized town or gore, who shall ~~hold office until he or she resigns or is~~  
20 ~~removed for cause~~ serve for a term of five years or until a successor is  
21 appointed. An appointed forest fire warden for an unorganized town or gore

1 may be reappointed for successive five-year terms by the Commissioner until  
2 the Commissioner appoints and the unorganized town or gore approves a  
3 successor. The warden may be removed for cause at any time by the  
4 Commissioner with the approval of the unorganized town or gore. The forest  
5 fire warden of an unorganized town or gore shall have the same powers and  
6 duties as town forest fire wardens and shall be subject to the requirements of  
7 this subchapter.

8 (c) When there are woodlands within the limits of a city ~~or incorporated~~  
9 ~~village~~, the chief of the fire department of such city ~~or village~~ shall act as the  
10 ~~city or village forest~~ fire warden with all the powers and duties of town forest  
11 fire wardens.

12 (d) When the ~~commissioner~~ Commissioner deems it difficult in any  
13 municipality for one warden to take charge of protecting the entire  
14 municipality from forest fires, he or she may appoint one or more deputy forest  
15 fire wardens. Such wardens under the direction of the fire warden shall have  
16 the same powers, duties, and pay and make the same reports through the fire  
17 warden to the ~~commissioner~~ Commissioner as forest fire wardens.

18 (e) The ~~commissioner~~ Commissioner may appoint special forest fire  
19 wardens who shall hold office during the pleasure of the ~~commissioner~~  
20 Commissioner. Such fire wardens shall have the same powers and duties

5 (a) The salary of a town forest fire warden shall be determined by the  
6 selectboard members for time spent in the performance of the duties of his or  
7 her office, which shall be paid by the town. ~~He or she shall also receive from~~  
8 ~~the town the sum of \$0.15 for each fire permit issued.~~ In addition thereto, he  
9 or she shall receive from the ~~commissioner~~ \$20.00 Commissioner \$30.00  
10 annually for ~~properly making out and submitting reports of fires in his or her~~  
11 ~~district~~ fulfilling the requirements of section 2645 of this title and keeping the  
12 required ~~state~~ State records. He or she shall also receive from the

20 ~~employment of a person to assist him or her, on the approval of the~~  
21 ~~Commissioner, shall be paid by the State from the monies annually available~~

1 ~~from taxes in the unorganized town and gore, and the Commissioner of~~  
2 ~~Finance and Management shall issue his or her warrant therefor. [Repealed.]~~

3 (c) ~~A person employed by a warden to assist him or her in extinguishing a~~  
4 ~~forest fire as authorized under section 2644 of this title, shall be paid at the~~  
5 ~~same rate per hour as is paid for labor upon highways. A minimum of two~~  
6 ~~hours' pay for the first hour or any portion thereof shall be allowed persons~~  
7 ~~who are officially summoned to assist in the extinguishment of forest fires.~~  
8 ~~When a warden employs men or women in extinguishing a fire in a~~  
9 ~~municipality adjoining his or her own, the expense incurred shall be paid by~~  
10 ~~the municipality in which the work was done at the rate of pay prevailing in the~~  
11 ~~municipality where the laborers reside. A municipality wherein such warden~~  
12 ~~resides shall forthwith pay the warden and assistants for their services, and the~~  
13 ~~municipality may recover the expense thereof in a civil action on this statute~~

15 § 2643. TOWN'S LIABILITY FOR EXTINGUISHING SUPPRESSION OF  
16 FOREST FIRES; STATE AID

17 or qualified holder, the Commissioner may petition the Director to release the  
18 conservation and preservation rights and interests from any lien recorded  
19 pursuant to this chapter.

20 (l) Land acquired by the Agency of Natural Resources; the Department of  
21 Forests, Parks and Recreation; the Department of Fish and Wildlife; or the

1 Department of Environmental Conservation for public uses, as authorized by  
2 10 V.S.A. § 6301(a)(1)–(4), is exempt from the levy of a land use change tax  
3 under this section.

10 on State lands), 11–13 (fire wardens; fire suppression), 14 (forest integrity;
