1	TO THE HONORABLE SENATE:
2	The Committee on Appropriations to which was referred House Bill
3	No. 130 entitled "An act relating to the Agency of Public Safety" respectfully
4	reports that it has considered the same and recommends that the report of the
5	Committee on Government Operations be amended by striking out in their
6	entirety Secs. 7 (18 V.S.A. § 4247) and 8 (effective dates) and their related
7	reader assistance headings and inserting in lieu thereof the following:
8	* * * Animal Cruelty * * *
9	Sec. 7. 24 V.S.A. § 1943 is added to read:
10	§ 1943. ANIMAL CRUELTY INVESTIGATION ADVISORY BOARD
11	(a) An Animal Cruelty Investigation Advisory Board is created within the
12	Department of Public Safety to advise the Governor, the General Assembly,
13	and the Commissioner of Public Safety on issues involving the cooperation
14	and coordination of all agencies that exercise animal welfare responsibilities.
15	The Governor shall appoint the following to serve on the Board:
16	(1) the Commissioner of Public Safety or designee;
17	(2) the Executive Director of State's Attorneys and Sheriffs or designee
18	(3) the Secretary of Agriculture, Food and Markets or designee;
19	(4) the Commissioner of Fish and Wildlife or designee;
20	(5) two members to represent the interests of organizations dedicated to
21	promoting the welfare of animals;

1	(6) three members to represent the interests of law enforcement;
2	(7) a member to represent the interests of humane officers working with
3	companion animals;
4	(8) a member to represent the interests of humane officers working with
5	large animals (livestock);
6	(9) a member to represent the interests of dog breeders and associated
7	groups;
8	(10) a member to represent the interests of veterinarians;
9	(11) a member to represent the interests of the Criminal Justice Training
10	Council;
11	(12) a member to represent the interests of sportsmen and women; and
12	(13) a member to represent the interests of town health officers.
13	(b) The Board shall elect a chair and a vice chair which shall rotate among
14	the various member representatives. Each member shall serve a term of two
15	years. The Board shall meet at the call of the Chair. A quorum shall consist of
16	eight members, and decisions of the Board shall require the approval of a
17	majority of those members present and voting.
18	(c) The Board shall have the following duties:
19	(1) undertake an ongoing formal review process of animal cruelty
20	investigations and practices with a goal of developing a systematic,

1	collaborative approach to providing the best services to Vermont's animals,
2	given monies available;
3	(2) work with the Department of Public Safety to study the feasibility of
4	designating one law enforcement agency to receive, dispatch, and document
5	the outcome of animal cruelty complaints, and with the assistance of the
6	Vermont Sheriffs' Association, develop a uniform response protocol for
7	assigning complaints to the appropriate local law enforcement agencies;
8	(3) ensure that investigations of serious animal cruelty complaints are
9	systematic and documented, develop written standard operating procedures and
10	checklists to support the objective investigation of cruelty complaints that
11	include objective measures of both environmental and clinical evidence of
12	cruelty;
13	(4) ensure that requests for voluntary compliance are made in writing,
14	with clear requests and timelines, and include a timeline for the investigator to
15	perform a follow-up visit to confirm actions taken;
16	(5) develop a guide for animal cruelty prosecution, including a review of
17	current sentencing recommendations for State's Attorneys;
18	(6) research the feasibility of developing and implementing an animal
19	cruelty prevention and education program for offenders to be used as a part of
20	offenders' sentencing:

1	(7) explore potential private and public sources of funding for animal
2	cruelty investigations, including animal care expenses;
3	(8) develop trainings, protocols, procedures, and guidance documents
4	for agencies engaging in animal welfare responsibilities;
5	(9) develop an animal cruelty investigation certification program for
6	humane officers in accordance with 13 V.S.A. § 356, and provide a means by
7	which a person who has been actively engaged in this State as a humane
8	officer conducting animal cruelty investigations for at least five years
9	preceding July 1, 2016 shall be eligible for certification without completion of
10	the certification program requirements;
11	(10) develop recommendations for providing liability protection and
12	reducing uncompensated costs to animal shelters and animal welfare groups
13	that assist law enforcement authorities in animal cruelty investigations;
14	(11) explore changing the annual deadline for dog licensure under
15	20 V.S.A. § 3582 to align better with the time of year dogs require annual
16	veterinary care; and
17	(12) determine what should appropriately constitute an enforcement
18	action triggering the obligation of the Agency of Agriculture, Food and
19	Markets to assist law enforcement pursuant to 13 V.S.A. § 354(a).
20	(d) The Board shall meet no fewer than six times a year to undertake its
21	duties as outlined in subsection (a) of this section. The Board shall present its

1	findings and recommendations in brief summary to the House and Senate
2	Committees on Judiciary annually on or before January 15.
3	Sec. 8. 20 V.S.A. § 2365b is added to read:
4	§ 2365b. ANIMAL CRUELTY RESPONSE TRAINING
5	As part of basic training in order to become certified as a Level Two and
6	Level Three law enforcement officer, a person shall receive a two-hour
7	training module on animal cruelty investigations as approved by the Vermont
8	Criminal Justice Training Council and the Animal Cruelty Investigation
9	Advisory Board.
10	Sec. 9. 13 V.S.A. § 356 is added to read:
11	§ 356. HUMANE OFFICER REQUIRED TRAINING
12	All humane officers, as defined in subdivision 351(4) of this title, shall
13	complete a certification program on animal cruelty investigation training as
14	developed and approved by the Animal Cruelty Investigation Advisory Board.
15	Sec. 10. 13 V.S.A. § 354 is amended to read:
16	§ 354. ENFORCEMENT; POSSESSION OF ABUSED ANIMAL;
17	SEARCHES AND SEIZURES; FORFEITURE
18	(a) The Secretary of Agriculture, Food and Markets shall be consulted prior
19	to any enforcement action brought pursuant to this chapter which involves
20	livestock and poultry. Law enforcement may consult with the Secretary in
21	person or by electronic means, and the Secretary shall assist law enforcement

1	in determining whether the practice or animal condition, or both represent
2	acceptable livestock or poultry husbandry practices.

4	Sec. 11. DEPARTMENT OF CORRECTIONS; ANIMAL CARE PILOT
5	PROGRAM
6	The Commissioner of Corrections shall implement a pilot program in at
7	least one correctional facility that would permit qualified inmates to provide
8	temporary care, on-site, for animals on a weekly or more frequent basis. The
9	program shall be established on or before January 1, 2017, and the
10	Commissioner shall report on this program, with recommendations as to
11	whether it could be expanded to care for animals that have been seized or
12	relinquished in cruelty or neglect investigations, to the Joint Committee on
13	Justice Oversight on or before November 1, 2017.

15	Sec. 12. 29 V.S.A. § 842 is added to read:
16	§ 842. TRAINING SAFETY SUBCOMMITTEE; RECOMMENDATIONS;
17	GOVERNANCE COMMITTEE REPORT
18	(a) Subcommittee creation. There is created as a subcommittee of the
19	Training Center Governance Committee the Training Safety Subcommittee to
20	make recommendations regarding training safety at the Robert H. Wood, Jr.

1	Criminal Justice and Fire Service Training Center of Vermont (Training
2	<u>Center).</u>
3	(b) Subcommittee membership. The Subcommittee shall be composed of
4	seven members.
5	(1) Four of these members shall be members of the Training Center
6	Governance Committee, appointed by the Committee as follows:
7	(A) two shall represent the Vermont Police Academy; and
8	(B) two shall represent the Vermont Fire Academy.
9	(2) The remaining three members shall be as follows:
10	(A) the Commissioner of Labor or designee;
11	(B) the Risk Management Manager of the Office of Risk
12	Management within the Agency of Administration; and
13	(C) one employee of the Vermont League of Cities and Towns who
14	specializes in risk management, appointed by the Executive Director of the

1	(d) Governance Committee review and report.
2	(1) The Training Center Governance Committee shall review and
3	consider the recommendations made by the Subcommittee under subsection (c)
4	of this section.
5	(2) Annually, on or before January 15, the Governance Committee shall
6	report to the General Assembly regarding:
7	(A) any training safety issues it has discovered at the Training Center
8	and any steps it has taken to remedy those issues; and
9	(B) whether the Governance Committee has instituted any of the
10	Subcommittee's recommendations for training safety and if not, the reasons
11	therefor.
12	(3) The provisions of 2 V.S.A. § 20(d) (expiration of required reports)
13	shall not apply to the report required to be made under this subsection.

17	(a) The Chair of the Training Center Governance Committee shall call the

1	(b) The Training Center Governance Committee shall make its initial report
2	to the General Assembly described in 29 V.S.A. § 842(d) in Sec. 12 of this act
3	on or before January 15, 2018.

6	This act shall take effect on passage, except Secs. 6 (13 V.S.A. § 352a)
