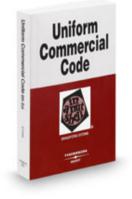
Office of Professional Regulation

Elections Applications Suite Implementation Update

In February 2014, the Elections Division initiated a complete implementation of an integrated elections software suite to ensure transparent and secure elections data for Vermont citizens. This software is critical to meeting state and federal election criteria.

The project is funded with 70% Help America to Vote Act (HAVA) (Federal) funds and 30% from the SOS special Fund.

The application systems included are:

- Vermont's voter registration checklist;
- Absentee ballot tracking;
- Election management;
- Campaign finance reporting (gone live in FY2014); and
- Lobbyist disclosure (gone live in FY2015)

Complete implementation on schedule for June 30, 2015.

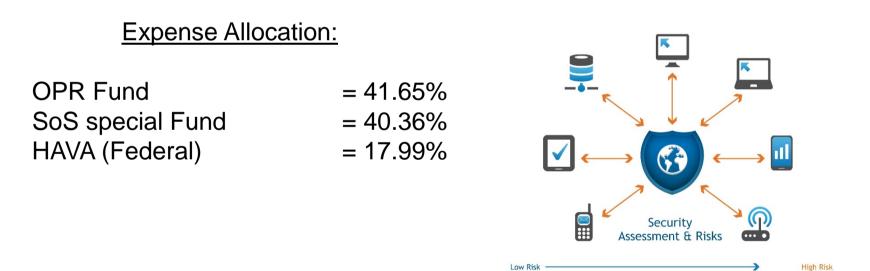

SoS IT Security Assessment

In FY15 the SOS initiated the first IT Security Assessment within Vermont State Government.

The cost of the assessment is \$392,584 (all payments to be made in FY15). The SoS was very pleased to select NuHarbor Consulting (Vermont-based) & Core Security Group (Boston) utilizing the State of Vermont standard bid process. The assessment will be finalized soon. We will review the recommendations and prioritize by risk level.



At the conclusion of the assessment, the office will have created, and will continue to improve upon security management competency.

SoS FY16 Key Budget Issues

- Elections IT Project: FY16 largest SoS Services Fund payment = \$382,000.
- **2)** Corporations IT Project initiated in FY13, largest payments through FY17. FY16 SoS Services Fund Payment = \$242,016.
- 3) IT Security Assessment Maintenance estimated @ 32,000.
- 4) Cost of living adjustments, step increases and 17.99% benefit increase.
- 5) APA Rulemaking the SoS is required to advertise all State agency rulemaking. These charges are offset by revenues (charged to the appropriate department), however, increase in advertising costs of \$43,743 from FY15.
- 6) BGS Print & Postal Middlesex Facility Renovation/Refit (Capital Bill Item for \$660,000) VSARA square footage to be reduced which equates to an \$18,000.00 savings for SoS in our FY16 Budget. We are carrying until BGS correctly moves the expense to their budget.



SoS FY16 Key Budget Issues Continued

8) OPR Assistant Director position - added to the FY16 Budget and

to Appropriation Bill.

The OPR Director currently has:

- 10 direct reports
- 32 employees total
- that are focused on:
 - *investigations;
 - *prosecutions;
 - *legal counsel;

*case management; and

*licensing administration for 46 professions and 60,000 licensees, including administrative support for 20 licensing boards.

9) OPR Business/Policy/Research Analyst (BA)- Convert PG 19 temporary to permanent in FY16 budget. Three more professions

will be added to OPR. The BA is currently providing business and data analysis, and para legal support. Additional duties include process mapping for streamlining, efficiencies, and system improvements.
