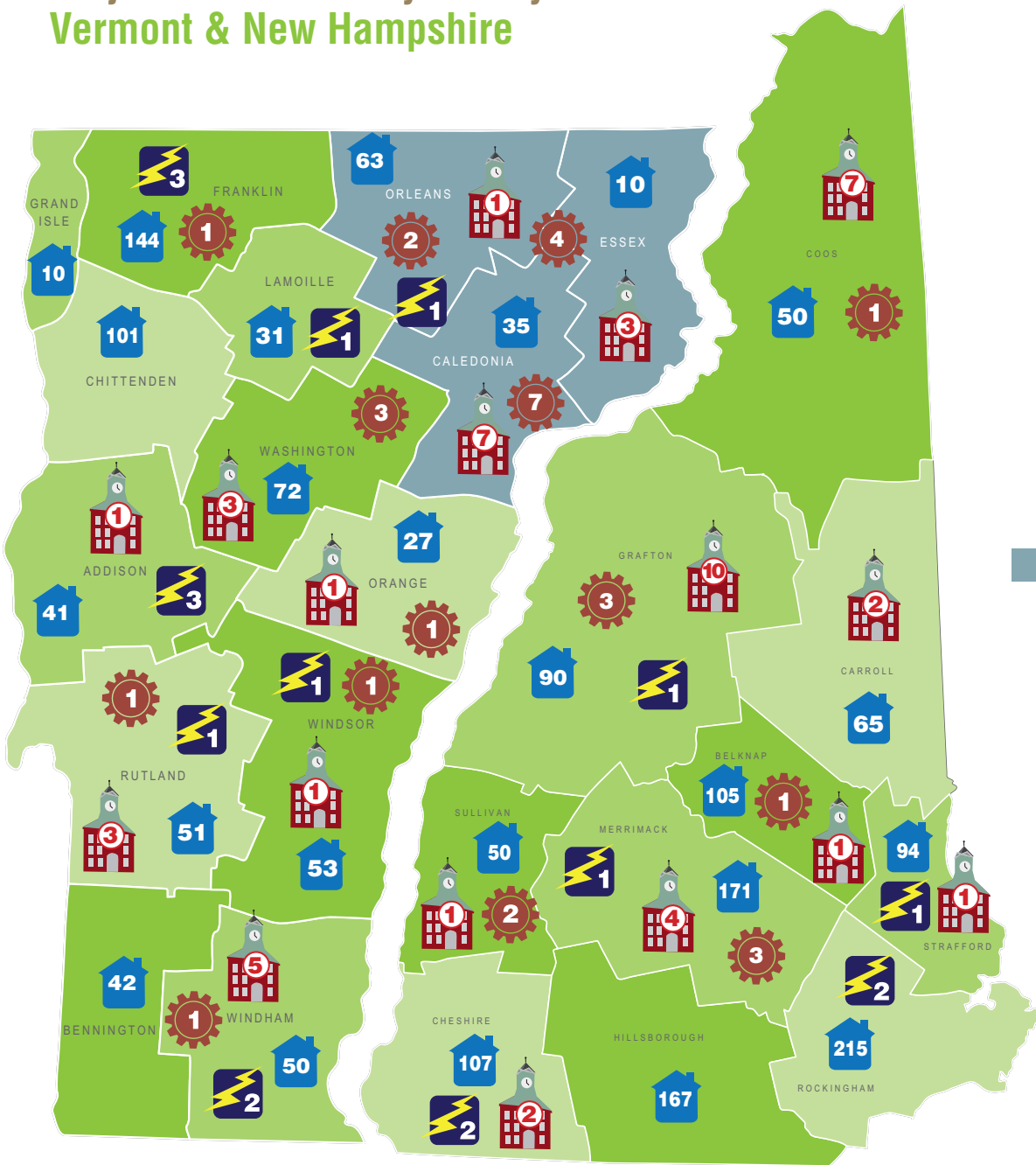

The Northeast Kingdom of Vermont is one of five Rural Economic Area Partnership Zones in the country. U.S. Sen. Patrick Leahy reauthorized the program in the 2014 Farm Bill, giving applicants in these counties access to set aside RD funding. In FY14, the designation brought the region an additional \$4,206,532.

**NOTE:** Multi-family rental properties receiving rental assistance were counted as one project. Each multi-family rental property represents multiple families receiving Rural Development assistance.

## INVESTING IN THE BIO-ECONOMY AT BURKE TOWN SCHOOL

As the leaves began to turn in late September, Burke Town School fired up its new high-efficiency wood pellet boiler that will keep 250 students, teachers, and staff warm through the winter months for years to come. The new boiler replaced an expensive and inefficient oil heating system the school used for decades.

A \$50,000 USDA Rural Development Community Facility Grant paid for a portion of the wood pellet boiler purchase and installation costs. This project will cut the school's heating bills while fostering energy independence from oil and supporting livable wage jobs in New England's wood pellet industry.

## INVESTING IN FOOD SYSTEMS IN VERMONT'S NORTHEAST KINGDOM

With the help of a USDA Rural Development Rural Business Enterprise Grant, Green Mountain Farm Direct is supporting Vermont agriculture and promoting healthy choices in Vermont's youth of the Northeast Kingdom.

During the months where schools are open a phone call to Green Mountain Farm Direct connects farmers with crop supplies in danger of becoming waste to schools in need of their abundant product. In the summer, Green Mountain Farm Direct connects Vermont farmers and children by operating a 'Lunchbox' truck that delivers good, healthy food from local farms to children who otherwise may not have access to lunch away from school.

## INVESTING IN COMMUNITY AND ECONOMIC DEVELOPMENT IN BERLIN, NEW HAMPSHIRE

In June, USDA Rural Development invested in a community economic development project that brought Tri-County Community Action Program, Public Service New Hampshire Energy Efficiency Services, New Hampshire Housing and Community Contact, Sherwin Williams, Caron Building Center, Rockingham Electric and Jim Lavirtue Carpentry together to improve an economically disadvantaged area of New Hampshire by bringing new life to an old home.

For Leon and Priscille Boucher of Berlin, New Hampshire, a \$7,500 USDA Rural Development home repair grant put a new roof on their family home of 47 years. It was also just the beginning of a flood of state, local business and volunteer efforts to install energy-saving insulation, update wiring, rehabilitate two dilapidated porches, put on a new coat of paint and plant a vegetable garden for these Berlin seniors.
