Sec. 9. 18 V.S.A. § 4353 is amended to read:

§ 4353. FEES

(a) The following fees shall be paid annually to the ~~board~~ Board at the time of making the application according to the following schedules:

(1) Restaurant I – Seating capacity of 0 to 25; ~~\$85.00~~ \$110.00

II — Seating capacity of 26 to 50; ~~\$145.00~~ \$200.00

III — Seating capacity of 51 to 100; ~~\$245.00~~ \$300.00

IV — Seating capacity of 101 to 200; ~~\$305.00~~ \$400.00

V — Seating capacity of over 200; ~~\$390.00~~ \$450.00

VI — Home Caterer; ~~\$95.00~~ \$155.00

VII — Commercial Caterer; ~~\$200.00~~ \$260.00

VIII — Limited Operations; ~~\$95.00~~ \$140.00

IX — Fair Stand; ~~\$70.00~~ \$125.00; if operating for four or more days per year; ~~\$160.00~~ \$230.00

(2) Lodging I — Lodging capacity of 1 to 10; ~~\$80.00~~ \$130.00

II — Lodging capacity of 11 to 20; ~~\$135.00~~ \$185.00

III — Lodging capacity of 21 to 50; ~~\$200.00~~ \$250.00

IV — Lodging capacity of ~~over 50~~ 51 to 200; ~~\$340.00~~ \$390.00

1 V — Lodging capacity of over 200; \$1,000.00

2 (3) Food processor - a fee for any person or persons that process food
3 for resale to restaurants, stores, or individuals according to the following
4 schedule:

5 (A) - Gross receipts of \$10,001.00 to \$50,000.00; ~~\$115.00~~ \$175.00

6 (B) - Gross receipts of over \$50,000.00; ~~\$155.00~~ \$275.00

7 (4) Seafood vending facility – ~~\$125.00~~ \$200.00, unless operating
8 pursuant to another license issued by the ~~department of health~~ Department of
9 Health and generating less than \$40,000.00 in seafood gross receipts annually.
10 If generating more than \$40,000.00 in seafood gross receipts annually, the fee
11 is to be paid regardless of whether the facility is operating pursuant to another
12 license issued by the ~~department of health~~ Department of Health.

13 (5) Shellfish reshippers and repackers – ~~\$285.00~~ \$375.00.

14 (b) The ~~commissioner of the department of health~~ Commissioner of Health
15 will be the final authority on definition of categories contained herein.

19 (a) A person owning or conducting a bakery as specified in sections 4441
20 and 4444 of this title shall pay to the ~~board~~ Board a fee for each certificate and
21 renewal thereof in accordance with the following schedule:

- 1 Bakery I – Home Bakery; ~~\$55.00~~ \$100.00
- 2 II – Small Commercial; ~~\$125.00~~ \$200.00
- 3 III – Large Commercial; ~~\$250.00~~ \$350.00
- 4 IV – Camps; ~~\$90.00~~ \$150.00

5 (b) The ~~commissioner of the department of health~~ Commissioner of Health
6 will be the final authority on definition of categories contained herein.
