REPORT ON THE RECOMMENDED IMPLEMENTATION OF H.765

An Act Relating to Establishing New Levels of Law Enforcement Officer Certification

Sec. 8. VERMONT CRIMINAL JUSTICE TRAINING COUNCIL; RECOMMENDED TRANSITION BETWEEN DIFFERENT LEVELS OF LAW ENFORCEMENT OFFICER CERTIFICATION

On or before January 15, 2015, the Vermont Criminal Justice Training Council shall submit to the House and Senate Committees on Government Operations:

(1) the Council's recommendation regarding the manner in which a law enforcement officer should be able to transition to a different level of law enforcement officer certification, once the officer has obtained one of the levels of certification described in Sec. 5 of this act, 20 V.S.A. § 2358 (minimum training standards; definitions); and

(2) after consulting with the Vermont Police Association, Inc., the Chiefs of Police Association of Vermont, the Vermont Constables Association, the Vermont Sheriffs' Association, Inc., and a representative from the Department of Public Safety, any Council recommendation regarding whether there should be any changes to the scope of practice for any of the levels of law enforcement officer certification described in Sec. 5 of this act, 20 V.S.A. § 2358.

Summary

H.765 can be considered as the most significant change to Vermont law enforcement in decades. Based on the concerns of the legislature as well as law enforcement executives, H.765 was passed into law and changes the certification levels of law enforcement officers. As the result of numerous meetings with law enforcement executives and other stake holders since the passage of H.765, the following additional recommendations are made:

As passed, H.765 provides for the elimination of full time and part time certified officers to be replaced by Level I, Level II and Level III certification. It provides for a specific scope of authority for Level I and Level II officers.

- 1. **Recommendation # 1**: The VCJTC recommends an expanded scope of authority for Level II to include additional laws that were determined should be included in Level II.
- Recommendation # 2: The VCJTC recommends that through the rule making process, a Level IIC be created. This level is for those current part time certified officers meeting a rigid minimum standard and would be grant an expanded scope of authority. This expanded scope of authority is still limited compared to the scope of authority of a Level III certified officer and will not be granted to any Level II certified officers beyond July 1, 2015.
- 3. **Recommendation # 3**: The VCJTC may through the waiver process, grant a specific Level III authority to a Level I or Level II officer based on a rigid set of criteria.
- 4. **Recommendation # 4**: The VCJTC recommends that any transition from a Level II to Level III require at a minimum, a full time academy, either in Vermont or other state that meets the minimum Vermont standards. There is currently a waiver process in place and there is no reason to change the policy.

Recommendation # 1: The VCJTC recommends an expanded scope of authority for Level II to include additional laws that were determined should be included in Level II.

A primary concern when discussing the Level II scope of authority is that after July 1, 2015, this scope of practice will be the maximum that can be obtained. The Level II as expanded will better meet the future needs of law enforcement executives.

The statures in bold and underlined are the added laws and investigative authority.

This level is for those current part time certified officers meeting a rigid minimum standard and would grant an expanded scope of authority. This expanded scope of authority is still limited compared to the scope of authority of a Level III certified officer and will not be granted to any Level II certified officers beyond July 1, 2015.

The original intent of H.765 was to provide safeguards for part time certified officers. The grandfathering clause was removed and as such, the implementation of a Level IIC rewards those officers that meet a rigid standard and have significant experience as a part time certified officer.

The minimum standards for award of Level IIC is as follows:

- 1. On July 1, 2015, the part time certified officer has a minimum of three years' experience
- 2. The officer has a worked a minimum of 3000 hours between 3 and 5 years
- 3. Duties performed primarily consisted of investigation and enforcement of motor vehicle, criminal, juvenile and drug offenses
- 4. The Chief's or Sheriff's endorsement.

The scope of authority includes all Level II and the following.

Recommendation # 3: The VCJTC may through the waiver process, grant a specific Level III authority to a Level II officer based on a rigid set of criteria.

Upon application of a Chief or Sheriff, the Waiver Committee may grant any single Level III offense to a Level II or Level IIC law enforcement officer based on the following:

- 1. The officer has a defined and documented expertise in a particular skill.
- 2. A clearly defined departmental need for the waiver to enable assignment to a specialized duty position

Recommendation # 4: The VCJTC recommends that any transition from a Level II to Level III require at a minimum, a full time academy, either in Vermont or other state that meets the minimum Vermont standards. There is currently a waiver process in place and there is no reason to change the policy.

This subject was discussed at length and the final recommendation is that the Level III certification requires a full academy either in Vermont or as now, a waiver based on full time certification from another state. A consideration given for the Special Certification, Recommendation # 3 is that the needs of a law enforcement executive can be met by a Level II with special skills. There is no need for a transition without full academy training.
