# General Assistance (GA) is an emergency financial assistance program for individuals needing help with basic needs.

#### Assistance may include:

- Emergency housing
- Personal needs income
- Rental subsidy
- Medical, Dental, or Prescriptions
- Burials

### Basic Emergency Housing Eligibility Criteria

In order to receive benefits, clients must be found eligible under one of three categories:

- 1) Vulnerable, for a benefit up to 28 days within a 12 month period
- 2) Catastrophic, for a benefit up to 84 days within a 12 month period
- Cold Weather Exception (CWE)

# Vulnerable Eligibility

#### Must meet one of the following criteria:

- 1. A family with a child under the age of 6
- 2. Individual in receipt of SSI or SSDI benefits
- 3. A woman in her third trimester of pregnancy
- 4. Is age 65 or older

# Catastrophic Eligibility

Housing criteria when an applicant is homeless because of:

- Natural disaster
- Constructive eviction due to landlord's failure to provide a habitable unit
- Court ordered eviction over which the applicant had no control
- Death of spouse or minor child
- Domestic violence

# Cold Weather Exception (CWE)

Eligibility for temporary housing will be relaxed in a district when any of the following conditions exist, or are anticipated to exist, within the hours of 6 p.m. – 6 a.m.

- 1. Temperatures or Wind Chill are less than 20 degrees (F); or
- 2. Temperatures are less than 32 degrees (F) with a higher than 50% chance of precipitation reported.

#### Eligibility for Medical/Dental Services

Experienced an emergency need and no available resources and;

- Is without prescriptions and did not lose health insurance due to noncompliance
- Has an emergency dental when the applicant has pain, infection, or bleeding
- Needs durable medical equipment when screened and deemed eligible by DVHA

# Personal Needs Income (PNI)

- PNI benefits are meant to assist with basic life essentials.
- To be eligible you must past an income test, be unable to work due to medical or other employment barriers, or be age 65 or older.
- The program can pay up to \$232.00 for rent inside Chittenden County, up to \$198.00 for rent outside of Chittenden County which is paid directly to the landlord.
- In addition to rental assistance, it can pay current utility/fuel bills along with Personal Need Income (PNI) which averages \$2.00 per day in cash assistance issued to an EBT card.

#### **GA** Burials

The application for burial assistance is completed by the funeral home that made/is making the burial arrangements for the deceased.

- The maximum payment is **\$1,100.00** and has been established by DCF to cover the basic final disposition of human remains.
- If available resources of the deceased and the surviving spouse equal or exceed the maximum payment (\$1,100.00), the department will not pay any burial expenses.
- Eligibility criteria: The deceased must be a Vermont resident or has died in Vermont and no funds/resources available to them at the time of their death that would allow their spouse and/or family to pay for the burial expenses.

### Vermont Rental Subsidy

- The VRSP provides tenant-based rental assistance patterned after the federal Section 8 Housing Choice Voucher Program.
- The program has a designated priority with the VT State Housing Authority Section 8 program.
- Is designed to function as a bridge to federal rental assistance.
- To be eligible, a household must be homeless and receiving Reach-Up or SSI, or be under 125% of Federal poverty level.

After hours, individuals contact Vermont 2-1-1 but must appear in person at a District Office on the following day business day.
