14	12		The Prop of Further Amendment concurs in the House Prop to add a section with legislative intent language about codifying the Vermont Supreme Court's decision in <i>State v. Hurley</i> . This case was decided after the Senate Transportation Committee voted out the bill. In its decision, the Court found that the law prohibiting hanging objects in front of a windshield only prohibits the hanging objects that materially obstruct the driver's view.
15	13	13	The Prop of Further Amendment concurs in the House Prop to amend the law governing obstructions to windshields and side windows to: i. codify the <i>Hurley</i> decision; and

			ii. add language specifying the allowed location of EZ Passes on motor vehicle windshields.

25	25	-	The Prop of Further Amendment concurs in the House proposal to add a new section that increases the authorized width of ATVs from 60 inches to 64 inches. DMV and the Agency of Natural Resources do not object to this increase.
26	26	27	No difference between Senate as Passed and House Prop of Amendment (authorizing proof of electronic ATV registration for a 10- day period and eliminates of ATV registration reciprocity requirement).
27	27	28	No substantive difference between Senate as Passed and House Prop of Amendment (increasing from 90 days to 12 months the perio that a military commercial motor vehicle driver may be separated from military employment and still be eligible for an exemption from the CDL road test).

Under the pilot program, the Commissioner of DMV may authorize pilot program participants to operate Type II school buses retrofitted with an auxiliary fuel tank to enable the use of biodiesel, waste vegetable oil, or straight vegetable oil.
