# **Called to Order**

The Senate was called to order by the President.

#### **Senate Resolution Adopted**

Senate resolution of the following title was offered, read and adopted, and is as follows:

By the Committee on Rules,

**S.R. 4.** Senate resolution reaffirming support for the Joint Fiscal Office and the nonpartisan nature of its work.

*Whereas*, the Joint Fiscal Office has provided trusted, nonpartisan analysis of fiscal issues to all members of the General Assembly for decades, and

*Whereas*, the Joint Fiscal Office conducts its analysis on the same independent and neutral basis for the newest member of the minority party as it would for the most senior member of the majority party, and

*Whereas*, in recent weeks the nonpartisan nature of the Joint Fiscal Office has been called into question by an individual in the Executive Branch, and

*Whereas*, Vermont's political culture has until now resisted attempts to undermine public confidence in nonpartisan staff in the manner seen in Washington, D.C., *now therefore be it* 

#### Resolved by the Senate:

That the Vermont Senate affirms its continued support for the Joint Fiscal Office in the face of attempts to malign its integrity and reaffirms that the Joint Fiscal Office's work is free from political interference or partisan bias, *and be it further* 

**Resolved:** That the Secretary of the Senate be directed to send a copy of this resolution to Stephen Klein, Chief Fiscal Officer of the Joint Fiscal Office, and to Governor Philip B. Scott.

#### House Proposal of Amendment Concurred In

**S.** 1.

House proposal of amendment to Senate bill entitled:

An act relating to co-payment limits for chiropractic care and physical therapy.

Was taken up.

The House proposes to the Senate to amend the bill as follows:

<u>First</u>: In Sec. 2, 8 V.S.A. § 4088a, in subdivision (a)(4), following "<u>under</u> the plan," by striking out "<u>, up to a maximum of 50 percent of the total</u> reimbursement amount to the chiropractic physician for providing the <u>services</u>"

Second: In Sec. 3, 8 V.S.A. § 4088k, following "<u>under the plan</u>," by striking out "<u>, up to a maximum of 50 percent of the total reimbursement</u> amount to the physical therapist for providing the services"

<u>Third</u>: In Sec. 5, health insurance coverage for non-opioid approaches to treating and managing pain; report, in subdivision (b)(3), following "<u>total</u> <u>charge</u>", by inserting "<u>or reimbursement</u>"

Thereupon, the question, Shall the Senate concur in the House proposals of amendment?, was decided in the affirmative.

Sec. H.11a 32 V.S.A. § 5402(a)(1) is amended to read:

(1) The tax rate for nonresidential property shall be \$1.59 per \$100.00 the same as in the prior fiscal year, unless set otherwise by the General Assembly.
