6	Statement of purpose of bill as introduced: This bill authorizes the towns of
7	Montgomery, Westfield, and Lowell to prohibit commercial vehicle operation
8	on the Hazen's Notch segment of Route 58 and prescribes penalties for a

10 11	An act relating to commercial vehicle operation on the Hazen's Notch segment of Vermont Route 58
12	It is hereby enacted by the General Assembly of the State of Vermont:
13	Sec. 1. 23 V.S.A. § 1006b is amended to read:
14	§ 1006b. SMUGGLERS' NOTCH; WINTER CLOSURE OF VERMONT
15	ROUTE 108; <u>HAZEN'S NOTCH</u> ; COMMERCIAL VEHICLE
16	OPERATION PROHIBITED
17	(a) The Agency of Transportation may close the Smugglers' Notch
18	segment of Vermont Route 108 during periods of winter weather.
19	(b)(1) As used in this subsection;

1	(A) "commercial Commercial vehicle" means
2	truck-tractor-semitrailer combinations and truck-tractor-trailer combination.
3	(B) "Hazen's Notch segment of Route 58" means the segment of
4	Route 58 (Hazen's Notch Rd.) starting in the town of Montgomery
5	approximately 3.89 miles east of the intersection of Vermont Route 118 and
6	Route 58 and extending easterly to the border between the towns of Westfield
7	and Lowell.
8	(2) Commercial vehicles are prohibited from operating on the
9	Smugglers' Notch segment of Vermont Route 108.
10	(3) The legislative bodies of the municipalities of Montgomery,
11	Westfield, and Lowell may adopt a regulation to prohibit commercial vehicles
12	from operating on the Hazen's Notch segment of Route 58.
13	(3)(4) Either the operator of a commercial vehicle who violates this
14	subsection or a municipal regulation adopted pursuant to this subsection, or the
15	operator's employer, shall be subject to a civil penalty of \$1,000.00. If the
16	violation results in substantially impeding the flow of traffic on Vermont Route
17	108 or on Route 58, the penalty shall be \$2,000.00. For a second or
18	subsequent conviction within a three-year period, the penalty shall be doubled.
19	(c) The Agency in the case of Vermont Route 108, and any town of
20	jurisdiction that exercises authority under this section in the case of Route 58,

- shall erect signs conforming to the standards established by section 1025 of
- 2 this title to indicate the closures and restrictions authorized under this section.
