| 13 | It is hereby enacted by the General Assembly of the State of Vermont:         |
| 14 | Sec. 1. 30 V.S.A. § 218a is amended to read:                                  |
| 15 | § 218a. PERMANENT TELECOMMUNICATIONS RELAY SERVICE;                           |
| 16 | COMMUNICATION FACILITATOR PROGRAM   |
| 17 | (a) The Department of Public Service shall develop the necessary standards    |
| 18 | for the establishment of a permanent, statewide telecommunications relay      |
| 19 | service and for an associated equipment program. The standards developed by   |

| 1  | the Department shall be equal to or exceed those standards mandated by the      |

| 2  | Americans With Disabilities Act of 1990 (Public Law 101-336, 104 Stat. 327      |
| 3  | (1990)) and expressly require that the designated provider of Vermont's         |
| 4  | telecommunications relay services comply, as expeditiously as possible, with    |
| 5  | any additional rederal regulations which may be promulgated by the Federal      |
| 6  | Communications Commission in accordance with the provisions of this             |
| 7  | section.  |
| 8  | (b) The Department of Rublic Service shall issue a request for proposal         |
| 9  | seeking competitive bids from qualified vendors to provide                      |
| 10 | telecommunications relay services and competitive bids from qualified           |
| 11 | vendors to provide telecommunications equipment in accordance with the          |
| 12 | provisions of this section, including the standards developed under subsection  |
| 13 | (a) of this section. The term of any contract shall not exceed four years.      |
| 14 | (c) The Department of Public Service may contract with the qualified            |
| 15 | bidder offering the most favorable proposal, giving due consideration to costs, |
| 16 | to quality of service, and to the interests of the community of people who are  |
| 17 | deaf, hard of hearing, or have speech limitations.                              |
| 18 | (d) The Department of Public Service shall establish a Vermont                  |
| 19 | Telecommunications Relay Service Advisory Council composed of the               |
| 20 | following members: one representative of the Department of Public Service-      |

| 20 | (e) The Department shall propose and the Board shall establish by rule or         |
| 21 | order a relecommunications equipment grant program to assist persons who are      |

| 6  | whose modified adjusted gross income as defined in 32 V.S.A. § 5829(b)(1)          |

| 9  | family of six or the actual number in the family, whichever is greater,            |

(f) The Department in consultation with the Agency of Human Services 1 shall propose and the Board shall establish by rule a communication facilitator 2 3 program to enable individuals who are deaf-blind to access videophones and 4 video relay services. 5 (g) The costs of the State's elecommunications relay service and any equipment benefit under subsection (e) of this section, as well as the costs of 6 7 the communication facilitator program established under subsection (f) of this 8 section, shall be included as part of the Vermont Universal Service Fund 9 Program. 10 Sec. 2. EFFECTIVE DATE 11 This act shall take effect on passage.

Sec. 1. 30 V.S.A. § 218a(d) is amended to read:

(d) The Department of Public Service shall establish the Vermont Telecommunications Relay Service Advisory Council composed of the following members: one representative of the Department of Public Service, who shall act as chair and who shall be designated by the Commissioner of Public Service; one representative of the Department of Disabilities, Aging, and Independent Living, who shall act as vice chair; two representatives of the deaf community; one member of the community of people who are hard of hearing or have a speech limitation; one representative of a company providing local exchange service within the State; and one representative of an organization currently providing telecommunications relay services. <u>The</u> <u>Council shall elect from among its members a chair and vice chair. Meetings</u> <u>shall be convened at the call of the Chair or a majority of the members of the</u> <u>Council. The Council shall meet not more than six times a year.</u> The members of the Council who are not officers or employees of the State shall receive per diem compensation and expense reimbursement in amounts authorized by 32 V.S.A. § 1010(b). The costs of <del>such</del> <u>the</u> compensation and reimbursement<sub>7</sub> and any other necessary administrative costs shall be included within the contract entered into under subsection (c) of this section. The Council shall advise the Department of Public Service and the contractor for telecommunications relay services on all matters concerning the implementation and administration of the State's telecommunications relay service.

## Sec. 2. COMMUNICATION FACILITATOR PROGRAM; STUDY

The Commissioner of Public Service, in consultation with the Commissioner of Disabilities, Aging, and Independent Living, shall make findings and recommendations regarding the establishment a communication facilitator program in Vermont that would enable members of the DeafBlind community to make telephone calls. The Commissioner shall solicit input from representatives or members of the DeafBlind community in Vermont and shall take into consideration similar programs offered in other jurisdictions. The Commissioner's findings shall include the administrative and implementation costs of the program; the number of individuals in the DeafBlind community in Vermont; expected participation in the program; and an assessment of whether there are grant opportunities to help defray program costs. The Commissioner's recommendations shall include a funding source for the program. The Commissioner shall report his or her findings and recommendations on or before December 15, 2018 to the House Committees on Energy and Technology and on Human Services and the Senate Committees on Finance and on Health and Welfare.

Sec. 3. EFFECTIVE DATE

This act shall take effect on passage.
