Subject: Taxation and finance; assessment and collection of taxes; assessment  
and collection in unified towns and gores of Essex County

Statement of purpose of bill as introduced: This bill proposes to:

(1) allow the unified towns and gores of Essex County to call a meeting  
on the second Saturday in September to present the proposed budget and tax  
rate;

(2) allow the Board of Governors of the unified towns and gores of  
Essex County to appoint appraisers from Essex County who are not residents  
of the gores; and

(3) repeal sections of Title 32 relating to the daily salary of appraisers  
and supervisors in unorganized towns and gores and appraisers in the unified  
towns and gores of Essex County.

An act relating to the annual town meeting of the unified towns and gores of  
Essex County and to the appraisers and supervisors of all unorganized  
towns and gores

1 It is hereby enacted by the General Assembly of the State of Vermont:

2 Sec. 1. 24 V.S.A. § 1351b is amended to read:

3 § 1351b. FUNCTIONS AND DUTIES OF BOARD OF GOVERNORS

4 (a) The Board of Governors shall hire, direct, or fire one or more  
5 supervisors for the gores who shall reside in Essex County; and who shall not  
6 be a current ~~member~~ members of the Board of Governors. The Board of  
7 Governors shall oversee the supervisor or supervisors in the execution of the  
8 Supervisor's functions and duties.

9 (b) The Board of Governors shall appoint the appraisers. Each of the  
10 appraisers shall be a resident of ~~the gores~~ Essex County.

12 Sec. 2. 32 V.S.A. § 4981 is amended to read:

13 § 4981. ASSESSMENT OF TAX

14 (a) A tax determined pursuant to this section is hereby annually assessed  
15 upon the grand list of the unified towns and gores in Essex County.

16 (b) Annually, the Board of Governors of the unified towns and gores in  
17 Essex County shall prepare a proposed municipal services budget and establish  
18 a proposed tax rate for the unified towns and gores in Essex County for the  
19 ensuing year. Annually, on the second Saturday in ~~August~~ September, the  
20 Board of Governors shall call a meeting of the residents and property owners

1 of the unified towns and gores in Essex County for the purpose of presenting  
2 the proposed budget and tax rate based upon the current grand list.

3 (c) Notice of the meeting and a copy of the proposed budget shall be sent  
4 by first class mail to all residents and property owners of the unified towns and  
5 gores at their last known address at least 30 days before the meeting. The  
6 meeting shall be held in Essex County. The notice shall include the itemized  
7 proposed budget and the proposed tax rate.

8 (d) Annually, on or before September 30, the Board of Governors shall  
9 adopt a budget and tax rate, and notify the residents and property owners of the  
10 unified towns and gores, the Supervisor, and the appraisers.

11 Sec. 3. 32 V.S.A. § 4984 is amended to read:

12 § 4984. COUNTY TAX TRANSMITTED TO SUPERVISOR

13 When a county tax is assessed in Essex County, the County Treasurer shall  
14 transmit to the Supervisor for the unified towns and gores within Essex County  
15 a certified statement of the amount of such tax based on the grand list of such  
16 unified towns and gores as shown by the list filed annually under the  
17 provisions of section ~~4303~~ 4301 of this title. The Supervisor shall thereupon  
18 issue his or her warrant in favor of Essex County for the amount of such tax  
19 out of the funds received by him or her from the tax levied under the  
20 provisions of section 4981 of this title.
