13	§ 3362. AUTHORITY TO TRANSACT VARIOUS KINDS OF
14	INSURANCE BUSINESS
15	The provisions of 11 V.S.A. § 762 shall not prevent a foreign or alien
16	insurer from transacting A foreign or alien insurer may transact more than one
17	kind of insurance business, provided the charter of such corporation authorizes
18	it to transact such different kinds of insurance business and its capital is
19	sufficient to provide the required capital for each kind of business to be
20	transacted.

2	Sec. 2. 8 V.S.A. § 3461 is amended to read:
3	§ 3461. DEFINITIONS
4	The following definitions, unless otherwise specified or qualified shall be
5	applicable to As used in this chapter:
6	(1) "Admitted assets" means assets permitted to be reported as admitted
7	assets on the annual statutory financial statement of the insurer for the next
8	preceding year or as shown by a current financial statement.
9	(2) "Appraised" or "appraised value" when used in connection with real
10	estate shall refer to appraisals made or examined and approved by an insurer or
11	its agents. An insurer shall have the right to make one or more renewals or
12	extensions of a loan secured by real estate, provided any renewal or extension
13	is based upon a reexamination of the facts and upon an appraisal made within
14	three years.
15	(3) "Asset-backed security" means a security or other instrument,
16	excluding a mutual fund, evidencing an interest in, or the right to receive
17	payments from, or payable from distributions on, an admitted asset, a pool of
18	admitted assets, or specifically divisible cash flows which are legally
19	transferred to a trust or another special purpose bankruptcy-remote business
20	entity, on the following conditions:

1	(A) The trust or other business entity is established solely for the
2	purpose of acquiring specific types of admitted assets or rights to cash flows,
3	issuing securities and other instruments representing an interest in or right to
4	receive cash flows from those admitted assets or rights, and engaging in
5	activities required to service the admitted assets or rights and any credit
6	enhancement or support features held by the trust or other business entity.
7	(B) The admitted assets of the trust or other business entity consist
8	solely of interest-bearing obligations or other contractual obligations
9	representing the right to receive payment from the cash flows from the
10	admitted assets or rights. However, the existence of credit enhancements, such
11	as letters of credit or guarantees, or support features such as swap agreements,
12	shall not cause a security or other instrument to be ineligible as an asset-backed
13	security.
14	(4) "Canada" means Canada, any province of Canada, or any political
15	subdivision of Canada.
16	(5) "Cap" means an agreement obligating the seller to make payments to
17	the buyer, with each payment based on the amount by which a reference price
18	or level or the performance or value of one or more underlying interests
19	exceeds a predetermined number, sometimes called the strike rate or strike
20	price.

1	(6) "Class one bond mutual fund" means a mutual fund that at all times
2	qualifies for investment using applicable SVO standards.
3	(7) "Class one money market mutual fund" means a money market
4	mutual fund that at all times qualifies for investment using applicable SVO
5	standards.
6	(8) "Collar" means an agreement to receive payments as the buyer of an
7	option, cap, or floor and to make payments as the seller of a different option,
8	cap, or floor.
9	(9)(7) "Counterparty exposure amount" means:
10	(A) The net amount of credit risk attributable to a derivative
11	instrument entered into with a business entity other than through a qualified
12	exchange, or qualified foreign exchange or cleared through a qualified
13	clearinghouse. Such derivative instruments are hereinafter referred to as
14	"over-the-counter derivative instruments." The amount of credit risk equals:
15	(i) the market value of the over-the-counter derivative instrument
16	if the liquidation of the derivative instrument would result in a final cash
17	payment to the insurer; or
18	(ii) zero, if the liquidation of the derivative instrument would not
19	result in a final cash payment to the insurer.
20	(B) If over-the-counter derivative instruments are entered into under
21	a written master agreement which that provides for netting of payments owed

1	by the respective parties, and the domiciliary jurisdiction of the counterparty is
2	either within the United States or, if not within the United States, within a
3	foreign jurisdiction listed in the Purposes and Procedures of the Securities
4	Valuation Office NAIC Investment Analysis Office as eligible for netting, the
5	net amount of credit risk shall be the greater of zero or the net sum of:
6	(i) the market value of the over-the-counter derivative instruments
7	entered into under the agreement, the liquidation of which would result in a
8	final cash payment to the insurer; and
9	(ii) the market value of the over-the-counter derivative
10	instruments entered into under the agreement, the liquidation of which would
11	result in a final cash payment by the insurer to the business entity.
12	(C) For open transactions, market value shall be determined at the
13	end of the most recent quarter of the insurer's fiscal year, and shall be reduced
14	by the market value of acceptable collateral held by the insurer or placed in
15	escrow by one or both parties.
16	(10)(8) "Covered" means that an insurer owns or can immediately
17	acquire, through the exercise of options, warrants, or conversion rights already
18	owned, the underlying interest in order to fulfill or secure its obligations under
19	a call option, cap, or floor it has written or has set aside under a custodial or
20	escrow agreement cash or cash equivalents with a market value equal to the

1	amount required to fulfill its obligations under a put option it has written, in an
2	income generation transaction.
3	(11)(9) "Derivative instrument" means an agreement, option,
4	instrument, or a series or combination thereof:
5	(A) to make or take delivery of, or assume or relinquish, a specified
6	amount of one or more underlying interests or to make a cash settlement in lieu
7	thereof; or
8	(B) that has a price, performance, value, or cash flow based primarily
9	upon the actual or expected price, level, performance, value, or cash flow of
10	one or more underlying interests. Derivative instruments include options,
11	warrants used in a hedging transaction and not attached to another financial
12	instrument, caps, floors, collars, swaps, forwards, futures, and any other

2	a designated obligor shall be primarily liable on the instrument representing the
3	obligation.
4	(14)(12) "Domestic jurisdiction" means the United States, any state of
5	the United States, or any political subdivision of any of the foregoing.
6	(15)(13) "Equity interest" means any of the following that are not rated
7	credit instruments:
8	(A) common stock;
9	(B) preferred stock;
10	(C) trust certificate;
11	(D) equity investment in an investment company other than a money
12	market mutual fund or a class one listed bond mutual fund;
13	(E) investment in a common trust fund of a bank regulated by a
14	federal or state agency;

5	(16)(14) "Floor" means an agreement obligating the seller to make
6	payments to the buyer in which each payment is based on the amount by which
7	a predetermined number, sometimes called the floor rate or price, exceeds a
8	reference price, level, performance, or value of one or more underlying
9	interests.
10	(17)(15)(A) "Foreign investment" means an investment in a foreign
11	jurisdiction, or an investment in a person, real estate, or asset domiciled in a
12	foreign jurisdiction, that is substantially of the same type as those eligible for
13	investment under this subchapter, other than under subdivision $3463(a)(28)$ of
14	this title. An investment shall not be deemed to be foreign if the issuing
15	person, qualified primary credit source, or qualified guarantor is a domestic
16	jurisdiction or Canada or a person domiciled in a domestic jurisdiction or
17	Canada, unless:
18	(i) the issuing person is a shell business entity; and
19	(ii) the investment is not assumed, accepted, guaranteed, or
20	insured or otherwise backed by a domestic jurisdiction or Canada or a person

that is not a shell business entity domiciled in a domestic jurisdiction or

(B) For purposes of this definition:
(i) "Qualified guarantor" means a guarantor against which an
insurer has a direct claim for full and timely payment, evidenced by a
contractual right for which an enforcement action can be brought in a domestic
jurisdiction or Canada.
(ii) "Qualified primary credit source" means the credit source to
which an insurer looks for payment as to an investment and against which an
insurer has a direct claim for full and timely payment, evidenced by a
contractual right for which an enforcement action can be brought in a domestic
jurisdiction or Canada.
(iii) "Shell business entity" means a business entity having no
economic substance except as a vehicle for owning interests in assets issued,
owned, or previously owned by a person domiciled in a foreign jurisdiction.
(18)(16) "Foreign jurisdiction" means a jurisdiction other than a
domestic jurisdiction or Canada.
(19)(17) "Forward" means an agreement (other than a future) to make or
take delivery of, or effect a cash settlement based on the actual or expected

(23)(21) "High grade investment" means a rated credit instrument rated
1 or 2 by the SVO or that meets and continues to meet the conditions for
exemption as provided in section 3461d of this title.
(24)(22) "Income generation transaction" means a derivative transaction
involving the writing of covered call options, covered put options, covered
caps, or covered floors that is intended to generate income or enhance return.

1	(25)(23) "Institution" or "business entity" includes a sole proprietorship,
2	corporation, limited liability company, association, partnership, joint stock
3	company, joint venture, mutual fund, trust, joint tenancy, or other similar form
4	of business organization, whether organized for profit or not-for-profit not for
5	profit.
6	(24) "Listed bond mutual fund" means a mutual fund that at all times
7	qualifies for inclusion on the "bond fund list" within the Purposes and
8	Procedures of the NAIC Investment Analysis Office or any successor
9	publication.
10	(26)(25) "Lower grade investment" or "lower grade obligation" means a
11	rated credit instrument rated 4, 5, or 6 by the SVO.
12	(27)(26) "Medium grade investment" or "medium grade obligation"
13	means a rated credit instrument rated 3 by the SVO.
14	(28)(27) "Money market mutual fund" means a mutual fund that meets
15	the conditions of 17 Code of Federal Regulations Par. C.F.R. Part 270.2a-7,
16	under the Investment Company Act of 1940 (15 U.S.C. § 80a-1 et seq.), as
17	amended or renumbered.
18	(29)(28) "Mortgage loan" means an obligation secured by a mortgage,
19	deed of trust, trust deed, or other consensual lien on real estate.
20	(30)(29) "Mutual fund" means an investment company or, in the case of
21	an investment company that is organized as a series company, an investment

1	company series that, in either case, is registered with the U.S. U.S. Securities
2	and Exchange Commission under the Investment Company Act of 1940 (15

4	(31)(30) "NAIC" means the National Association of Insurance
5	Commissioners.
6	(32)(31) "Obligation" means a bond, note, debenture, trust certificate,
7	including an equipment certificate, production payment, negotiable bank
8	certificate of deposit, bankers' acceptance, credit tenant plan, loan secured by
9	financing net leases, and other evidence of indebtedness for the payment of
10	money (or participations, certificates, or other evidences of interest in any of

12	(33)(32) "Option" means an agreement giving the buyer the right to buy
13	or receive (a "call option"), sell or deliver (a "put option"), enter into, extend,

16	(34)(33) "Potential exposure" means the amount determined in

13	(37)(36) "Qualified exchange" means:

4	(38)(37) "Qualified foreign exchange" means a foreign exchange, board

8	Commodity Futures Trading Commission (CFTC) Rule 30.10 (as set forth in
9	Appendix C to Part 30 of the CFTC's Regulations, 17 C.F.R. Part 30);
10	(B) that is, or its members are, subject to the jurisdiction of a foreign
11	futures authority that has received regulatory comparability relief under CFTC
12	Rule 30.10 (as set forth in Appendix C to Part 30 of the CFTC's Regulations,
13	17 C.F.R. Part 30) as to futures transactions in the jurisdiction where the
14	exchange, board of trade, or contract market is located; or

2	(i) Relies on cash flows from assets that are prepayable at par at

4	(ii) Does not make payments of par that are fixed as to amount and
5	timing; and
6	(iii) Has a negative rate of return at the time of acquisition if a
7	prepayment threshold assumption is used with such prepayment threshold
8	assumption defined as either:
9	(I) Two times the prepayment expectation reported by a
10	recognized, publicly available source as being the median of expectations
11	contributed by broker dealers or other entities, except insurers, engaged in the
12	business of selling or evaluating such securities or assets. The prepayment
13	expectation used in this calculation shall be, at the insurer's election, the
14	prepayment expectation for pass-through securities of the Federal National
15	Mortgage Association, the Federal Home Loan Mortgage Corporation, the

2	subdivision (39), if the asset-backed security is purchased in combination with
3	one or more other asset-backed securities that are supported by identical
4	underlying collateral, the insurer may calculate the rate of return for these
5	specific combined asset-backed securities in combination. The insurer must
6	maintain documentation demonstrating that such securities were acquired and
7	are continuing to be held in combination.
8	(41)(40) "State of the United States" means any state of the United
9	States of America, and the District of Columbia, and the Commonwealth of
10	Puerto Rico.
11	(42)(41) "SVO" means the Securities Valuation Office of the NAIC or
12	any successor office established by the NAIC.
13	(43)(42) "Swap" means an agreement to exchange or to net payments at
14	one or more times based on the actual or expected price, level, performance, or
15	value of one or more underlying interests.
16	(44)(43) "Underlying interest" means the assets, liabilities, other
17	interests, or a combination thereof underlying a derivative instrument, such as
18	any one or more securities, currencies, rates, indices, commodities, or
19	derivative instruments.
20	(45)(44) "Warrant" means an instrument that gives the holder the right
21	to purchase an underlying financial instrument at a given price and time or at a

3	§ 4685. RATE STANDARDS
4	(a) General. Rates shall not be excessive, inadequate, or unfairly
5	discriminatory.
6	(b) Excessiveness.
7	(1) Competitive market. A rate in a competitive market is not excessive
8	or unfairly discriminatory.
9	(2) Noncompetitive market. Rates in a noncompetitive market are
10	excessive if they are producing or are likely to produce unreasonably high
11	profits for the insurance provided or if expenses are unreasonably high in
12	relation to services rendered.
13	(c) Inadequacy. Rates are not inadequate unless insufficient to sustain
14	projected losses and expenses in the class or classes of business to which they
15	apply or the use of such rates has or, if continued, will have the effect of
16	substantially lessening competition or the tendency to create a monopoly in
17	any market.
18	(d) Unfair discrimination. Unfair discrimination exists if, after allowing for
19	practical limitations, price differentials fail to reflect equitably the differences
20	in expected losses and expenses. A rate is not unfairly discriminatory because
21	different premiums result for a class of policyholders with like loss exposures

1	but different expenses, or like expenses but different loss exposures, so long as
2	provided that the rate equitably reflects the differences with reasonable
