7 Statement of purpose of bill as introduced: This bill proposes to make  
8 miscellaneous changes to the statutes pertaining to the State employees',  
9 municipal employees', and teachers' retirement systems and to set the  
10 contribution rates for municipal employees.

11 An act relating to pensions, retirement, and setting the contribution rates for  
12 municipal employees

13 It is hereby enacted by the General Assembly of the State of Vermont:

17 (a) As used in this subchapter:

19 (4) "Average final compensation" shall mean:

20 (A) For a ~~group~~ Group A and a ~~group~~ Group F member, the average

1 annual earnable compensation of a member during the three consecutive fiscal  
2 years beginning July 1 and ending June 30 of creditable service affording the  
3 highest average, or during all of the years of creditable service if fewer than  
4 three years. If the member's highest three years of earnable compensation are  
5 the three years prior to separation of service and the member separates prior to  
6 the end of a fiscal year, average final compensation shall be determined by  
7 adding:

8 (i) The actual earnable compensation earned in the fiscal year of  
9 separation through the date of separation and the service credit to correspond  
10 with the last ~~paydate~~ pay date.

12 (B) For a ~~group~~ Group C member, the average annual earnable

17 are the two years prior to separation of service and the member separates prior  
18 to the end of a fiscal year, average final compensation shall be determined by

21 separation through the date of separation and the service credit to correspond

9 he or she withdraw his or her contributions, or become a beneficiary or die, he  
10 or she shall thereupon cease to be a member. However, the membership of any  
11 employee entering such classes of military or naval service of the United  
12 States as may be approved by resolution of the Retirement Board, shall be  
13 continued during such military or naval service if he or she does not withdraw  
14 his or her contributions, but no such member shall be considered in the service  
15 of the State for the purpose of the Retirement System during such military or

21 (c) Every recipient of disability benefits who has not reached his or her  
22 normal retirement date shall, annually on a date determined by the Retirement

1 Board, file with the State Treasurer a statement certifying, under penalty of  
2 perjury and in such form as the Retirement Board shall prescribe, the full  
3 amount of his or her earnings from earned income during the preceding  
4 calendar year. The State Treasurer may request, and the beneficiary shall  
5 provide within 60 days ~~of~~ after such request, additional financial information  
6 and records pertinent to the beneficiary's earned income. The beneficiary's  
7 statement and accompanying forms and schedules and any other financial  
8 information and records provided by the beneficiary to the State Treasurer  
9 shall be confidential. In the event that a beneficiary fails to submit the  
10 certification or any required or requested financial information or records  
11 pertinent to the beneficiary's earned income, the beneficiary's retirement  
12 allowance shall be suspended until all such information and records have been  
13 submitted, and in the event that the failure continues for one year, all the  
14 beneficiary's rights in and to his or her pension and any pending  
15 reemployment rights under this section may be revoked by the Board.  
16 Notwithstanding any provision of this section to the contrary, if the  
17 beneficiary's earned income for the preceding year exceeded the difference  
18 between the beneficiary's retirement allowance and his or her average final  
19 compensation at retirement as adjusted for inflation each year following  
20 retirement, the beneficiary shall refund the portion of the preceding year's  
21 retirement allowance that is equal to the amount of the reduction specified in

1 subsection (b) of this section, and the refund amount may be offset against the  
2 beneficiary's monthly pension benefits. Prior to suspension or revocation of  
3 the beneficiary's retirement allowance, reemployment rights, or inception of  
4 any offset under this subsection, the Retirement Board shall provide the  
5 beneficiary with written notice and an opportunity to be heard.

13 An individual who is not a vested member of the System and who has not yet
