Subject: Executive; boards and commissions; mergers, repeals, and per diems

Statement of purpose of bill as introduced: This bill proposes to combine, eliminate, and provide per diems for certain State boards and commissions and to provide for the review of the ongoing necessity for the State's boards and commissions.

An act relating to boards and commissions

It is hereby enacted by the General Assembly of the State of Vermont:

* * * Merger of Groundwater and Well Water Committees * * *

Sec. 1. 10 V.S.A. § 1392 is amended to read:

§ 1392. DUTIES; POWERS OF SECRETARY

(a) The Secretary shall develop a comprehensive groundwater management program to protect the quality of groundwater resources by:

* * *

(c)(1) The Secretary shall establish a groundwater coordinating committee, with representation from the Division of Drinking Water and Groundwater Protection within the Department, the Division of Geology and Mineral Resources within the Department, the Agency of Agriculture, Food and

1 Markets, and the Departments of Forests, Parks and Recreation and of Health
2 to provide advice in the development of the program and its implementation,
3 on issues concerning groundwater quality and quantity, and on groundwater
4 issues relevant to well-drilling activities and the licensure of well drillers.

5 (2) In carrying out his or her duties under this subchapter, the Secretary
6 shall give due consideration to the recommendations of the groundwater
7 coordinating committee.

8 (3) The Secretary may request representatives of other agencies and the
9 private sector, including licensed well drillers, to serve on the groundwater
10 coordinating committee.

14 ~~(a) The Vermont water well advisory committee is created. The committee~~
15 ~~shall consist of seven members: the director of the groundwater and water~~
16 ~~supply division, the state geologist, a representative from the department of~~
17 ~~health, and four members appointed by the governor. Three of the four public~~
18 ~~members shall be licensed well drillers, with at least five years of experience.~~
19 ~~The fourth public member shall be a person not associated with the well-~~
20 ~~drilling business who has an interest in wells and water quality.~~

1 ~~(b) The purpose of the committee is to advise and assist agency personnel~~
2 ~~in the formulation of policy, including recommended statutory and regulatory~~
3 ~~changes, regarding the proper installation and maintenance of water wells,~~
4 ~~licensing of well drillers, and groundwater issues impacted by well drilling~~
5 ~~activities. The committee shall promote and encourage cooperation and~~
6 ~~communication between governmental agencies, licensed well drillers, and~~

9 ~~appointments of the public members made for lesser terms, so that the~~

6 ~~and consent of the Senate, for three year terms beginning February 1 of the~~
7 ~~year in which the appointment is made, except that one of the initial~~
8 ~~appointments shall be for a term of one year and two of the initial~~
9 ~~appointments shall be for a term of two years. A vacancy in the Board shall be~~
10 ~~filled in the same manner as the original appointment for the unexpired portion~~

18 (a)(1) The Commission on Women is created as the successor to the
19 Governor's Commission on Women established by Executive Order No. 20-
20 86. The Commission shall be organized and have the duties and
21 responsibilities as provided in this section.

1 (2) The Commission shall be an independent agency of the government
2 of Vermont and shall not be subject to the control of any other department or
3 agency.

4 (3) Members of the Commission shall be drawn from throughout the
5 State and from diverse racial, ethnic, religious, age, sexual orientation, and
6 socioeconomic backgrounds, and shall have had experience working toward
7 the improvement of the status of women in society.

8 (b) The Commission shall consist of 16 members, appointed as follows:

9 (1) Eight members shall be appointed by the Governor; ~~no~~, not more

(i)(1) No part of any funds appropriated to the Commission by the ~~legislature~~ General Assembly shall, in the absence of express authorization by the ~~Legislature~~ General Assembly, be used directly or indirectly for legislative or administrative advocacy. The Commission shall review and amend as necessary all existing contracts and grants to ensure compliance with this subsection.

(2) ~~For purposes of~~ As used in this subsection, legislative or administrative advocacy means employment of a lobbyist as defined in 2 V.S.A. chapter 11, or employment ~~of, or~~ establishment ~~of,~~ or maintenance of; a lobbyist position whose primary function is to influence legislators or State officials with respect to pending legislation or ~~regulations~~ rules.

Sec. 7. COMMISSION ON WOMEN; CURRENT TERMS

A member of the Commission on Women on the effective date of this act whose appointing authority is repealed under the provisions of Sec. 6 of this act may serve the remainder of her or his term.

Sec. 8. 10 V.S.A. § 1372 is amended to read:

§ 1372. MEMBERS; APPOINTMENT; TERM

(a) Within 30 days after he or she has executed the ~~compact~~ Compact with any or all of the states legally joined therein, the ~~governor~~ Governor shall appoint three persons to serve as commissioners to the New England Interstate

1 Water Pollution Control Commission. The ~~commissioner of environmental~~
2 ~~conservation~~ Commissioner of Environmental Conservation and the
3 ~~commissioner of health~~ Commissioner of Health shall serve as ex officio
4 commissioners ~~thereon~~ on the Commission.

5 (b) The commissioners so appointed shall hold office for six years.

6 ~~Vacancies~~ A vacancy occurring in the office of ~~the commissioners a~~

17 § 268. BOARDS AND COMMISSIONS; SUNSET ADVISORY

18 COMMISSION

19 (a) Creation.

20 (1) There is created the Sunset Advisory Commission to review existing
21 State boards and commissions, to recommend the elimination of any board or

1 commission that it deems no longer necessary or the revision of any of the
2 powers and duties of a board or commission, and to recommend whether
3 members of the boards and commissions should be entitled to receive per diem
4 compensation.

5 (2) As used in this section, “State boards and commissions” means
6 professional or occupational licensing boards or commissions, advisory boards
7 or commissions, appeals boards, promotional boards, interstate boards,
8 supervisory boards and councils, and any other boards or commissions of the
9 State.

10 (b) Membership.

11 (1) The Commission shall be composed of the following six members:

12 (A) two current members of the House of Representatives who shall
13 not both be from the same political party and one of whom shall be appointed
14 co-chair, who shall be appointed by the Speaker of the House;

15 (B) two current members of the Senate, who shall not both be from
16 the same political party and one of whom shall be appointed co-chair, who
17 shall be appointed by the Committee on Committees; and

18 (C) two persons appointed by the Governor.

19 (2) Members shall be appointed at the beginning of each biennium. A
20 member shall serve biennially and until his or her successor is appointed,

1 except that a legislative member's term on the Commission shall expire on the
2 date he or she ceases to be a member of the General Assembly.

3 (c) Powers and duties. The Commission shall have the following powers
4 and duties:

5 (1) Inventory; group; review schedule. The Commission shall inventory
6 all of the State boards and commissions, organize them into groups, and
7 establish a schedule to conduct a review of one group each biennium.

8 (2) Biennial review.

9 (A) Each biennium, the Commission shall review all of the State
10 boards and commissions within one of its inventoried groups and shall take
11 testimony regarding whether each of those boards and commissions should
12 continue to operate or be eliminated and whether the powers and duties of any
13 of those boards and commissions should be revised.

14 (B) In its review of each State board and commission, the
15 Commission shall consider:

16 (i) the purpose of the board or commission and whether that
17 purpose is still needed;

18 (ii) how well the board or commission performs in executing that
19 purpose; and

1 (iii) if the purpose is still needed, whether State government would
2 be more effective and efficient if the purpose were executed in a different
3 manner.

4 (C) Each board and commission shall have the burden of justifying
5 its continued operation.

6 (D) For any board or commission that the Commission determines
7 should continue to operate, the Commission shall also determine whether
8 members of that board or commission should be entitled to receive per diem
9 compensation and if so, the amount of that compensation.

10 (3) Biennial report. On or before the end of the biennium during which
11 it reviews a group, the Commission shall submit to the House and Senate
12 Committees on Government Operations its findings, any recommendation to
13 eliminate a State board or commission within that group or to revise the powers
14 and duties of a board or commission within the group, its recommendations
15 regarding board or commission member per diem compensation, and any other
16 recommendations for legislative action. The provisions of 2 V.S.A. § 20(d)
17 (expiration of required reports) shall not apply to the report to be made under
18 this subsection.

19 (d) Assistance. The Commission shall have the administrative, technical,
20 and legal assistance of the Office of Legislative Council, the Joint Fiscal
21 Office, and the Agency of Administration.

1 (e) Compensation and expense reimbursement.

2 (1) For attendance at meetings during adjournment of the General
3 Assembly, a legislative member of the Commission shall be entitled to per
4 diem compensation and reimbursement of expenses pursuant to 2 V.S.A. § 406
5 for not more than five meetings per year. These payments shall be made from
6 monies appropriated to the General Assembly.

7 (2) Other members of the Commission who are not employees of the
8 State of Vermont and who are not otherwise compensated or reimbursed for
9 their attendance shall be entitled to per diem compensation and reimbursement
10 of expenses pursuant to 32 V.S.A. § 1010 for not more than five meetings per
11 year. These payments shall be made from monies appropriated to the Agency
12 of Administration.

13 Sec. 10. TRANSITIONAL PROVISION; INITIAL SUNSET ADVISORY

14 COMMISSION

15 The members of the initial Sunset Advisory Commission established in
16 3 V.S.A. § 268 in Sec. 9 of this act shall be appointed on or before October 15,
17 2018 and shall meet prior to the 2019-2020 biennium in order to inventory all
18 of the State boards and commissions and organize them into groups as
19 described in Sec. 9 of this act in 3 V.S.A. § 268(c) so as to be able to review all
20 groups within four bienniums, and during the 2019-2020 biennium those

1 members shall conduct the first biennial review of a group in accordance with
2 that subsection.

3 Sec. 11. SUNSET OF THE SUNSET ADVISORY COMMISSION

4 3 V.S.A. § 268 (boards and commissions; Sunset Advisory Commission) is
5 repealed on January 6, 2027.
