16	§ 4501. LIMITATIONOF PROSECUTIONS FOR CERTAIN CRIMES
17	(a) Prosecutions for aggravated sexual assault, aggravated sexual assault of
18	a child, sexual assault, human trafficking, aggravated human trafficking,
19	murder, arson causing death, and kidnapping may be commenced at any time

1	after the commission of the offense.
2	(b) Prosecutions for manslaughter, sexual assault, lewd and lascivious
3	conduct, sexual exploitation of children under chapter 64 of this title, sexual
4	abuse of a vulnerable adult, grand larceny, robbery, burglary, embezzlement,
5	forgery, bribery offenses, false claims, fraud under 33 V.S.A. § 141(d), and
6	felony tax offenses shall be commenced within six years after the commission
7	of the offense, and not after.
8	(c) Prosecutions for any of the following offenses alleged to have been
9	committed against a child under 18 years of age shall be commenced within 40
10	years after the commission of the offense, and not after:
11	(1) sexual assault sexual exploitation of children under chapter 64 of

14	(3) sexual exploitation of a minor as defined in subsection 3258(c) of
15	this title;

4	In accordance with 21 V.S.A. § 306, it is the policy of the State of Vermont
5	that no confidential employment separation agreement shall inhibit the
6	disclosure to prospective employers of factual information about a prospective
7	employee's background that would lead a reasonable person to conclude that
8	the prospective employee has engaged in conduct jeopardizing the safety of a
9	vulnerable adult or minor.

12	(a) Criminal records and criminal record information received under this

11	headmaster and employees of a supervisory union, school district, or
12	recognized or approved independent school shall provide factually correct
13	information concerning a former employee's employment record with the
14	supervisory union, school district, or recognized or approved independent
15	school to a prospective employer of that individual if requested by the
16	prospective employer. Nothing in this subsection shall permit the disclosure of

2	(a) Creation. There is created the Committee for Enhancing School Safety.
	(b) Membership. The Committee shall be composed of the following eight ten members:
