6	Statement of purpose of bill as introduced: This bill proposes to require a
7	resident 18 years of age or older who operates a bicycle on the highways of
8	this State to register his or her bicycle.

10	It is hereby enacted by the General Assembly of the State of Vermont:

12	§ 364a. MOTOR-DRIVEN CYCLES: REGISTRATION; FINANCIAL
13	RESPONSIBILITY; BICYCLE REGISTRATION
14	(a) The annual fee for registration of a motor-driven cycle shall be \$28.00.
15	(b) Motor-driven cycle operators shall be subject to the provisions of
16	section 801 of this title, which requires, in certain cases, that proof of financial
17	responsibility be filed with the Commissioner after an accident.
18	(c) A resident 18 years of age or older who operates a bicycle on the
19	highways of this State shall register his or her bicycle and shall be subject to an
20	annual registration fee of \$28.00. A resident who has moved into the State

1	from another jurisdiction shall register his or her bicycle within 60 days
2	following moving into the State. The Commissioner shall issue each registrant
3	a registration certificate as well as a plate or decal with a unique combination
4	of identifying letters and numbers, and the plate or decal shall be affixed to the
5	bicycle as prescribed by the Commissioner. Upon initial registration by an
6	owner or transferee, the Commissioner shall require proof of ownership.
7	Bicycle registrants shall be subject to the requirements and prohibitions of
8	sections 307-310 of this title and be subject to the rights and requirements of
9	sections 321-324 of this title regarding transfer of ownership, except that the
10	Commissioner may charge a fee upon transfer of not more than \$15.00.
11	(d) A person who violates a requirement of subsection (c) of this section
12	shall be subject to a civil penalty of not more than \$100.00.
13	(e) Owners of bicycles not required to be registered under this section may
14	elect to register their bicycles in order to facilitate the return of recovered
15	stolen bicycles.

17	§ 381. FEES TURNED OVER TO STATE TREASURER
18	(a) Except as otherwise provided, all fees for registering motor vehicles,
19	licensing operators, and all other motor vehicle fees shall be collected by the
20	Commissioner and forthwith paid into the State Treasury or deposited to such
21	bank to the credit of the State Treasurer as he or she may direct.
