Concurrent Resolutions for Adoption Under Joint Rule 16

The following concurrent resolutions will be adopted automatically unless a Representative or Senator requests floor consideration before the end of Friday's legislative session. Requests for floor consideration must be communicated to the House Clerk's office or the Senate Secretary's office.

Resolutions

H.C.R. 26.

House concurrent resolution commemorating the 225th anniversary of the Town of Mount Holly

Offered by: Representatives Devereux of Mount Holly and Potter of Clarendon

Offered by: Senators Clarkson, McCormack, Nitka, Collamore, and Flory

<u>Whereas</u>, in order to raise funds to support Vermont's military preparations during the Revolutionary War, on February 23, 1781, the General Assembly sold to Abraham Jackson Esq. and 30 associates "a certain tract or gore of land, lying and being situated on the east side of Wallingford, containing by estimation nine thousand seven hundred acres...To be annexed to and incorporated with the town of Wallingford," and

Whereas, the sale raised two hundred seventy pounds, and

Whereas, the tract of land sold became known as Jackson's Gore, and

Whereas, the first settlers in Jackson's Gore, including Abraham Jackson, arrived in 1782, and

<u>Whereas</u>, on October 18, 1792, residents of Jackson's Gore and the western part of adjacent Ludlow that "Impassable Mountains" cut off from the eastern section of that town filed a petition with the General Assembly for the chartering of a new town, and

Whereas, on October 31, 1792, a legislative charter incorporating "the separate town of Mount Holley" was passed into law, and

<u>Whereas</u>, the new Town of Mount Holley (which subsequently dropped the "e" from the spelling of Holly) included the original Jackson Gore, 11,739 acres from the town of Ludlow, and 3,888 acres from the town of Wallingford for a total of 25,796 acres, and

<u>Whereas</u>, at the first Mount Holly town meeting on November 19, 1792, the citizens of the town voted to incorporate and elected Abraham Jackson as moderator; Stephen Clark as town clerk; Jackson, Clark, and Silas Proctor as

selectmen; and Jackson as the town's first State representative, and at a second town meeting held on March 4, 1793, all of the original officials were reelected, plus the voters chose a lister, poundkeeper, treasurer, and other officials, and

<u>Whereas</u>, Mount Holly's 1870 efforts to annex a section of the Town of Weston were unsuccessful, but the boundaries with Ludlow were modified in 1994 Acts and Resolves No. 123, and

Whereas, 2017 marks the Town of Mount Holly's 225th anniversary, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the 225th anniversary of the Town of Mount Holly, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Mount Holly town clerk and the Mount Holly Historical Society.

<u>Whereas</u>, the speedy five runners who comprised the 2016 Highlander State championship meet team finished first, second, third, eighth, and ninth, earning an amazingly low score of a mere 21 points, the lowest score being the objective in crosscountry competition, and

<u>Whereas</u>, the next lowest scoring team was Montpelier, which at 67 points trailed far behind Harwood as the delighted Highlanders brought home their eighth consecutive Division II title, and

Whereas, the victorious 2016 Highlanders were Erin Magill, Anneka Williams, Julianne Young, Lily Clark, Isabella Jamieson, Phoebe Sweet, and Willa Yonkman, and

Whereas, the leadership of coaches John Kerrigan, Tom Strasser, Andrew Reid, and Laurel Whitney was critical for the Harwood victory, now

<u>Whereas</u>, after graduation, Dr. Carl Heilman completed his neurosurgical residency at the Tufts University Medical Center, serving as chief resident before completing advance training in skull surgery at the University of Tennessee, and

Whereas, in 1994, the impressed senior neurosurgeons at Tufts Medical Center hired Dr. Carl Heilman as a neurosurgery faculty member, and

Whereas, over the past 23 years, Dr. Carl Heilman has been a prolific author of medical journal articles and book chapters on neurosurgery topics, and

Whereas, as a recognized neurosurgery leader, Dr. Carl Heilman has served as president of several local and national professional organizations, and

House concurrent resolution designating the month of February 2017 as SelfCare Month in Vermont

Offered by: Representative Turner of Milton

<u>Whereas</u>, self-care is a lifelong daily habit of health lifestyle choices, good hygiene practices, prevention of infection and illness, avoiding unhealthy choices, monitoring for signs and symptoms of changes in health, knowing when to consult a health care practitioner, and knowing when it is appropriate to self-treat conditions, and

Whereas, the U.S. Food and Drug Administration deems informed adult use

and carefully adult monitored child use of overthecounter (OTC) medicines safe and effective for the self-care treatment of minor acute and chronic health conditions and symptoms such as pain, the common cold, allergies, and other conditions that affect large segments of the population, and

<u>Whereas</u>, according to a 2012 study that the consulting firm booz&co. and the Consumer Healthcare Products Association issued, OTC medicines save consumers \$102 billion annually in health care product costs and save approximately \$6.00 to \$7.00 for each dollar spent, and

<u>Whereas</u>, OTC medicines may be developed as new nonprescription medicines or switched from existing prescription medicines, and

Whereas, OTC nonprescription medicines are self-care products that consumers purchase in pharmacies, supermarkets, retail stores, and online, and

Whereas, nonprescription medicines help to ease the burden on health care practitioners, and

<u>Whereas</u>, Vermont benefits when its citizens practice appropriate self-care, and do not unnecessarily visit health care practitioners, and

<u>Whereas</u>, Vermont encourages its citizens to take advantage of self-care's potential to improve personal and public health, and

<u>Whereas</u>, achieving self-care's potential is a shared opportunity for consumers, health care practitioners, policymakers, and regulators, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates the month of February 2017 as SelfCare Month in Vermont.
