Whereas, Marilyn Childs graduated from the Springfield, Massachusetts, public schools; earned a bachelor's degree from American International College; and pursued graduate studies at Springfield College and the University of Vermont, and

Whereas, her journalism career began at the *Springfield* (Massachusetts) *Union* in 1940, the same year she graduated from high school, and

Whereas, for many years, students at Chelsea High School knew Marilyn Childs as a respected educator who taught English, French, journalism, composition and speech; served as a guidance counselor and assistant principal; coached outstanding forensics teams that won 10 State championships and other debating honors; was twice named as Vermont Debate Coach of the Year; and taught her students to respect the power of the English language, and

Whereas, Marilyn Childs was a civic and political leader, serving as a Chelsea Justice of the Peace, chairing the town's Republican committee, and sitting on the party's county and State committees, and

Whereas, staring at nine years of age and for 60 years thereafter, Marilyn Childs was in the saddle or engaged in a variety of equestrian-related roles, including editing specialized periodicals, writing five topically related books, serving as a licensed judge and steward of the American Horse Show Association, and directing the American Morgan Horse Association, and she was 1975's Morgan Horse Woman of the Year, and

Whereas, Marilyn C. Childs died at 93 years of age on December 16, 2016, and her survivors include her sons, David, Robert, and Carl; six grandsons; two granddaughters; and a great-grandson, now therefore be it

Whereas, following completion of a family medicine residency at UVM, he returned to Townshend and entered private practice, and

Whereas, Dr. Robert Backus, who is board certified in family and geriatric medicine and is a Fellow of the American Academy of Family Physicians and the American Geriatrics Society, has described the small and nonprofit Grace Cottage Hospital, where he has continued to be employed, as "the greatest community-development project I've ever seen," and

Whereas, his dedication to this unique medical center involves extensive fundraising work that he conducts with a passion, and

Whereas, his patients revere him, and he places great importance on continuously updating his medical knowledge, and

Whereas, since 2006, Dr. Robert Backus has exercised his discerning judgment presiding as the Wardsboro Town Moderator, and

Whereas, on March 9, 2017, an era in southern Vermont's health care will end when Dr. Robert Backus concludes his full-time practice of medicine, but fortunately, he will remain associated with Grace College Hospital, focusing on fundraising and the addition of a gerontology practice, now therefore be it

Whereas, Grace Weber was actively involved with the Weybridge Volunteer Fire Department and her local church, and

Whereas, she was an instrumental organizer of town picnics, and her delicious home-baked treats added to these events' festivities, and

Whereas, Grace Weber designed an English grammar curriculum that she assisted in teaching at the Weybridge Elementary School and St. Mary's School in Middlebury, and

<u>Whereas</u>, a passionate lover of the Italian language, Grace Weber organized and participated in Italian conversation groups, and Steve and she traveled to Italy on a number of occasions, and

<u>Whereas</u>, Grace Weber was an enthusiastic singer who performed at school talent shows and other local venues, extending from Middlebury to Burlington, often with Steve providing piano accompaniment, and

Whereas, in the early 1980s, he acquired the 185-yearold building that had housed a restaurant since 1930, and was originally Wilmington's U.S. Post Office, and

Whereas, John Reagan soon opted to rename this well-known eatery Dot's Restaurant, and it continued to attract enthusiastic local residents and vacationers visiting southern Vermont, and

Whereas, in 1984, Patty Bemis of Jacksonville applied for a waitressing job, John Reagan promptly hired then fired her, officially for not showing up to work on time, but they later married, and ever since have been devoted business and life partners, and

Whereas, although a purveyor of fantastic and popular meals, Dot's Restaurant is precariously located adjacent to the Deerfield River, and when Tropical Storm Irene devastated the town of Wilmington in 2011, it severely damaged Dot's home, and

Whereas, the establishment's future at first appeared dubious, but with a persevering spirit and financial support from many individuals, the Friends of the Valley Foundation, the Preservation Trust of Vermont, and the Wilmington Fund, Dot's Restaurant triumphantly reopened in 2013, and its elegant restoration was awarded a 2014 Preservation Trust of Vermont award "for preserving Vermont's historic architecture," and

Whereas, in 2010, shortly before her 92nd birthday, Rachel Mason recited a sample of her Pownal history poetry at the town's 250th anniversary celebration, and her reading was posted on YouTube, and

Whereas, for an impressive 80 years, Rachel Mason was a member of the Bennington Grange and served in many leadership positions, and

<u>Whereas</u>, Rachel Mason volunteered for both the local 4-H and the Southwestern Vermont Medical Center, and

Whereas, the Camp Ondawa Association appreciated her fine work as one of its trustees, and

Whereas, worshipers at the Second Congregational Church in Bennington knew Rachel Mason as a member of their congregation, and

Whereas, Rachel Mason died on August 31, 2016, and her survivors include her four children, David, Doris, Connie, and Terri; nine grandchildren; six great-grandchildren; two great-great-grandchildren, now therefore be it
