H.C.R. 107.

House concurrent resolution designating April 2017 as Financial Capability Month in Vermont

Offered by: Representatives Ancel of Calais, Dakin of Colchester, Deen of Westminster, Hooper of Montpelier, Kitzmiller of Montpelier, Mrowicki of Putney, Sheldon of Middlebury, Toll of Danville, and Wood of Waterbury

Whereas, basic financial capability is a prerequisite for all Vermonters, and in 2014, President Obama proclaimed April as National Financial Capability Month "to renew our drive to give all Americans the tools to navigate the financial world," and

Whereas, financial independence can be measured in terms of life cycle events, including universal experiences (childhood or aging), expected or recurring experiences (events that happen for many, such as getting a job or having children), and unexpected experiences (losing a job or a medical crisis), and

Whereas, the importance of increasing the number of Vermonters who are financially capable is evident on many fronts, and

Whereas, the Champlain Valley Office of Economic Opportunity reports that 27 percent of Vermont households are only one layoff or major medical incident away from falling below the poverty line, 14.3 percent of Vermonters are either unbanked or underbanked, and nearly 50 percent of Vermonters do not have an employment-related retirement plan, and

Whereas, according to Champlain College's National Report Card on financial literacy, 65 percent of college graduates carry student loan debt averaging \$29,000.00, and

Whereas, despite these alarming statistics, there are positive developments on the personal financial front, and

Whereas, since 1997, over 1,000 Vermonters have participated in the Individual Development Account Program and have invested \$2.5 million in their future lives, and

Whereas, \$1.1 million is invested annually in the Microbusiness Development Program that has assisted Vermonters with low or moderate income to either start or expand businesses, and

Whereas, one hour of financial education increases average monthly net savings by \$1.16 monthly and ten hours yields \$1,390.00 annually, and

Whereas, Vermonters can learn important lessons and practices if they are financially capable, and today, April 6, 2017, individuals and organizations dedicated to promoting financial capability are visiting the State House to remind everyone of its importance, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates April 2017 as Financial Capability Month, and be it further

Whereas, Alzheimer's disease is currently the fifth leading cause of death in Vermont, the sixth nationally, and nationwide, a new Alzheimer's case is documented every 66 seconds, and

Whereas, by 2050, the cost of Alzheimer's disease to the nation's economy is projected to rise from the current \$259 billion to \$1.1 trillion, and

Whereas, 12,000 Vermonters are living with Alzheimer's disease or a related form of dementia, a figure projected to increase to 17,000 by 2025, and

Whereas, nationally, 82 percent of persons with Alzheimer's disease are 75 years of age or older, and

Whereas, since 2000, in Vermont, there has been a 99 percent increase in deaths attributed to Alzheimer's disease, and

Whereas, it is estimated that Vermont Medicaid expenses for persons with Alzheimer's disease are estimated to equal \$98 million in 2017, and this amount is projected to increase nearly 45 percent by 2025, and

Whereas, 30,000 Vermonters are providing an estimated 34 million hours of unpaid care to persons with Alzheimer's or related dementia, and

Whereas, if compensated, this care would be worth \$430 million, and

Whereas, nationally, 15,975,000 Americans are providing an estimated 18,192,000,000 hours of uncompensated care with an estimated value of \$230.1 billion, and

Whereas, throughout the country, 35 percent of caregivers for persons with Alzheimer's disease or other forms of dementia report their own health has deteriorated since assuming this role, and their additional health care costs nationally total \$10.85 billion, and

Whereas, today, April 6, 2017, health care professionals, families with members who suffer from Alzheimer's disease and caregivers are gathered at the State House to inform legislators about the problems caregivers must confront and the status of efforts to find a cure for Alzheimer's disease, now therefore be it

Whereas, cartooning is a creative and colorful form of artistic expression appearing in newspapers, magazines, graphic novels, on the Internet, or as stand-alone works that can convey a cultural, political, or philosophical idea, or simply a lighthearted thought, and

Whereas, Alison Bechdel, one of America's most praised contemporary cartoonists, is originally from Pennsylvania and earned a degree in studio art and art history from Oberlin College, and

Whereas, after graduation, her first cartooning initiative was a series of single drawings that evolved into the multi-panel strip *Dykes to Watch Out For*, featuring a lesbian perspective on the American scene that was serialized in 50 alternative newspapers, and

Whereas, her graphic novel Fun Home: A Family Tragicomic, published in 2006, chronicled her childhood and realistically portrayed the unique idiosyncrasies of her parents, especially her father, and

Whereas, Are You My Mother?, a second graphic novel published in 2012, centered on her relationship with her mother, and

Whereas, both novels received wide praise in the literary press, including *Fun Home*'s listing as a National Book Critics Circle Award finalist, and

Whereas, the academic, literary, and publishing communities have bestowed many honors on Alison Bechdel, including her serving as a Mellon Residential Fellow for Arts and Practice at the University of Chicago, the Comics Alliance's citing her as one of 12 women cartoonists deserving of lifetime recognition, a Guggenheim Fellowship, and in 2014, a prestigious MacArthur Fellowship, and

Whereas, in 2015, the Broadway musical based on *Fun Home* won multiple Tony Awards, including best musical, and

Whereas, the Center for Cartoon Studies originated the post of Vermont Cartoonist Laureate, and James Kochalka and Ed Koren have been so honored, and

Whereas, today, Thursday, April 6, 2017, Alison Bechdel is being appointed as Vermont's third Cartoonist Laureate, now therefore be it

Whereas, Alex Aldrich's innovative leadership of the VAC has benefited artists, arts organizations, and arts education programs, and

Whereas, as a board member of the Vermont Council on Rural Development, he promoted a creative economy that emphasizes the arts, and

Whereas, in collaboration with the Vermont Department of Marketing and Tourism, Alex Aldrich helped develop Vermont's Heritage Tourism Kit, and

Whereas, he played a major role in the VAC's headquarters enhancements, including the addition of a new building wing and the creation of a sculpture garden, and

<u>Whereas</u>, the Camel's Hump design on the Vermont Quarter and the selection of *These Green Mountains* as the State Song owe much to his constructive input, and

Whereas, other significant initiatives he fostered were the Palettes of Vermont project, the Art of Action project, and the Animating Infrastructure program, and

Whereas, Alex Aldrich has announced his VAC leadership will conclude on April 14, 2017, ending an outstanding 20-year tenure, now therefore be it

House concurrent resolution recognizing the 3–4–50 chronic disease resource as a valuable preventative health care guide

Offered by: All Members of the House

Whereas, according to the Vermont Department of Health (the Department), three behaviors: lack of physical activity, poor nutrition, and tobacco use, contribute to four chronic diseases: Type 2 diabetes, lung disease, heart disease and stroke, and cancer, which cause 50 percent of the deaths in Vermont, and

Whereas, the Department also reports that 36 percent of adults are either overweight or obese, 14 percent of high schoolers are in one of these two categories, and over three-quarters of the younger group are not sufficiently physically active, and

Whereas, tobacco use is the number one preventable cause, which in Vermont leads to approximately 1,000 smoking-related deaths each year and \$348 million in medical expenses, and

Whereas, Vermonters Taking Action Against Cancer (VTAAC) represents Vermont's cancer community, including the Department of Health, the statewide cancer coalition, Vermont hospitals, cancer survivors, the American Cancer Society, and other nonprofit organizations that speak with one voice about reducing cancer risk, detecting cancer earlier, creating better access to quality cancer treatment, and improving the quality of life for cancer survivors, and

Whereas, the tenets of 3–4–50 can help VTAAC and Vermont achieve these prevention goals, and

Whereas, according to the most recent data from the National Center for Health Statistics, cancer is the leading cause of death in Vermont, a status that cancer shared with heart disease from the 1960s until 2007, and

Whereas, in the summer of 1777, two brigades of British forces, under the command of British General John Burgoyne, were seeking to isolate New England militarily from the rest of the United States, and

Whereas, Burgoyne's forces, having suffered a tactical loss to American forces at the Battle of Hubbardton, were marching southbound toward Saratoga, New York, and a decisive defeat to come in October 1777, and

Whereas, more immediately, in need of military stores and general supplies, the British, who had support from German mercenaries, American Indians, and loyalists, learned of a supply depot in Bennington and headed in that direction, and

Whereas, the Council of Safety of the newly established Republic of Vermont sought to halt this British advance and solicited military support from the State of New Hampshire, and

Whereas, Continental Army Brigadier General John Stark lead local independence forces in this effort, and

Whereas, on August 16, 1777, General Stark led a combined contingent of soldiers from Vermont, Massachusetts, and New Hampshire that twice defeated the British, the second time with the welcomed assistance of Vermonters Seth Warner and the Green Mountain Boys, and

Whereas, the Battle of Bennington, an important milestone on the road to American independence, is commemorated as an annual State holiday, and 2017 marks this battle's 240th anniversary, now therefore be it

Whereas, a life cut short by an opioid overdose death is devastating for the family and loved ones left behind, and is a tragic reminder of the significant and complex challenges we face in communities throughout the State, and

Whereas, in Vermont, from 2010 to 2016, the total number of accidental and undetermined-manner opioid-related fatalities involving either a prescription drug, heroin, fentanyl, or a combination thereof rose from 41 to 106, and

Whereas, at the other end of the life spectrum, from 2009–2015, the rate per 1,000 live births to Vermont residents in Vermont hospitals of infants exposed to opioids rose from 22.6 to 34.0, and

Whereas, Vermont has a multifaceted, statewide approach that involves multiple State and community partners, including local governments, police and public safety officials, first responders, educators, nonprofit and faith-based organizations, and individuals, working to address opioid addiction and to reverse the increase in the incidence of opioid overdoses, and

Whereas, the Division of Alcohol and Drug Abuse Programs within the Vermont Department of Health, in conjunction with partner organizations, has adopted SBIRT (Screening, Brief Intervention and Referral to Treatment), "an evidence-based public health approach for identifying patients who use alcohol and other drugs at risky levels with the goal of reducing and preventing related health consequences," and

Whereas, Vermonters working to reduce the incidence of opioid overdosing in the State are gathered at the State House today, April 13, 2017, to remind everyone of this important objective, now therefore be it
