Whereas, as the fourth-seeded team in the unusually competitive 2017 Division II boys' ice hockey playoffs, the talented North Country Union High School Flacons were aiming to achieve championship glory, and

Whereas, dispelling any doubts about their hockey prowess, the Falcons defeated the top-seeded Hartford Hurricanes 6–3 in the semifinal game and eagerly anticipated their championship face-off against the second-seeded Harwood Union High School Highlanders at the University of Vermont's (UVM) Gutterson Fieldhouse, marking North Country's first appearance at UVM since 2006, and

Whereas, in the decisive contest of the 2016–2017 season, the Falcons established a 3–0 lead, and despite the Highlanders closing the scoring gap, the Falcons persevered and scored a 4–3 victory, proudly clinching the 2017 Division II crown, and

Whereas, Head Coach Ryan Jacobs, Assistant Coach Jimmy Jacobs, and team manager Reid Burke served as great Falcon ice hockey supporters, now therefore be it

Whereas, Sam Lloyd played many roles on the Broadway stage; in regional theaters, especially the Weston Playhouse where he appeared in over 1,000 performances and served on its board; and on the silver screen, and

Whereas, his outstanding theatrical career was only one facet of a life in which business and civic roles were of at least equal magnitude, and

Whereas, born in New York City, Sam Lloyd served with distinction as a U.S. Marine in World War II, including at the invasion of Iwo Jima, and trained at New York's Feagin School of Drama and Radio, and

Whereas, his first Weston Playhouse appearance in 1951 was so satisfying that in 1960, Sam Lloyd permanently located to Weston for what became a diverse and fulfilling life, and

Whereas, for three decades, Sam Lloyd ran the Weston Bowl Mill, a manufacturer of wooden kitchenware and accessories, and

Whereas, the voters of Weston elected him to sit on the selectboard, and he served on the town's planning commission, and

Whereas, undoubtedly his most enduring municipal office was serving as Weston Town Moderator, and he presided at town meetings fairly and faithfully for nearly four decades, and

Whereas, with an interest in the quality of the local public school, Sam Lloyd served on the Flood Brook Schoolboard, and he also donated computers and funds to the school to promote digital literacy, and

Whereas, beginning in January 1973, Sam Lloyd served as the member from Weston in the House of Representatives, developing a special interest in environmental issues while serving on the Committee on Natural Resources and rising to the posts of vice chair and chair, and

Whereas, after leaving the House, this interest continued as he served on the Environmental Board, and

Whereas, Sam Lloyd, a leader of many passions, a philanthropist, and a respected figure in the town of Weston, died on March 25 at 91 years of age, and his surviving family members include his wife, Barbara; his children, Sam, Laurel, Robin, and Sandra; four grandchildren; four great-grandchildren; three step children; three step grandchildren; one step great-grandchild; and three siblings, now therefore be it

Whereas, in 1964, Hubert Schriebl accepted a teaching position at the Stratton Ski School where he established a presence that has lasted for over half a century, and

Whereas, Hubert Schriebl is not only an expert skier and mountain guide but also an experienced photographer whose first camera was a Voigtländer 35 millimeter, and

Whereas, in the early 1960s, before arriving at Stratton, he journeyed on mapping expeditions to some of the highest peaks of the Himalayan Mountains as well as to remote Ellesmere Island north of the Arctic Circle, developing an eye for the ideal photograph, and

Whereas, on the Stratton slopes, Huber Schriebl would typically carry a camera in his pack, ever ready to capture a photographic scene or event, and

Whereas, Stratton Corporation soon noticed his photographs and began using them in promotional materials for the mountain and in 1968 named Hubert Schriebl as its official photographer, and

Whereas, the photographic side of his career reached an important milestone when, in 1972, he was introduced to the Austrian photographer Ernst Haas whom he subsequently accompanied on photographic expeditions from the North Sea to the American Southwest, and

Whereas, his background of skiing expertise, including serving as a coach of the Greek ski team, and photographic mastery made him an ideal photographer to cover the Winter Olympics on four occasions, and

Whereas, his work has appeared in *GEO*, *Newsweek*, *SKI*, *Skiing*, *Sports Illustrated*, *Time*, and *Vermont Life Magazine* as well as prominently in Stratton's publications and throughout the ski area's facilities, and

Whereas, in 2009, the Vermont Ski Museum honored Hubert Schriebl, presenting him the Paul Robbins Ski Journalism Award for his outstanding promotion of skiing in Vermont and beyond through his photojournalism, and

Whereas, in 2010, Stratton: The First 50 Years: A Visual History by Hubert Schriebl was published, and

Whereas, Hubert Schriebl is truly one of the greats in the world of ski photography and photojournalism, now therefore be it

Whereas, born in Barton and raised on his family's dairy farm in South Albany, Leland Kinsey, a seventh-generation Vermonter, whose Scottish ancestors were among the early settlers of the towns of Albany, Craftsbury, Glover, and Greensboro, was the unofficial poet laureate of the Northeast Kingdom, and

Whereas, he was educated at Craftsbury Academy, where he met his wife, Lesley; Lake Region Union High School, where the Northeast Kingdom novelist Howard Frank Mosher, later a close friend, was his honors English teacher; the University of Vermont; and finally Syracuse University, where Leland Kinsey earned a masters' degree in writing, and

Whereas, eschewing a full-time out-of-state position in academia, Leland Kinsey returned home to Barton, and

Whereas, Leland Kinsey devoted part of his life to working in myriad occupations, as is true for many of his neighbors, such as carpentry, farming, Morgan horse training, logging, sugarmaking, and teaching astronomy and birding, and

Whereas, these jobs, however, did not prevent him from a prolific career as a poet whose work was published in eight volumes, and he participated in the Vermont Arts Council's Artists in Schools program, teaching poetry to students at more than 100 high schools, and

Whereas, Leland Kinsey's writing was hardly esoteric as he mused mostly about the beauty, challenges, joy, and realities of living in the Northeast Kingdom as well as conveying thoughts on his Scottish heritage, and

Whereas, among his published compilations are Family Drives, The Immigrant's Contract (a book length narrative), Not One Man's Work, Winter Ready, and most recently Galvanized: New and Selected Poetry, and his final posthumous volume, The Long Correspondence, is scheduled for publication this April, and

Whereas, Leland Kinsey, who wrote with great style and poetic mastery and truly loved his Northeast Kingdom home, died at 66 years of age on September 14, 2016 in his native Barton, and his survivors include his wife, Lesley, his best friend for 51 years; four children; and three grandchildren, now therefore be it

Whereas, every eight minutes, one woman in the U.S. loses her battle with lung cancer, and

Whereas, lung cancer is the number one cancer killer of women and men in the U.S. and Vermont, and

Whereas, the number of women dying from lung cancer has nearly doubled over the past 35 years, and

Whereas, according to the Centers for Disease Control and Prevention, in 2014 in Vermont, 397 persons (209 male and 188 female) died of lung cancer for a rate of 55.4 persons per 100,000 population, and

Whereas, advocacy and increased awareness will result in more and better treatments and early detection for people with lung cancer that will ultimately save lives, and

Whereas, LUNG FORCE is a fast-growing initiative of the American Lung Association intended to unite the women and their loved ones in the fight against lung cancer and to eradicate this disease, now therefore be it

Whereas, in 2008, NECCA established the Circus in the Neighborhood outreach program, and

Whereas, NECCA continued to expand its facilities, and NECCA's first Circus Spectacular premiered at Brattleboro's Latchis Theater, and

Whereas, NECCA serves over 2000 individuals in a range of programs, including recreational community classes, professional level training, and outreach programs serving at-risk and disadvantaged youth, and

Whereas, more recently, NECCA launched a capital campaign to build a new 8,600-square-foot circus arts center in Brattleboro known as a trapezium, using the Integrated Project Delivery building process, and the muchanticipated, spacious and accessible circus arts facility is scheduled to open this summer, and

Whereas, NECCA is a vital part of the Brattleboro arts community, and

Whereas, Elsie Smith and Serenity Smith Forchion were the 2016 recipients of the Vermont Art Council's Walter Cerf Medal for Outstanding Achievement in the Arts, now therefore be it

Whereas, in 1917, the Society for the Promotion of Occupational Therapy (now the American Occupational Therapy Association) was formed, establishing the new profession of occupational therapy, and

Whereas, occupational therapy is a wholistic health care profession, deeply rooted in science, that employs therapeutic occupations to restore functional independence for clients with developmental or acquired disabilities, and

Whereas, it addresses the cognitive, physical, psychosocial, sensory-perceptual, and other aspects of occupational performance for the purpose of promoting the physical and mental well-being of the client, and

Whereas, this type of therapy serves children, youths, and adults in many settings, including acute care and rehabilitation hospitals, clinics, individual homes, mental health facilities, schools and colleges, and the workplace, and

<u>Whereas</u> in fiscal year 2016, the Office of Professional Regulation's biennial renewal reported almost 400 licensed occupational therapists who practice in Vermont, and

Whereas, occupational therapy is a related service under Part B of the federal Individuals with Disabilities Education Act, and

Whereas, Medicare and Medicaid both offer coverage for occupational therapy, and

Whereas, the U.S. Bureau of Labor Statistics projects a 27 percent increase in the growth of occupational therapy positions between 2014 and 2024, and

Whereas, occupational therapists serve clients who have disabilities related to many physical and mental illnesses, and

Whereas, these therapists are pioneers in assisting in the modification of homes, schools, and work environments and in teaching new movement and adaptive skills to their clients, and

Whereas, occupational therapists enable persons of all ages to live life to its fullest, now therefore be it

That the General Assembly commemorates the 100th anniversary of the occupational therapy profession, and be it further

<u>Whereas</u>, Ed Steele's leadership and dedication to the Waterbury community can be traced to his roles as both student council and class president at Waterbury High School, and

Whereas, at Norwich University, from which Ed Steele graduated as a member of the class of 1959, he was an outstanding skier and basketball player, and he later served as a general officer in Norwich's Partridge Society, as a member of the alumni association, and was always an avid fan and supporter of Norwich athletics, and

<u>Whereas</u>, on completing his military obligation, Ed Steele joined the family business, Steele's, Inc., a provider of heating, propane, and plumbing services that grew under his watch before he sold the company to Green Mountain Power, and

Whereas, aside from his primary business, Ed Steele was a local developer who specialized in rehabilitating properties in Waterbury, including most significantly the former Anderson Industrial Area that became the home of Green Mountain Coffee Roasters, and

Whereas, the citizens of Waterbury best remember Ed Steele as the chair of the town's selectboard, a role he filled conscientiously for 26 years, and

Whereas, highlights of his leadership tenure included the successful merger of the town's and village's highway and fire departments, the attraction of major new businesses, including Ben & Jerry's Ice Cream, and securing from the State of Vermont a payment in lieu of taxes agreement regarding the State Hospital and a financial settlement for the Lincoln Street Park and Ride, and

<u>Whereas</u>, in recognition of his superb civic leadership, the town of Waterbury dedicated the municipal highway facility in his name and presented him the Keith Wallace Community Service Award, and

Whereas, the recipients of Ed Steele's generous philanthropy included Norwich University and the town of Waterbury, especially funding for the new municipal complex where the community room is named in his honor, and

Whereas, Ed Steele, a true leader in the town of Waterbury, died on April 1, 2017, and his survivors include his wife, former Representative Karen Steele; his daughter, Gretchen; his son, Shawn; and two granddaughters, now therefore be it

Whereas, the VSHF honors Helmut Lenes as its 2017 David K. Hakins Inductee in recognition of his "contributions as a business leader in exceptional promotion and development of sports, athletics and recreation in the state of Vermont," and

Whereas, Helmut Lenes was a respected mountain guide and ski instructor in his native Austria, and

Whereas, in 1968, Helmut Lenes moved to Vermont and subsequently established the Climb High retail store, specializing in mountain and rock climbing and other outdoor sports, and

Whereas, an unusual feature that Helmut Lenes introduced at Climb High was a 28-foot rock climbing wall that he made available for public use at no charge and the store also offered free rock climbing classes, and

Whereas, Helmut Lenes's own climbing accomplishments are worthy of special praise as he twice summited Denali, North America's highest peak; ascended to the top of the Himalayas; and reached the summits of major European mountains, including setting a one-day record for reaching the top of the North Face of the Eiger in Switzerland, a dangerous 13,000-foot vertical climb of a mountain that has been characterized as the most notorious in the world, and

Whereas, through his leadership at Climb High, Helmut Lenes invigorated mountaineering in Vermont and displayed outstanding entrepreneurship, and the VSHF induction ceremony will occur in South Burlington on April 22, now therefore be it

Whereas, until his third and final retirement in 2016, Tom Connor's involvement in public education was broad in scope, entailing professional experiences that few of his peers might ever envision, and

Whereas, he graduated from Mount Saint Joseph Academy in Rutland, the University of Vermont, and initially taught at the former Newbury High School and Black River Academy in Ludlow, and

Whereas, in 1970, he earned a master's degree from the Antioch University campus in Putney, and a field project at Leland & Gray Seminary (now Middle and High School) in Townshend resulted in a job offer, and

Whereas, Tom Connor taught a catalog's worth of traditional social studies courses, coached varsity baseball and girls' basketball teams to divisional finals, and chaired the Jamaica School Board, and

Whereas, Tom Connor's true legacy to public education in Vermont is Leland & Gray's Journey East curriculum, a unique Asian Studies intercultural exchange program conducted in association with the Asian Studies Outreach Program at the University of Vermont (UVM), and with generous financial support from the Freeman Foundation, and

Whereas, the genesis of Journey East was a UVM teachers' recertification trip Tom Connor took to China and a subsequent excursion that he and then Windham Central Supervisory Union Superintendent Holden Waterman co-led, and

Whereas, over 300 Leland & Gray students, teachers, and community members have traveled to China, and an approximately similar number of Chinese and Mongolian nonEnglish-speaking college students have visited Vermont's West River Valley, and

Whereas, Tom Connor, who also directed the Governor's Institute on Asian Cultures, is the recipient of numerous honors from the University of Vermont recognizing his leadership in secondary school Asian studies, including a Fulbright Scholarship that facilitated his studying in Japan, and an honorary professorship granted him in 2016 from the Art College of Inner Mongolia University, now therefore be it

Whereas, Michelle LeBlanc is a Norwich University graduate, served as a member of the U.S. Army's military police force, and worked briefly for the Bennington County Sheriff's Department before joining the VSP, and

Whereas, she served on the VSP's elite corridor team that primarily patrols the northern segment of Interstate 89, and she also provided instructional support at the Vermont Police Academy, and

Whereas, in 2005, Michelle LeBlanc entered a new phase of her law enforcement career, graduating, along with her new canine work partner K9 Casko, from the basic patrol school, and becoming only the third female VSP canine handler, and

 $\underline{\text{Whereas}}$, the illustrious crime-fighting LeBlanc-K9 Casko team was deployed in over 1,550 instances, saved several lives, and assisted in the confiscation of over \$250,000.00 worth of cash and drugs, and

Whereas, the Vermont Police Canine Association twice named the team the Tracking Team of the Year and the K9 Team of the Year, and presented it with the K9 Lifesaving Award, the K9 Apprehension of the Year Award, the K9 Public Service Award (twice), and the Dedicated Service Award (four times), and

Whereas, an unidentified Vermonter nominated both Michelle LeBlanc and K9 Casko (the only dog ever nominated) for Vermonter of the Year recognition, and

Whereas, K9 Casko was medically retired after being injured during an armed robbery track on October 6, 2015, but remained with Corporal LeBlanc until his death in June 2016, and

Whereas, K9 Casko was the longest-serving and possibly most successful VSP K9 and was cremated with honor and dignity, now therefore be it

Whereas, the jurors assessed the home's architecture, constructability, envelope performance and durability, financial liability, indoor air quality and ventilation, interior design, lighting and appliance usage, overall energy efficiency, and on the team's presentation and document quality, and

Whereas, the team from the Rubenstein School of Environment and Natural Resources, consisting of students Adam Wechsler, Victoria Kushner, Alex Schoedler and Harrison Myers, and advisors Marc Companion and Gary Hawley, entered in a
