#### **Concurrent Resolutions for Adoption Under Joint Rule 16**

The following concurrent resolutions will be adopted automatically unless a Representative or Senator requests floor consideration before the end of Friday's legislative session. Requests for floor consideration must be communicated to the House Clerk's office or the Senate Secretary's office.

#### Resolutions

#### H.C.R. 198.

House concurrent resolution honoring Jane Williamson for her exemplary administrative and curatorial leadership of the Rokeby Museum

Offered by: Representatives Lanpher of Vergennes, Van Wyck of Ferrisburgh, and Devereux of Mount Holly

<u>Whereas</u>, in 1793, Thomas Robinson purchased the Rokeby, a farmstead in Ferrisburgh that served as the Robinson family's residence for four generations until 1961, when, in accordance with Elizabeth Donoway Robinson's direction, it became a museum, and

<u>Whereas</u>, in the early 19th century, the Rokeby farm featured Merino sheep raising before its conversion to a dairy operation, and

<u>Whereas</u>, Rowland Thomas Robinson (1796–1879) and his wife, Rachel Gilpin Robinson (1799–1862), were prominent Vermont abolitionists who welcomed fugitive slaves into their home, making the Rokeby a major stop on the Underground Railroad, and

<u>Whereas</u>, Jane Williamson, who holds both masters' degrees in library science and historic preservation, arrived at the Rokeby as a volunteer in 1989, organized the museum's archives, and became its director in 1995, and

<u>Whereas</u>, her first directorship achievement was the National Park Service's 1997 designation of the Rokeby as a National Historic Landmark, and

<u>Whereas</u>, she spearheaded an approximately decade-long one-milliondollar-plus fundraising campaign and construction effort that in 2013 culminated in the opening of the Underground Railroad Education Center, a modern multi-gallery exhibition building placing the Rokeby's role as an Underground Railroad stop center stage, and

<u>Whereas</u>, the new building has increased the Rokeby Museum's attendance and is the home for both the permanent "Free & Safe" exhibit as well as temporary exhibits such as 2017's "Yours in the Cause: Faces of Radical Abolition," and <u>Whereas</u>, Jane Williamson has organized complementary educational programs related to the exhibits, the museum's collections, and the site's historic structures, as well facilitated forums focused on contemporary social justice issues, and

<u>Whereas</u>, after nearly three decades, Jane Williamson has concluded her role as the director of the Rokeby Museum, having enhanced the institution in all respects, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors Jane Williamson for her exemplary administrative and curatorial leadership of the Rokeby Museum, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Jane Williamson and to the Rokeby Museum.

## H.C.R. 199.

House concurrent resolution commemorating the 100th anniversary of the birth of the Russian author, historian, and former Cavendish resident Aleksandr Isayevich Solzhenitsyn

Offered by: Representative Christensen of Weathersfield

Offered by: Senators Clarkson, McCormack, and Nitka

Whereas, Aleksandr Solzhenitsyn, one of Russia's most distinguished intellectuals and noted dissidents during the Soviet era, was born in Kislovodsk, Russia, on December 11, 1918, and

<u>Whereas</u>, although a decorated artillery officer during World War II, his criticism of Joseph Stalin's leadership and the Soviet Army's conduct resulted in Aleksandr Solzhenitsyn's imprisonment from 1945 to 1953, and

Whereas, in 1962, Aleksandr Solzhenitsyn's description of his imprisonment, *One Day in the Life of Ivan Denisovich*, became his only book published in the former Soviet Union, and

<u>Whereas</u>, he was the recipient of the 1970 Nobel Prize for Literature, but he only accepted this honor in 1974, following the publication in the west of *The Gulag Archipelago* and his expulsion from the Soviet Union, and

<u>Whereas</u>, in 1975, Aleksandr Solzhenitsyn visited Norwich University, and in 1976, he and his family moved to an isolated estate in Cavendish, where

the sign placed outside the general store reading "No Directions to the Solzhenitsyn Home" epitomized the town's protection of his privacy, and

Whereas, the respect Cavendish afforded Aleksandr Solzhenitsyn enabled him to finish his multi-volume Russian history novel, *The Red Wheel*, and

<u>Whereas</u>, in March 1994, prior to his return to post-Soviet Russia, Aleksandr Solzhenitsyn attended the Cavendish Town Meeting and thanked the town's citizens for their wonderful welcome and support, and

<u>Whereas</u>, Aleksandr Solzhenitsyn resided and worked in Russia until his death in Moscow on August 3, 2008 at 89 years of age, and

<u>Whereas</u>, the Cavendish Historical Society, in association with the Vermont Historical Society, the Vermont Humanities Council, the Russian studies program at the University of Vermont, and members of the Solzhenitsyn family, is conducting a series of commemorative programs, including an exhibit at the Vermont Historical Society Museum, local presentations, and its highly praised permanent exhibit honoring Aleksandr Solzhenitsyn located at the Cavendish Stone Church, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the 100th anniversary of the birth of the Russian author, historian, and former Cavendish resident Aleksandr Isayevich Solzhenitsyn, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to Aleksandr Solzhenitsyn's son and Cavendish resident Ignat Solzhenitsyn and to the Cavendish Historical Society.

<u>Whereas</u>, in collaboration with the Great Schools Partnership and the Vermont Agency of Education, Linda Cloutier-Namdar helped edit and pilot an ELA Transferable Skills Task, and

Whereas, she is a writer for the Essex Westford Education Association, and

<u>Whereas</u>, as a member of the Vermont Writing Collaborative, she has taught workshops at the organization's summer institutes and copresented a seminar at the 2017 New England Secondary School Consortium's School Redesign In Action event, and

<u>Whereas</u>, Linda Cloutier-Namdar's English language education expertise is appreciated at the Flynn Theater, where she serves as teacher-leader, and

<u>Whereas</u>, the Vermont Agency of Education has recognized that Linda Cloutier-Namdar is an outstanding teacher and has selected her as the 2018 Vermont Teacher of the Year, and

<u>Whereas</u>, she will represent Vermont at the Council of Chief State School Officers' 2018 National Teacher of the Year competition to be held in the spring of 2018 in Washington, D.C., now therefore be it

and qualified for the 2014 U.S. Junior Amateur Championship, and

<u>Whereas</u>, after his high school graduation, Drake Hull enrolled at the University of Kansas as a Jayhawk golfer, earning placement on the Fall Athletic Director's and the Big 12 Commissioner's honor rolls as a business and sports management major, and

<u>Whereas</u>, Drake Hull earned a new place in Vermont's golfing annals, winning the 2017 Vermont Amateur Golf Championship at the Dorset Field Club, becoming the first Rutland Country Club representative since 1993 to garner this victory, and

<u>Whereas</u>, despite temporarily losing his two-shot, final-round lead as a result of a triple bogey on the eighth hole, Drake Hull rebounded, birdieing the 17th hole, breaking a leadership tie, and he then proceeded to birdie the 18th hole as well to conclude the round with a two-shot win, two under par (68), compiling an excellent overall tournament score of seven under par (273), and

House concurrent resolution designating Saturday, June 2, 2018 as Neighbors Day in Vermont

Offered by: Representatives Houghton of Essex and Giambatista of Essex

Whereas, neighbors are the persons who reside in our immediate vicinity and whom we encounter on a daily basis, and

<u>Whereas</u>, although contact with our neighbors may be frequent, we often remain unacquainted, perhaps not even knowing their names, and

Whereas, Neighbors Day is intended to develop bonds of friendship between neighbors, and

<u>Whereas</u>, the goals of Neighbors Day include: developing a stronger sense of belonging, mutual support, safety, and security in neighborhoods; establishing connections with neighbors that can be helpful in a time of crisis; creating families of choice; and promoting opportunities for enjoyable neighborhood events, and

Whereas, in the late 1990s, an elderly woman died in the 17th

arrondissement of Paris, and her body was not discovered for months, and

<u>Whereas</u>, as a result of this tragic occurrence, in 1999, the deputy mayor of the 17th arrondissement, Atanase Périfan, established Neighbors Day on the first Saturday in June with the hope of fostering a sense of belonging and lessening the likelihood of a similar occurrence, and

Whereas, that first year, 10,000 neighbors in Paris participated, and

<u>Whereas</u>, in 2000, the geographic scope of Neighbors Day grew as it was celebrated in 30 French municipalities, and in the ensuing years, the observance has expanded across Europe and eventually to five continents, and

Whereas, by 2017, 30 million persons across the globe participated in Neighbors Day celebrations, including groups of neighbors in Essex Junction, and

<u>Whereas</u>, Neighbors Day events might include neighborhood potlucks, barbecues, pancake breakfasts, picnics, pizza parties, or events not involving food such as the outdoor screening of a film, a book and plant exchange, or a game of whiffle-ball or kickball, and

<u>Whereas</u>, although variations of Neighbors Day exist in the United States, no American jurisdiction has designated it as an official observance, and

<u>Whereas</u>, the camaraderie of the Essex Junction events justifies encouraging Neighbors Day observances throughout Vermont, making our State the first to designate Neighbors Day officially, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates Saturday, June 2, 2018 as Neighbors Day in Vermont and urges Vermonters to organize Neighbors Day celebrations.

<u>Whereas</u>, Paij Wadley-Bailey developed the Lesbian and Gay Studies Program and Center at Goddard College, served as the first coordinator of the LGBTQA Services Program at UVM, and held faculty positions at each academic institution, and

<u>Whereas</u>, she served as director of the Vermont Anti-Racism Action Team, organized its public school-based Reading to End Racism program, attended a 2001 United Nations World Conference Against Racism held in Durban, South Africa, and taught in a Holocaust Studies for Youth summer institute, and

<u>Whereas</u>, as a passionate local archivist and historian, Francis Favreau coordinated and edited a volume relating to Copley Hospital's history, assisted updating the Hyde Park town history documentation, and participated in cataloging the vital records of Holy Cross Church, and

<u>Whereas</u>, beginning in 1973, Francis Favreau engaged in a parallel career as a dedicated appointed or elected official in the town of Morristown, where his contributions benefited municipal government in many spheres, and

<u>Whereas</u>, for two decades, Francis Favreau served as the Morristown Health Officer, he assisted for many years in the town listers' office, and more recently he has supported the work of both the town clerk and planning director, and

<u>Whereas</u>, recognizing his devotion to the town of Morristown, the voters elected him to serve as a justice of the peace, and

<u>Whereas</u>, although he has performed the duties associated with these positions honorably and with distinction, not surprisingly, Francis Favreau is most noted for his service as the Morristown Town Historian, and he is a critical resource for anyone researching Morristown's history, and

Whereas, in recognition of Francis Favreau's unique contribution to his community, in 2006, the Morrisville Village Report was dedicated in his honor, and

Whereas, on January 11, 2018, at 83 years of age, Francis Favreau is saying

farewell to his roles in Morristown's town government, and an open house will mark his public service with the deserved acclaim, now therefore be it

### S.C.R. 19.

Senate concurrent resolution commemorating the 50th anniversary of the enactment of the Vermont outdoor advertising law of 1968.

*Whereas*, nearly a century ago, the General Assembly first addressed the aesthetic impact of outdoor advertising billboards, when it enacted 1921 Acts and Resolves No. 44, "An Act to Control the Use of Bill-Boards" that established a largely permissive regulatory scheme but limited a billboard's size to no greater than six square feet, and

*Whereas*, 1925 Acts and Resolves No. 32 amended the 1921 act to prohibit billboards "within fifty feet of any public park, playground, square or cemetery," except on-premises advertising and municipal or State traffic, directional, or public safety signs, and

*Whereas*, in 1937, following the placement of seven billboards in Springfield, billboard opponents formed the Vermont Association for Billboard Restriction, and the Springfield billboards proved short-lived, and

*Whereas*, in a 1943 ruling, *Kelbro, Inc. v. Myrick*, 113 Vt. 64, the Vermont Supreme Court rejected a challenge to the State's billboard regulatory scheme, describing it as "a regulation of the use of the streets and other public thoroughfares," and "not so much a regulation of private property," and

*Whereas*, 1957 Acts and Resolves No. 275 created a 750-foot exclusion zone for advertising adjacent to a limited-access highway, serving as a limitation, but hardly a prohibition, and

*Whereas*, opposition to billboards continued into the 1960s, culminating in the General Assembly's 1968 adoption of a comprehensive ban on traditional highway billboards, 1968 Acts and Resolves No. 333, that also repealed the existing, far more limited, outdoor advertising statutes and made Vermont the first state to ban traditional off-premises advertising billboards, and

Whereas, Act 333 enabled Vermont to preserve the scenic landscape views from the State's highways, replacing traditional billboards with limited

informational and directional signs that promote tourism and public safety, and ending the presence of the large, and at times distracting, billboards that had lined Vermont's highways since at least the early 1920s, and

Whereas, Act 333 has helped maintain Vermont's unique character and provided a precedent for other jurisdictions to remove billboards, and

*Whereas*, occasional efforts to weaken the principles of Act 333 have not derailed this historic law that in 2018 is marking a half-century in force, *now therefore be it*

*Whereas*, the Smirkus Residency program visits hundreds of schools, teaching circus arts skills and their applicability to daily life, and

Whereas, in recent years, Circus Smirkus has been featured on PBS, The Martha Stewart Show, Fletch, America's Got Talent, and at the Toronto Film Festival, and

*Whereas*, Ed LeClair has continued the Circus Smirkus tradition of international cultural exchanges through partnerships with circuses in Colombia, Cuba, Ethiopia, France, and Mongolia, and the organization participated in the 2017 Smithsonian Folklife Festival in Washington, D.C., and

*Whereas*, his leadership has included: the reorganization of the Ringmaster Residency program; the purchase, historic restoration, and energy-efficiency upgrading of the organization's World Headquarters in Greensboro; and the

opening of a new summer camp, also in Greensboro, culminating a \$3 million fundraising campaign, and

*Whereas*, he represented Circus Smirkus both nationally and internationally, has been an active member of the Vermont Creative Economy NEK Leadership Team, and served as a board member of the Circus Now trade association, and,

*Whereas*, Ed LeClair is concluding his innovative leadership tenure at Circus Smirkus, and he and his wife, Beth Comolli, are looking forward to a new chapter in their lives, *now therefore be it*
