### **Resolutions**

#### **.H.C.R. 272.**

House concurrent resolution honoring Manchester Fire Chief Philip Bourn for his laudable public service

Offered by: Representatives Keefe of Manchester, Browning of Arlington, Corcoran of Bennington, Fagan of Rutland City, Harrison of Chittenden, Pajala of Londonderry, Shaw of Pittsford, Sullivan of Dorset, and Turner of Milton

Offered by: Senators Campion, Sears, Collamore, Flory, and Soucy

Whereas, a municipal fire chief must react quickly and wisely in the midst of tension-filled emergency situations and also oversee the department's daily administrative matters, and

Whereas, Manchester Fire Chief Philip (Grub) Bourn has served in this pivotal role twice, initially for a five-year term from 1994 to 1999 and then for a longer period, commencing in 2003 and continuing for 15 years into 2018, and

Whereas, the responsibilities of the Manchester Fire Chief entail devoting approximately 20 hours each week to overseeing the personnel and financial details of the department's operations, and

Whereas, Grub Bourn has performed both the routine and extraordinary supervisory duties of his post while owning Bourn's Tire and Auto Center and personally managing in excess of 100 plowing accounts for his customers in winter, and

Whereas, his fellow firefighters have great confidence in Grub Bourn's leadership, having repeatedly reelected him as their chief, and

Whereas, under Chief Bourn's leadership, the Manchester Fire Department has moved forward with major infrastructure projects, including the installation of an upgraded radio system, the purchase of a fire truck featuring a 95-foot tower, and the construction of a new public safety facility that greatly improved the department's home base, and

Whereas, in directing the firefighting and protection services in Manchester, Grub Bourn continued a family tradition, as his father was chief until 1970, and

Whereas, after a combined 20 years in command as the outstanding Manchester Fire Chief, Grub Bourn is handing over his portfolio of duties to another chief, and

Whereas, although his successful tenure as chief is ending, Grub Bourn is not departing and intends to remain an active member of the Manchester Fire Department, responding to the calls to douse a blaze, and to continue his teaching role as a Vermont State Fire Instructor, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors Manchester Fire Chief Philip Bourn for his laudable public service, and be it further

### **H.C.R. 273.**

House concurrent resolution honoring Brendan J. Whittaker of Brunswick for his years of insightful leadership in the State, municipal, and religious sectors

Whereas, Brendan Whittaker's life as a forester and conservationist, respected municipal official in the Town of Brunswick, and Episcopal priest represents an unusual blend of passionate interests with which he is equally adept, and

Whereas, after his marriage to Dorothy Alden in 1956, and their respective University of Massachusetts graduations, they settled on a farm in Brunswick, and

Whereas, Brendan Whittaker's work as a forester and conservation advocate was a solid foundation for his role as an Act 250 District Commissioner and later, under Governor Richard Snelling, as Secretary of the Agency of Environmental Conservation (now Natural Resources), and

Whereas, he has continued working as an independent consulting forester,

and his institutional natural resources roles have included membership on the U.S. Department of Agriculture's Farm Service State Committee in Vermont and on the Ammonoosuc Conservation Trust Lands Committee, and

Whereas, in 1966, Brendan Whittaker graduated from the Episcopal Theological (now Divinity) School in Cambridge, Massachusetts, and for 45 years preached at St. Thomas and Grace Episcopal Church in Brandon, and

Whereas, the citizens of Brunswick have known Brendan Whittaker for his extensive and exemplary 57-year record of civic service, dating to his 1961 election as a grand juror, and

Whereas, in 1963, he was elected a justice of the peace, and

Whereas, for a dozen years, beginning in 1980, Brendan Whittaker served as a member of the town's municipal planning board and continued as the zoning administrator for many years thereafter, and

Whereas, for a long tenure of three decades, Brendan Whittaker has sat as a knowledgeable and thoughtful member of the Brunswick Selectboard, and

Whereas, his wealth of experience presiding at meetings has proven invaluable during his seven years serving as both town and school meeting moderator, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors Brendan J. Whittaker of Brunswick for his years of insightful leadership in the State, municipal, and religious sectors, and be it further

House concurrent resolution in memory of Gordon E. Tallman of Hyde Park

Whereas, Gordon Tallman of Hyde Park, the youngest of 11 children, graduated in 1956 from Lamoille Central Academy (LCA), and his mastery of soccer, basketball, and baseball helped his school win divisional championships, and

Whereas, in partnership with his brother Donald, he contributed to LCA's 1953 State baseball title and to bringing the 1954 team into the championship game against Stowe High School, and

Whereas, competitive sports continued to be central for the adult Gordon Tallman, who coached his sons' Hyde Park Little League baseball teams, and

Whereas, once his sons were past Little League age, Gordon Tallman pursued his personal passion for competition on the diamond, playing on local adult baseball and slow-pitch softball teams in northern Vermont, and

Whereas, during his career at Bullard's Mill manufacturing golf tees, Gordon Tallman enjoyed a moment of fame by appearing on the national television show *What's My Line*, trying to stump the panelists regarding his vocation, and

Whereas, Gordon Tallman was an avid outdoorsman and enjoyed deer hunting and collecting moose sheds, and he was a dedicated Boston Red Sox fan, and

Whereas, when not at work, on the playing fields, or in the woods, Gordon Tallman, who knew the way to construct a rhyming stanza, wrote poetry reflecting his rural Vermont roots, and

Whereas, his poems were published in two volumes, *Backroads and Bygones* and *Backroads and Bygones, Volume II*, and

Whereas, in 2002, Gordon Tallman and his brother Clifford were the joint recipients of the Vermont Life and Heritage Center Award for Traditional Artists (Poetry), and

Whereas, he was privileged to recite his poetry as the devotional speaker on several occasions at the opening of legislative sessions in Montpelier, and

Whereas, Gordon E. Tallman died on February 9, 2018, at 79 years of age, and his survivors include his sons, Kevin and Wyatt, and their mother, Hilda; his partner, Barbara Hawley; and his grandchildren and great-grandchildren, now therefore be it

House concurrent resolution congratulating William Busier of Essex on his 100th birthday

Whereas, Bill Busier was born on March 8, 1918, the year the World War I Armistice was signed, and

Whereas, he served our nation heroically in World War II, and

Whereas, as a member of the U.S. Army, Bill Busier was deployed to the European Theater of Operations, and

Whereas, in December 1944, as thousands of Allied troops, including Bill Busier, headed eastward towards Germany through the Ardennes region of Wallonia in France, Belgium, and Luxenberg, the Germans launched a surprise counteroffensive in an attempt to halt the Allied advance, and

Whereas, this campaign that the Germans designated as Operation Watch on the Rhine and that became known as the Battle of the Bulge resulted in the highest number of American casualties in any World War II operation, and

Whereas, among those Americans the Germans took prisoner was Bill Busier of Essex, and he was forced to endure the brutal conditions of a German prisoner of war camp for the duration of the war in Europe, and

Whereas, after he was freed, he was awarded the Purple Heart, and

Whereas, Bill Busier returned home to Vermont and, despite his harrowing wartime experience, has since lived a long life, and

Whereas, he will observe his 100th birthday on March 8, 2018, and

Whereas, in celebration of this special occasion, Veterans of Foreign Wars Post No. 1767 is throwing Bill Busier a most deserved surprise birthday party on March 3, 2018 at the post's headquarters in Winooski, and

Whereas, this party will honor a man who can especially appreciate the sacrifices Americans have made to protect their freedom, now therefore be it

House concurrent resolution commemorating the 100th anniversary of the Wayside Restaurant in Berlin

Whereas, the Wayside, an eating establishment that offers “Home cooking away from home,” served its first customer in July 1918, and

Whereas, the original proprietor, Effie Ballou, prepared some of the menu at her hillside home and then carried the cooked meals to the small roadside eatery she operated adjacent to the Barre-Montpelier Road, and

Whereas, in 1945, Joseph and Amy Fish assumed ownership, and their son and daughter-in-law, George (Roy) and Vivian, succeeded them in 1954, and

Whereas, in 1966, Eugene and Harriet Galfetti purchased the Wayside and over 33 years constructed seven additions, greatly expanding the premises, and

Whereas, in 1998, a new generation took command at the Wayside when Karen (Galfetti) Zecchinelli and her husband, Brian, succeeded her parents with the goal of maintaining all the Wayside’s wonderful dining traditions, and

Whereas, the Wayside’s outstanding Yankee cookery has been publicized in the *New York Times*, the *Burlington Free Press*, the *Times Argus*, and *Seven Days*, and

Whereas, in 2014, the restaurant was the winner of a Vermont Legacy Award, and Senator Leahy has offered a personal tribute, and

Whereas, the Wayside includes a bakery that offers a variety of pies, breads, and muffins for take-out sale and a creamery that produces 14 flavors of ice cream for consumption after a meal or as a standalone treat, and

Whereas, the Wayside was Montpelier’s first green restaurant and the fifth in the State, and has taken multiple steps to reduce its carbon footprint, such as installing six solar tube panels on its back roof that preheat the dishwasher’s water, and

Whereas, a locally-oriented initiative is working with area farmers and fishermen to offer Vermont fresh food products, and

Whereas, in celebration of its 100th birthday, a book, *It’s Worth the Ride to the Wayside: Celebrating 100 Years with Anniversary Ale, Yankee Cooking and Ice Cream*, and that includes favorite recipes, has been published, and

Whereas, on July 29, 2018, a customer appreciation party, featuring a free ice cream social and a fireworks display, will take place to commemorate a century of delightful family-friendly dining, now therefore be it

*Whereas*, closer to home, in 2008, the Woodstock Curling Club was established, and its enthusiastic members play as a team commonly referred to as the Woodstock Stoners, and

*Whereas*, the Woodstock Stoners, unlike most of their competitors, lacks a dedicated practice and playing facility, and the team must play all home games in ice hockey arenas that feature an irregular ice surface, and

*Whereas*, notwithstanding these challenges, the Woodstock Stoners bravely entered the Maine-iac 'Spiel curling tournament, held in Belfast, Maine, with teams from Maine, New Brunswick, New Hampshire, Ohio, Pennsylvania,

Quebec, and Washington, D.C., and

*Whereas*, the winner of the 2017 Maine-iac 'Spiel brings home the Larry the Lobster trophy that during the prior two years has resided in the Province of Quebec, and

*Whereas*, despite the seemingly insurmountable and far less favorable odds than those of John Shuster and the U.S. Olympic team's bringing home a gold medal, the Woodstock Stoners emerged victorious at the 2017 Maine-iac 'Spiel, and

*Whereas*, the Woodstock Stoners proudly brought the Larry the Lobster trophy and its own lobster trap carrying case to Vermont for the first time, and

*Whereas*, the skilled curlers of the Woodstock Stoners are Bob Holt, Lisa Holt, Bruce Seely, and Phil Swanson, *now therefore be it*
