<u>Seventh</u>: In Sec. 1, in 13 V.S.A. § 4055, in subdivisions (b)(1) and (b)(2), by, in each instance, striking out " $\underline{60 \text{ days}}$ " and inserting in lieu thereof " $\underline{\text{six}}$ months"

<u>Eighth</u>: In Sec. 1, in 13 V.S.A. § 4056, in subsection (a), in the second sentence, after the word "<u>service</u>" by inserting "<u>, and shall deliver a copy to the holding station</u>"

<u>Ninth</u>: In Sec. 1, 13 V.S.A., after § 4060, by inserting a § 4061 to read as follows:

§ 4061. EFFECT ON OTHER LAWS

This chapter shall not be construed to prevent a court from prohibiting a person from possessing firearms under any other provision of law.
